To Have and to Hold to the said grantee, their assigns forever.

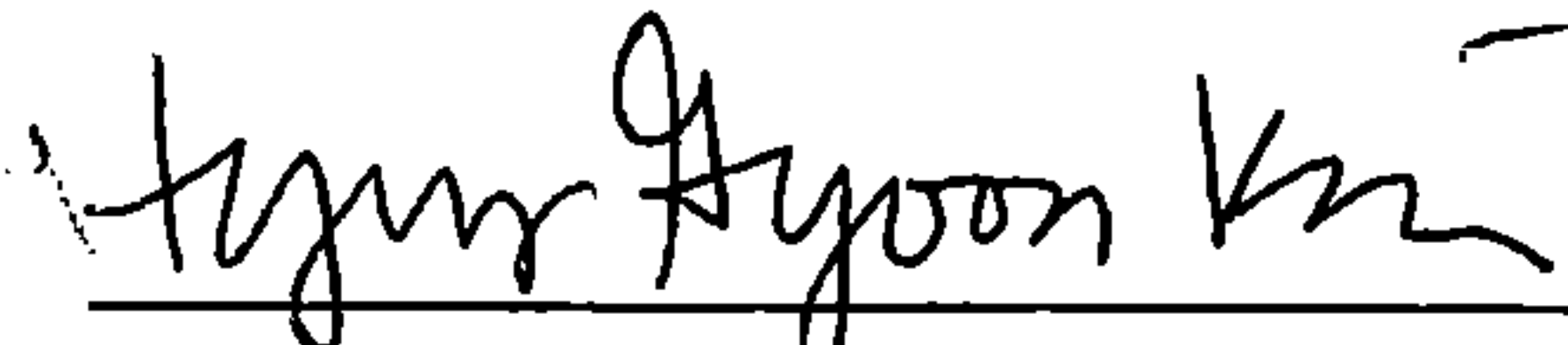
