KNOW ALL MEN BY THESE PRESENTS, That in consideration of Two Million Six Hundred Fifty Thousand and 00/100 Dollars (\$2,650,000.00), being the contract sales price, to the undersigned Grantors in hand paid by the Grantee herein, the receipt of which is hereby acknowledged,

(herein referred to as "Grantors") do grant, bargain, sell and convey unto

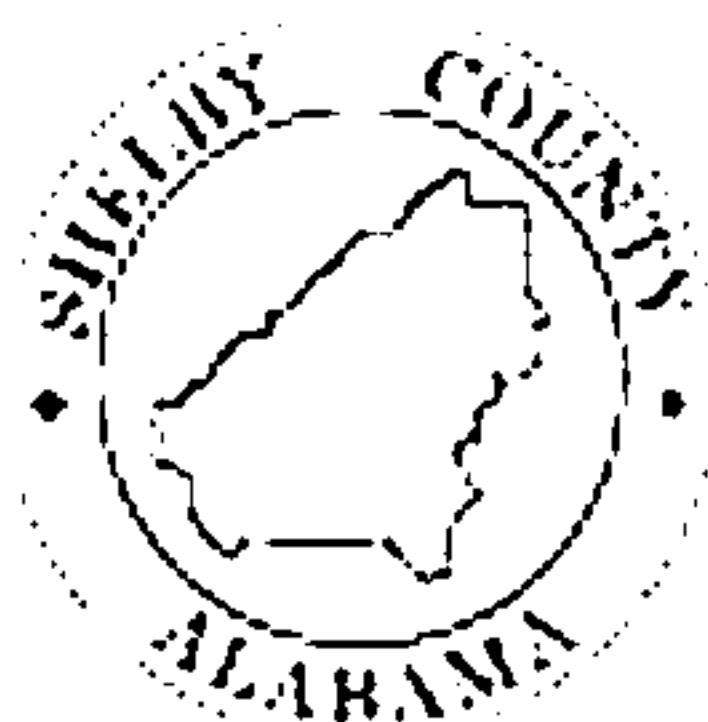
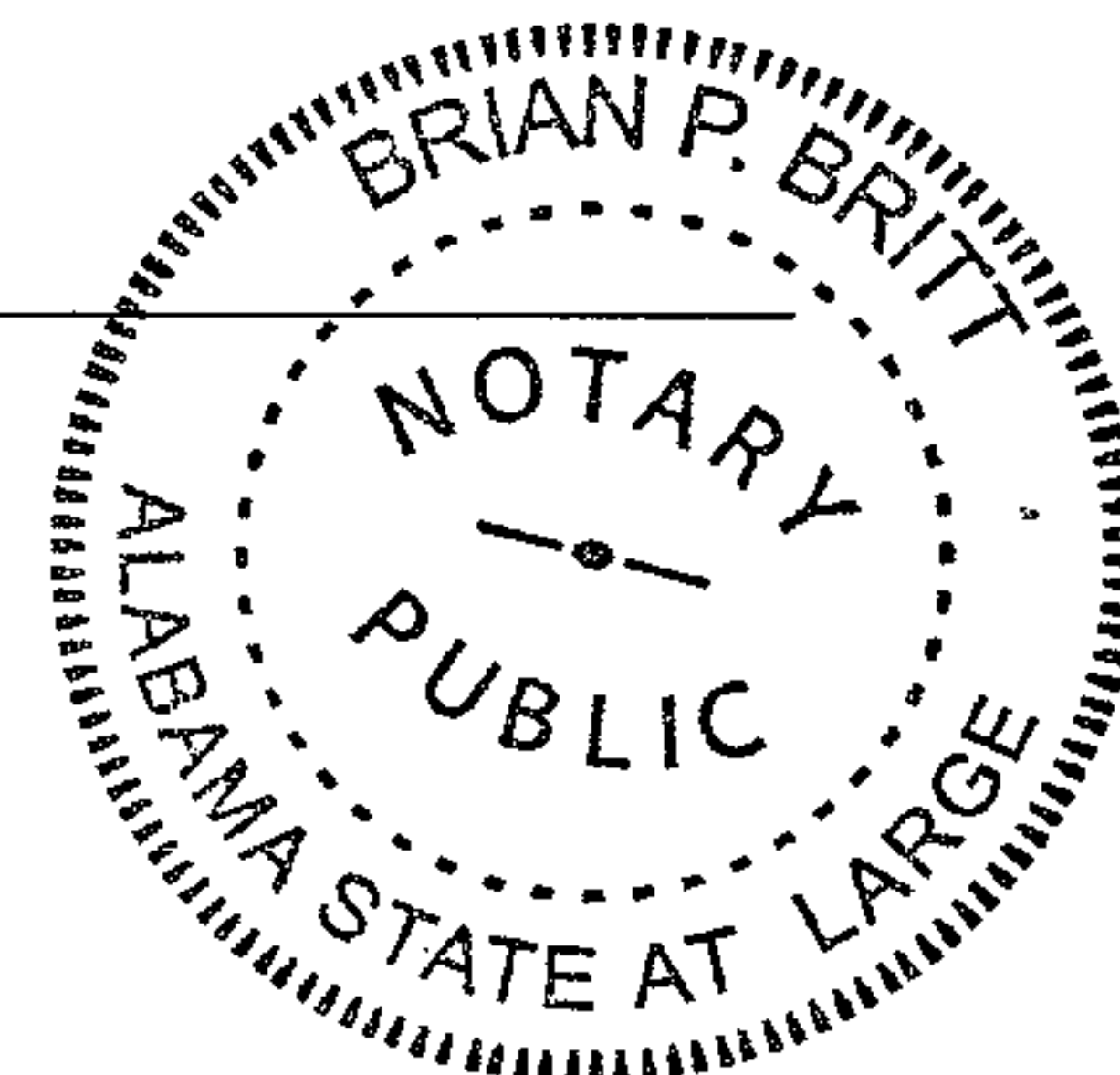
