Know all Men by These Presents, that in consideration of one dollar and other good and valuable consideration to the undersigned GRANTOR, in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, Shannon P. Champion, an unmarried person (herein referred to as grantors), do grant, bargain, sell and convey unto Shannon P. Champion, Trustee, or her successors in trust, under the Champion Living Trust dated the 19th day of September, 2025, and any amendments thereto (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:

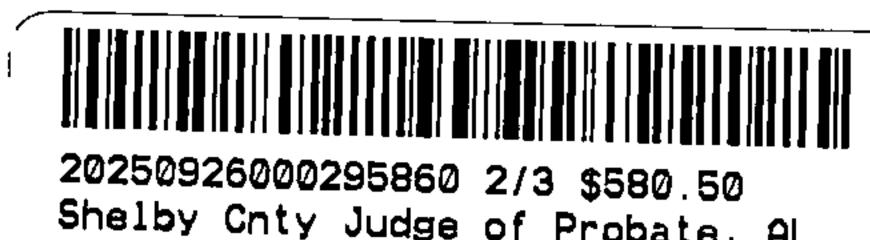

Subject to taxes, right of ways, conditions, restrictions, and easements of record.

The Grantor herein reserves a life estate in the above-described property for the duration of her lifetime.

Grantor was the joint owner, with right of survivorship, of said Parcel being conveyed herein, as evidenced by that certain Warranty Deed dated August 16, 1977, and recorded in the Office of the Judge of Probate of Shelby County, Alabama, on August 26, 1977, in Deed Book/Page 307/472. The other owner, as identified on that certain deed, Richard M. Champion died on or about June 30, 2023.
