For ad valorem tax purposes only, the address of the above-described property is 201 Perthshire Cove, Pelham, AL 35124.

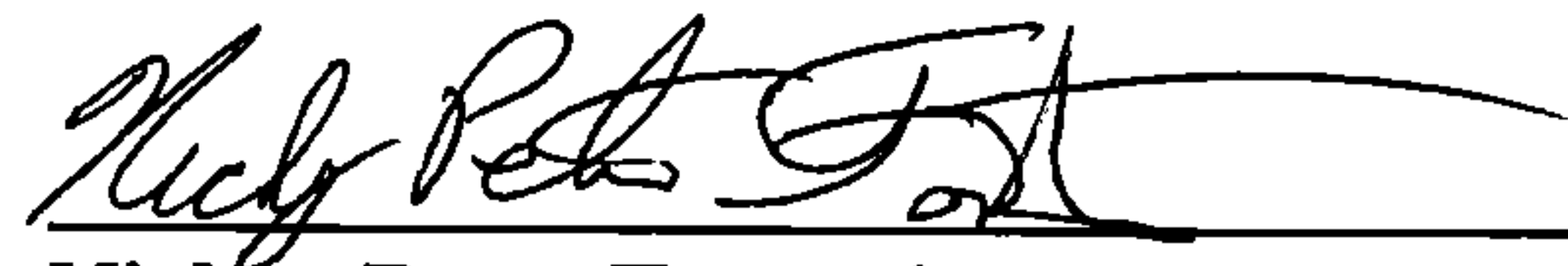

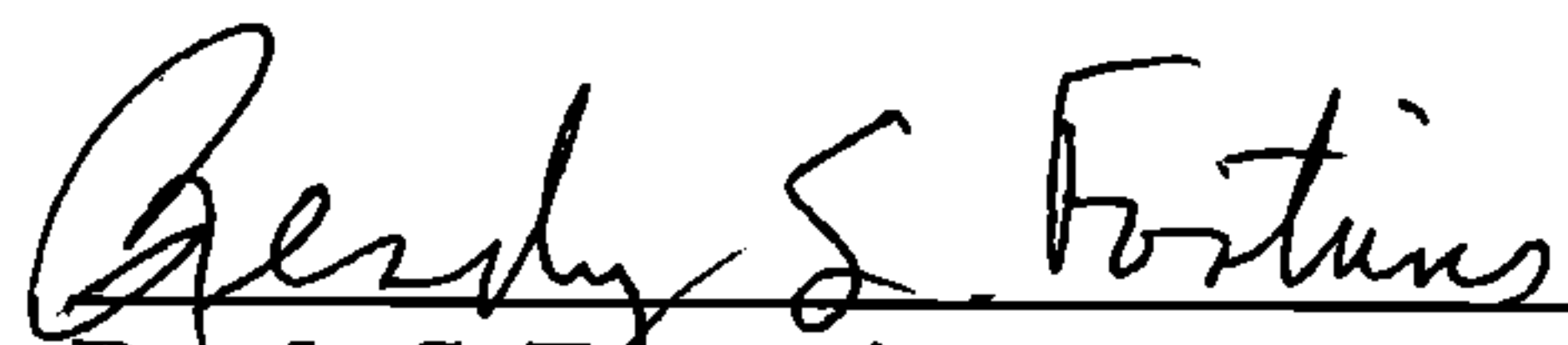

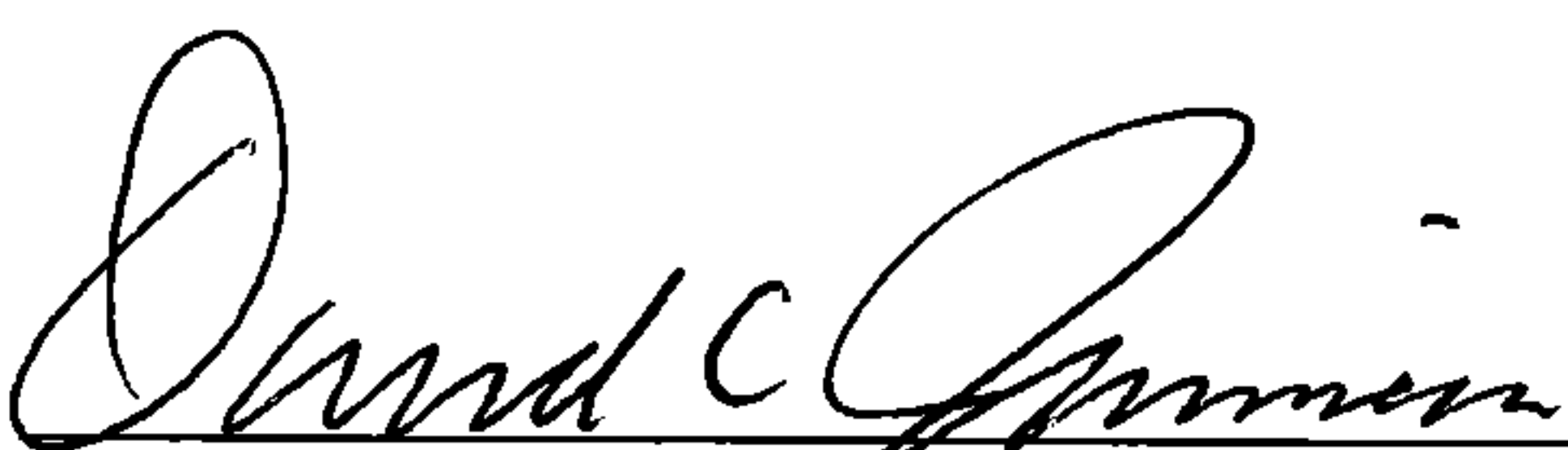
