

## SUMMARY OF PROCEDURES AND PROCEDURAL RIGHTS

- 1. Persons with an interest in property the State seeks to forfeit by this process must file either a claim or a petition for exemption with the prosecutor's office whose address is set forth below WITHIN THIRTY (30) DAYS after the effective date of this notice of pending forfeiture. Any such claim or petition must comply with Section 809A.11 of the Iowa Code and also as described in paragraph 6 below.
- 2. The prosecutor will provide in writing a Recognition of Exemption and Statement of Non-Exempt Interests to all persons who file petitions for exemption.
- 3. Any person who takes exception to the prosecutor's determination is required to file a claim within thirty (30) days of service of the written Recognition of Exemption and Statement of Non-Exempt Interests. If this claim is not filed, the person waives further rights to raise claims to the property.
- 4. If no one files a claim objecting to the prosecutor's determination of interests, the prosecutor shall prepare a written declaration of forfeiture if the value of the value of the property is \$5,000 or less or will apply to the court for an order confirming those interests and finalizing rights of all parties as determined by the written Recognition of Exemption and Statement of Non-Exempt Interests.
- If one or more claims is filed objecting to the prosecutor's determination of interests the prosecutor will file a judicial forfeiture proceeding in the district court and a hearing will be scheduled for a judge to determine the interests of the parties.
- 6. The requirements for claims and petitions pursuant to 809A.11 are as follows:

The claim or petition and all supporting documents shall be in affidavit form, signed by the claimant under oath, and sworn to by the affiant before one who has authority to administer the oath, under penalty of perjury, and shall set forth all of the following:

- a. The caption of the proceedings and identifying number, if any, as set forth on the notice of pending forfeiture or complaint, the name of the claimant or petitioner, and the name of the prosecuting attorney who authorized the notice of pending forfeiture or complaint.
- b. The address where the claimant or petitioner will accept mail.
- c. The nature and extent of the claimant's or petitioner's interest in the property.
- d. The date, the identity of the transferor, and the circumstances of the claimant's or petitioner's acquisition of the interest in the property.
- e. The specific provision of law relied on in asserting that the property is not subject to forfeiture.
- f. All essential facts supporting each assertion.
- g. The specific relief sought.
