County of Shelby

That in consideration of the sum of **Four Hundred Eighty Two Thousand Five Hundred Dollars and No Cents (\$482,500.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Billy Franklin**, a married man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Michael Austin Franklin and Reagan Elizabeth Franklin**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Block 86, according to Dunstan's Map of the Town of Calera, Shelby County, Alabama.

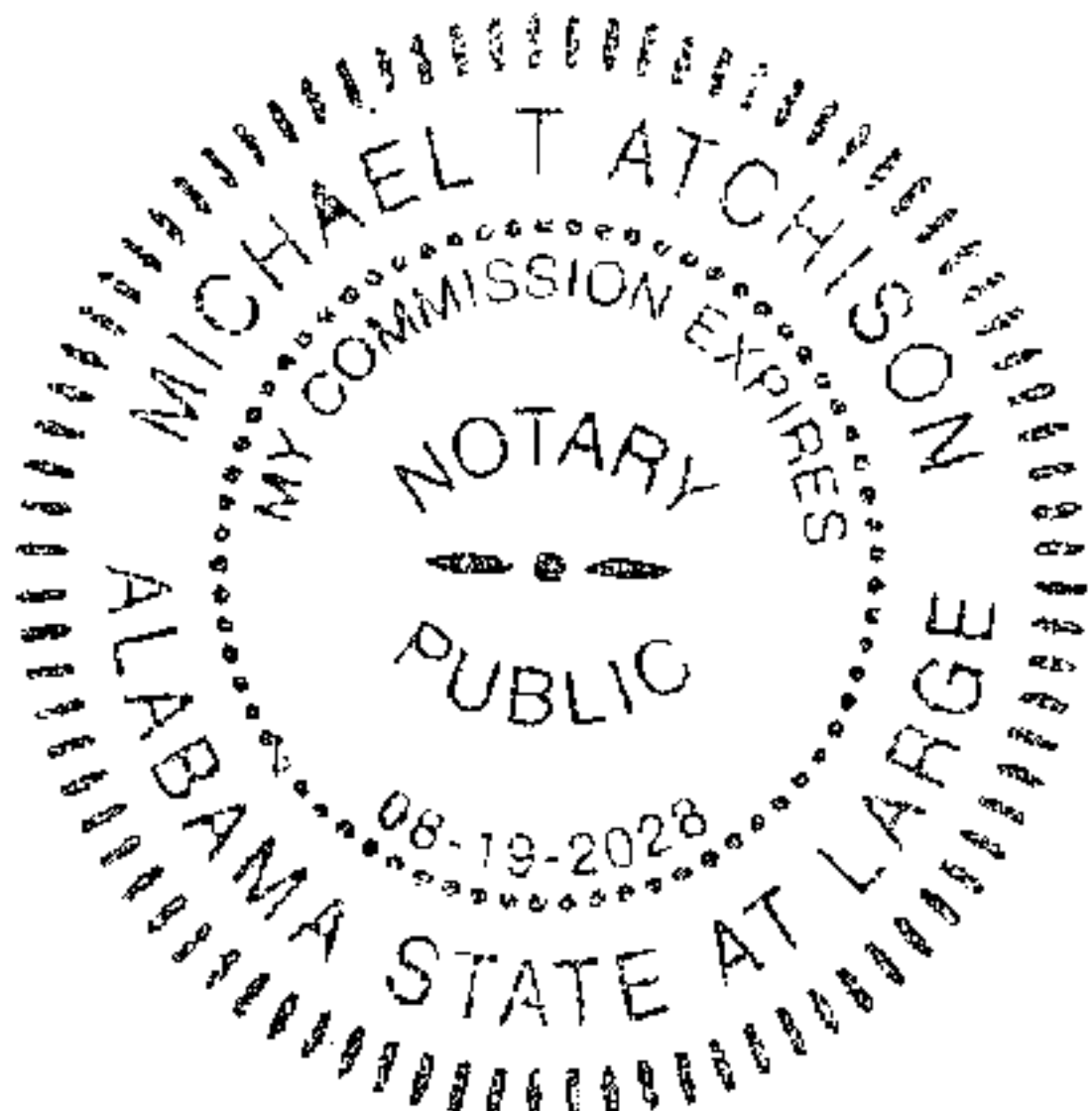
