That for and in consideration of **ONE HUNDRED FIFTY FIVE THOUSAND AND NO/100 (\$155,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **LEO STEVEN LOWERY, an unmarried man, and MICHAEL KEITH LOWERY, an unmarried man**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **CHRIS MANISCALCO**, (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 2, Block 3, according to the Map of Navajo Hills First Sector, as recorded in the Probate Office of Shelby County, Alabama, in Map Book 5, Page 18, in the Probate Office of Shelby County, Alabama.

Mary Louise Lowery aka Louise Lowery died on or about October 5, 2024.


