FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, February 13, 2023, Arturo Henderson and Linda Henderson, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Fairway Independent Mortgage Corporation, which said mortgage was recorded in Instrument Number 20230214000039510 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Lakeview Loan Servicing, LLC by instrument recorded in Instrument Number 20240423000118580 in the aforesaid Probate Office (hereafter "Transferee"); and

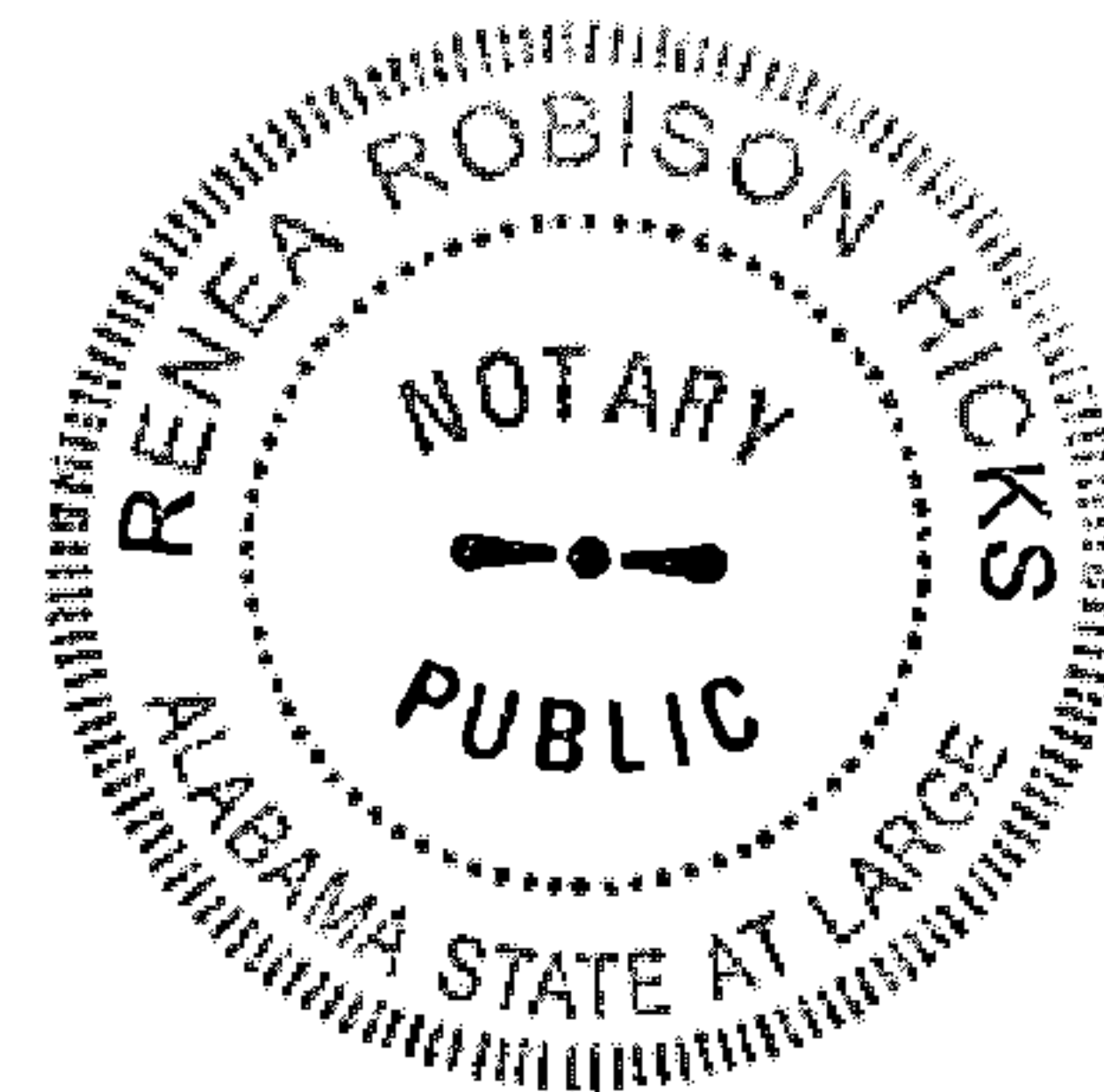

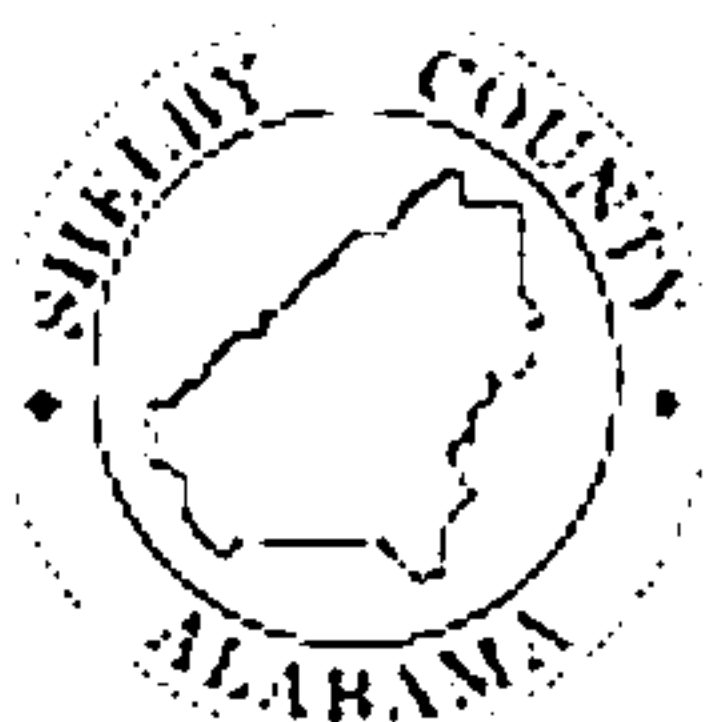
