KNOW ALL MEN BY THESE PRESENTS: That in consideration of **Four Hundred Twenty Thousand and No/100 Dollars (\$420,000.00)** and other good and valuable consideration, to the undersigned grantor, in hand paid by the grantees herein, the receipt where is acknowledged I, **Paul W. Gamble and Fionnuala F. Gamble, a married couple** (herein referred to as grantor), grant, bargain, sell and convey unto **Iris Claros and Luis Claros** (herein referred to as grantees) for and during their joint lives, and upon death of any of them, then to the survivor(s) of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in **Shelby County, Alabama**, to wit:

Lot 1 according to the Addition of Lot 1 First Addition to Riverchase Country Club as recorded in Map Book 8 Page 43 in the Office of the Judge of Probate of Shelby County, Alabama.

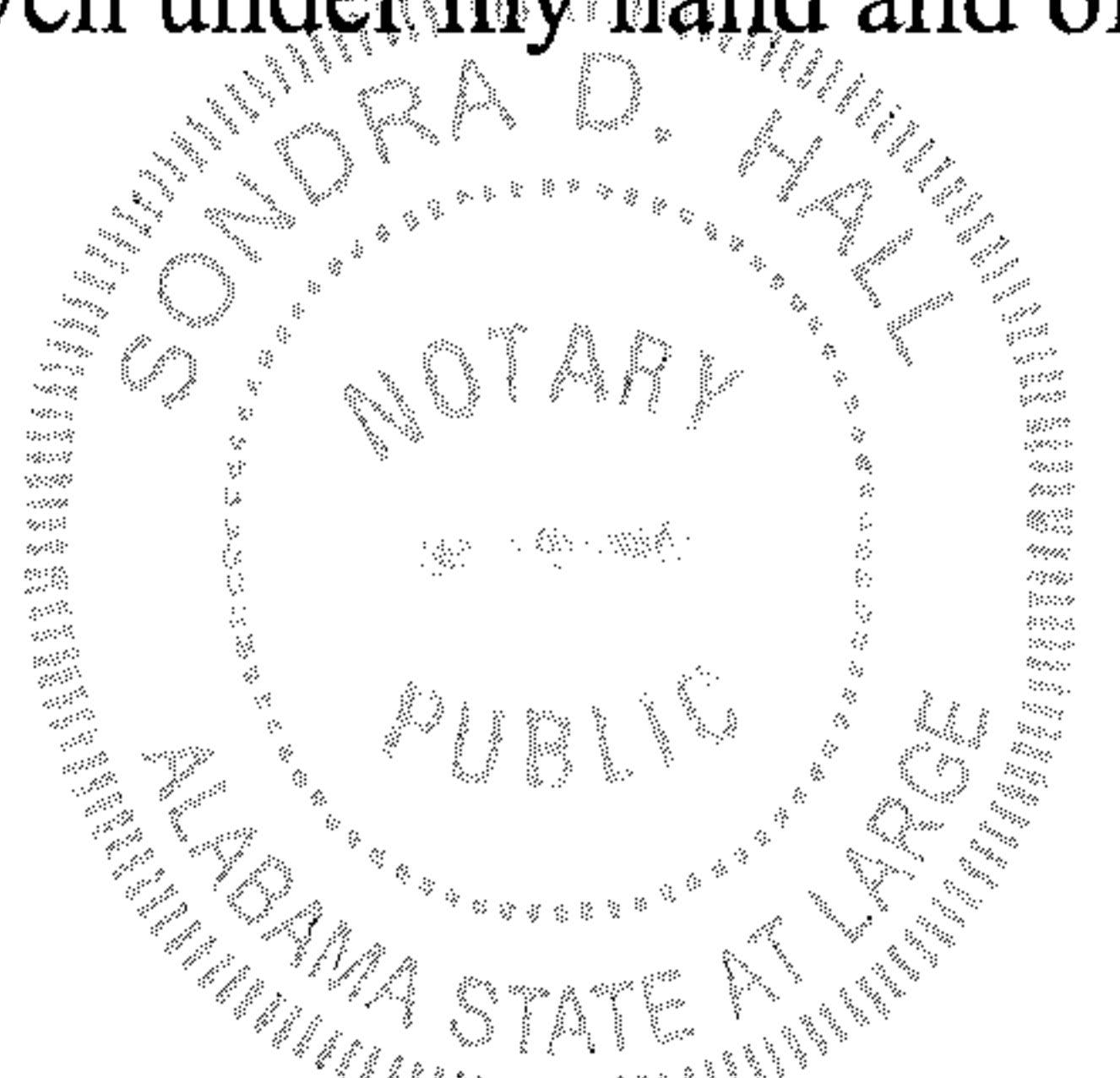
