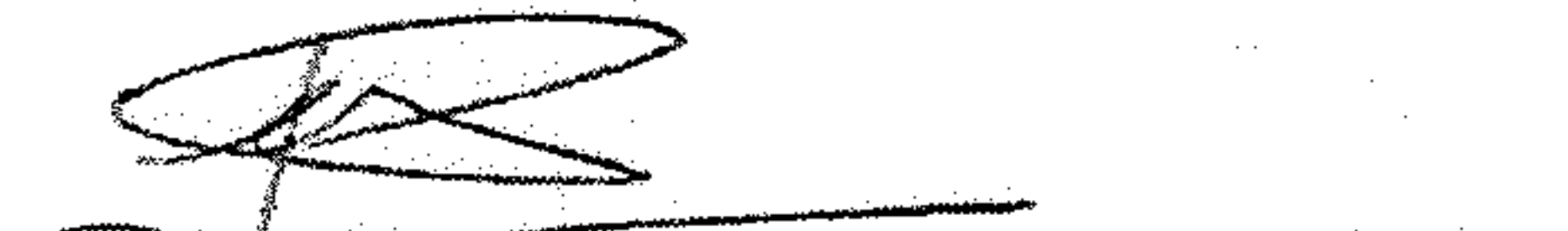
Subject to a third party mortgage in the amount of \$369,562.00 executed and recorded simultaneously herewith.

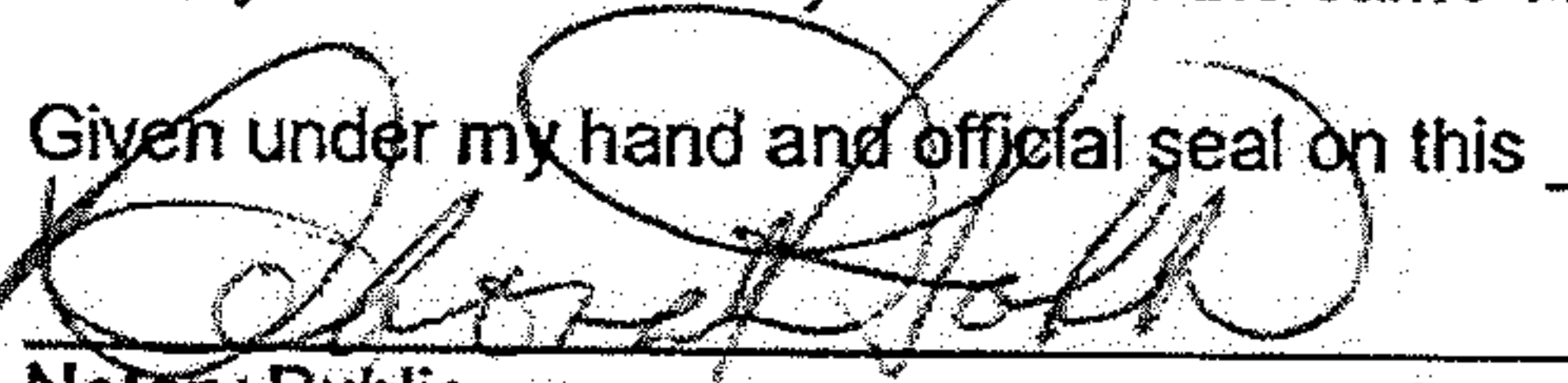
