EX PARTE TEMPORARY RESTRAINING ORDER

This matter came before the Court on Plaintiff's VERIFIED COMPLAINT, MOTION FOR EX PARTE ORDER DISMISSING LIEN DUE TO IRREPERABLE HARM and RULE 65(b) Certification filed on or about October 15, 2025. Upon the court's review thereof, it is therefore

ORDERED, ADJUDGED and DECREED as follows:

1. That the lien at issue in this cause, claiming indebtedness upon 48 County Road 107, Montevallo, Alabama 35115 in the amount of Fifty-six thousand one hundred forty-eight dollars and twenty-seven cents (\$56,148.27), appears on its face to be invalid, and is hereby DISMISSED.
