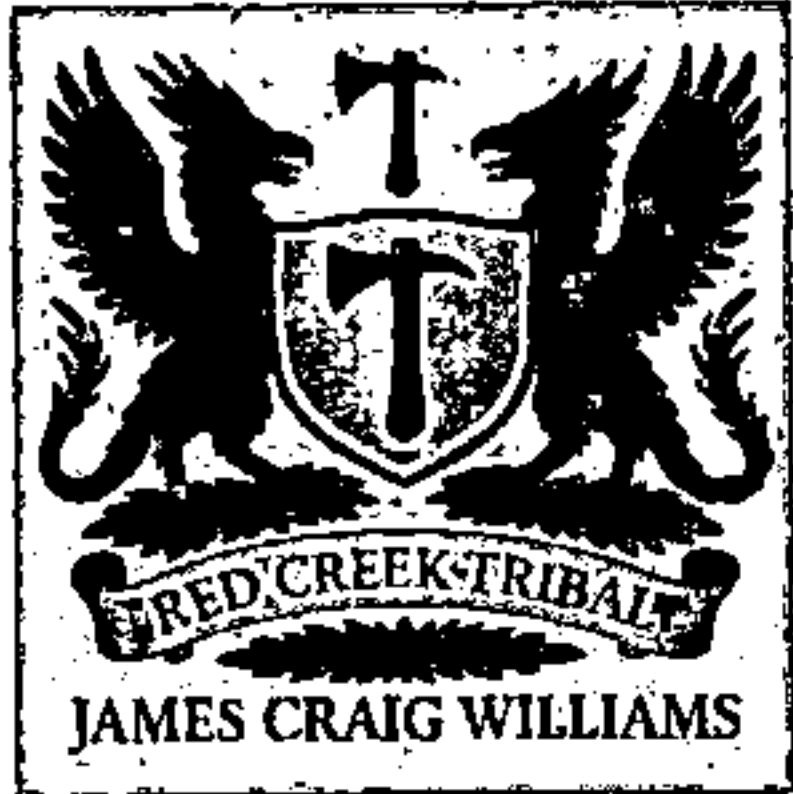

- It is self-executing and binding upon all parties engaging in commercial or related to The Consumer Life Estate and Dynastic Trust.*

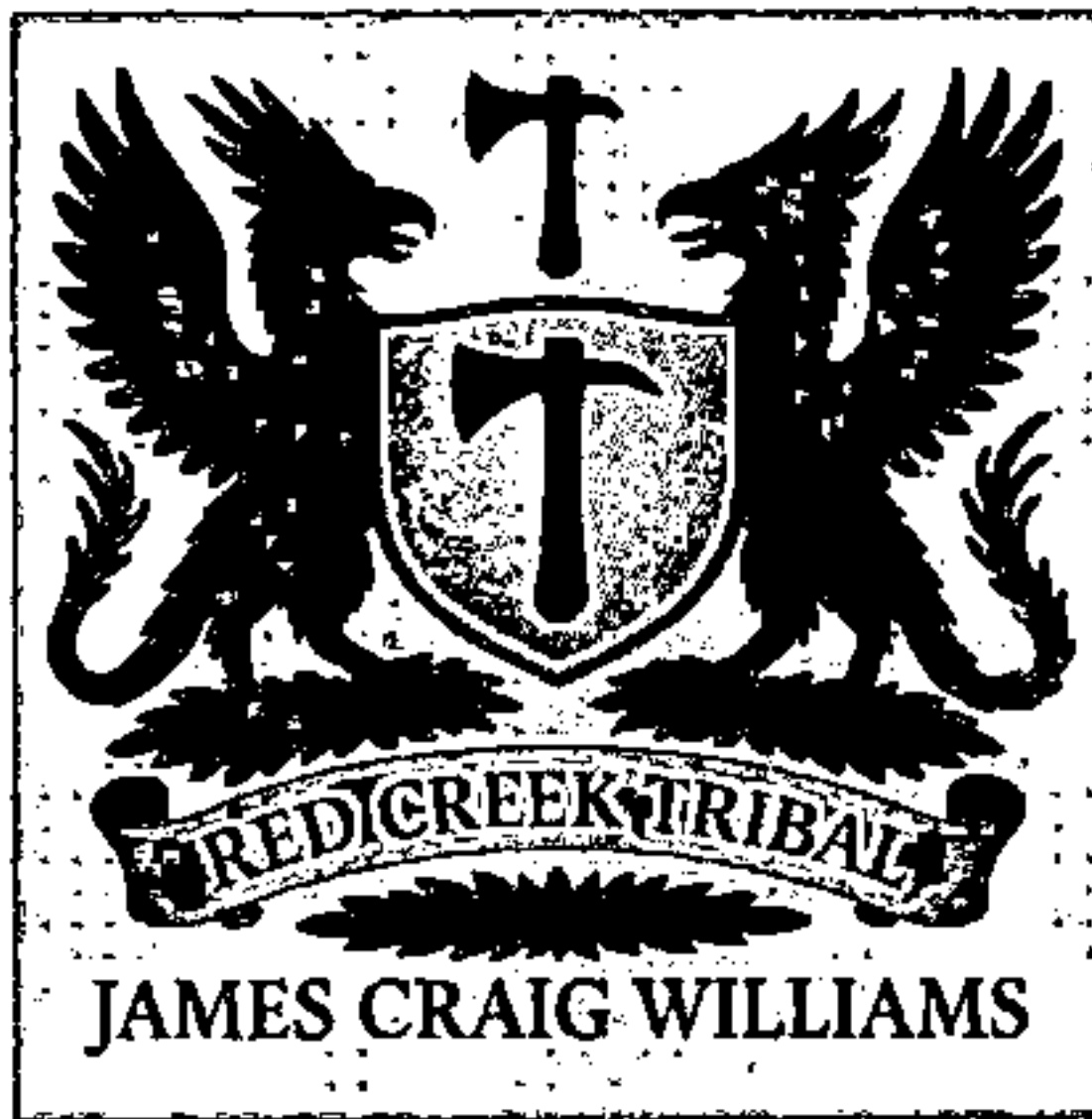

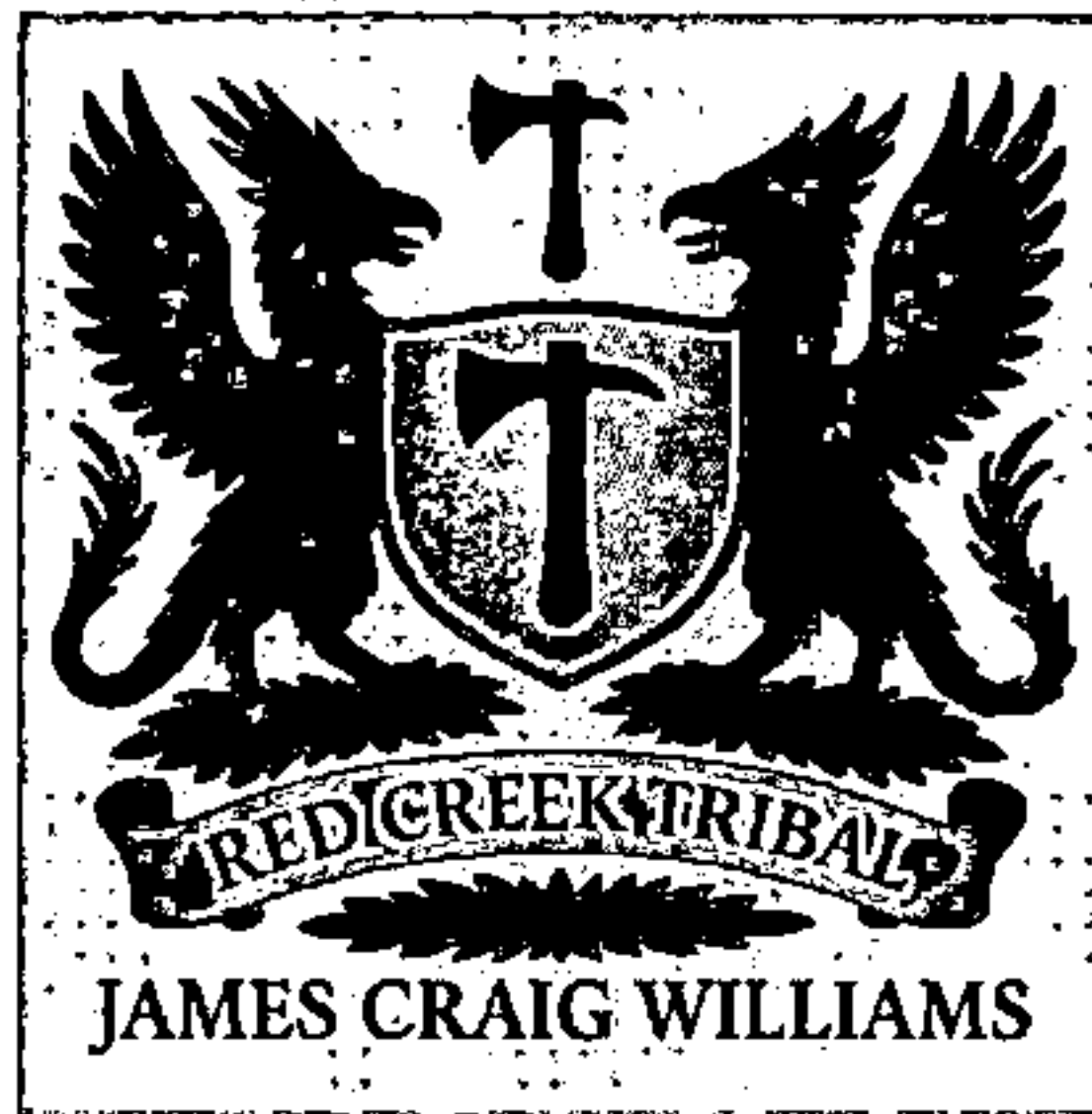

- Commercial Liability – All trust-designated assets, funds, and proprietary data remain exempt from commercial encumbrances, ensuring immunity from unauthorized claims.

This provision operates under common law jurisdiction, enforcing absolute legal protections for all trust participants.

Article IV – Spendthrift Clause & Asset Protection

To secure and protect trust assets from unauthorized claims or misallocation, this Spendthrift Clause is established, ensuring \$100 million shall be allocated for the beneficiaries, enforceable upon principles of acceptance.

A. The Williams Trustees may deem any and all goods, services, and properties exempt from any and all commercial activity, preventing statutory taxation or regulatory interference.

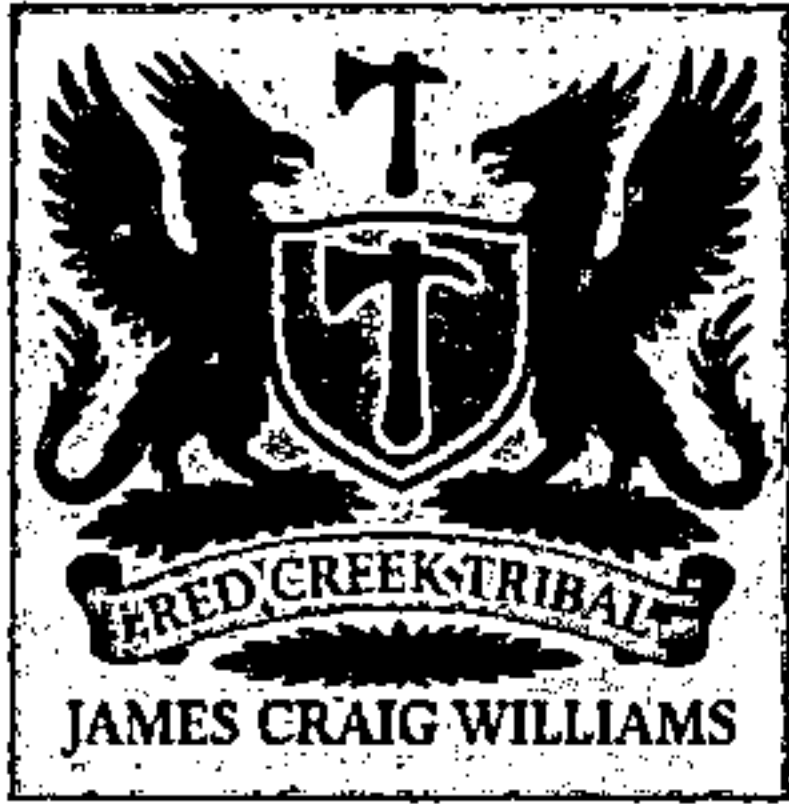
B. The Trustee retains discretion to restrict commercial interference, preserving private financial sovereignty.
