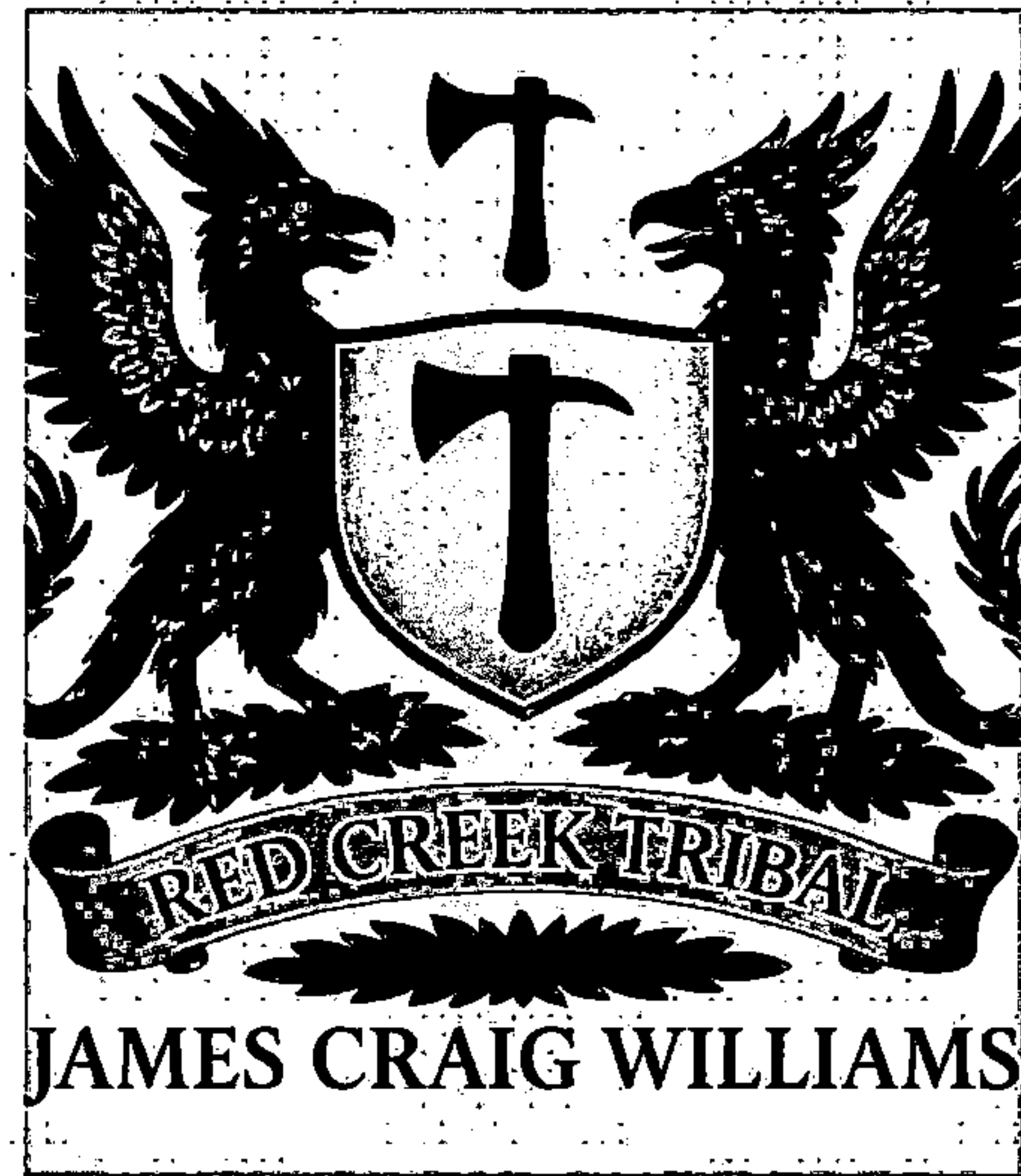

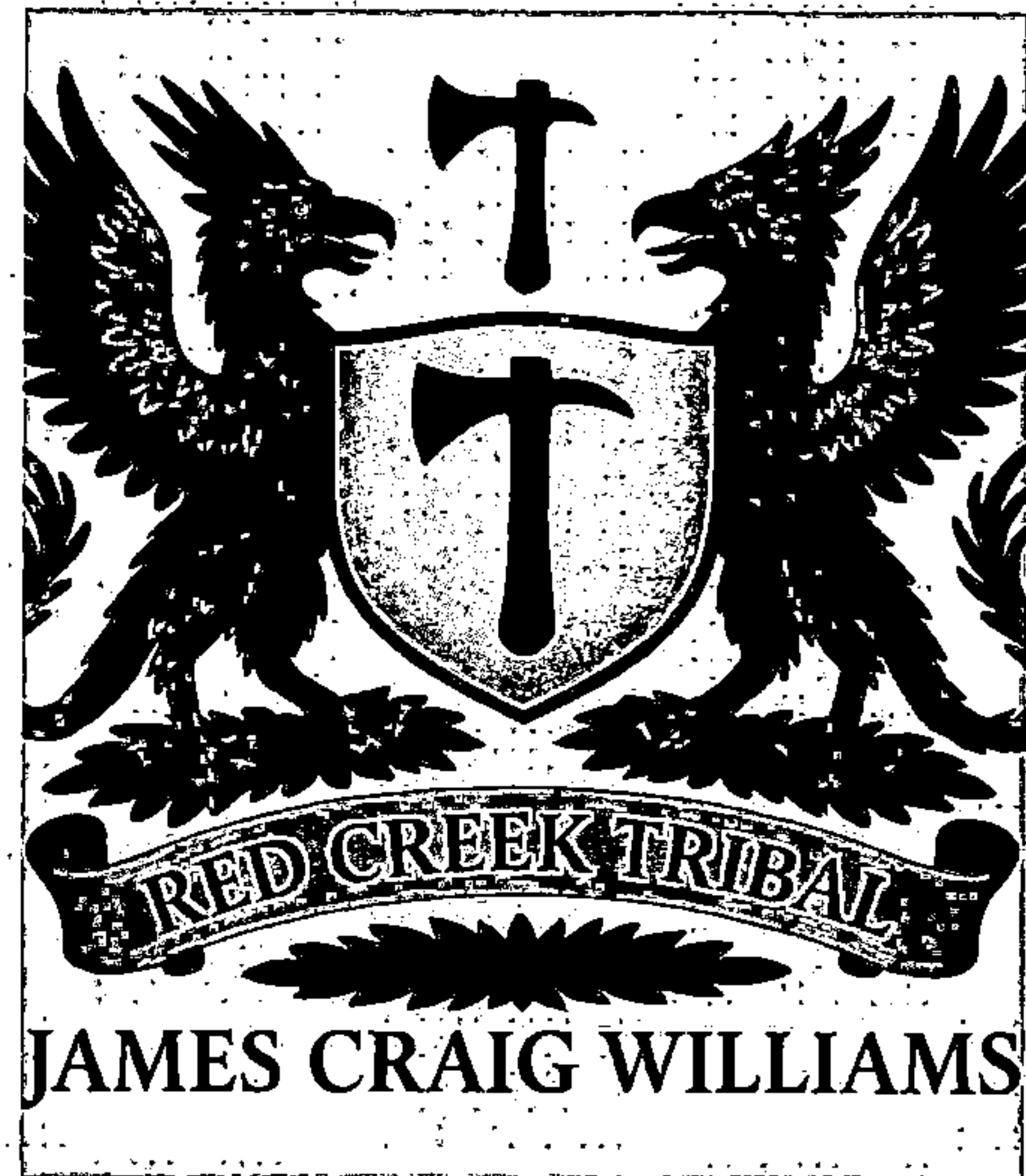

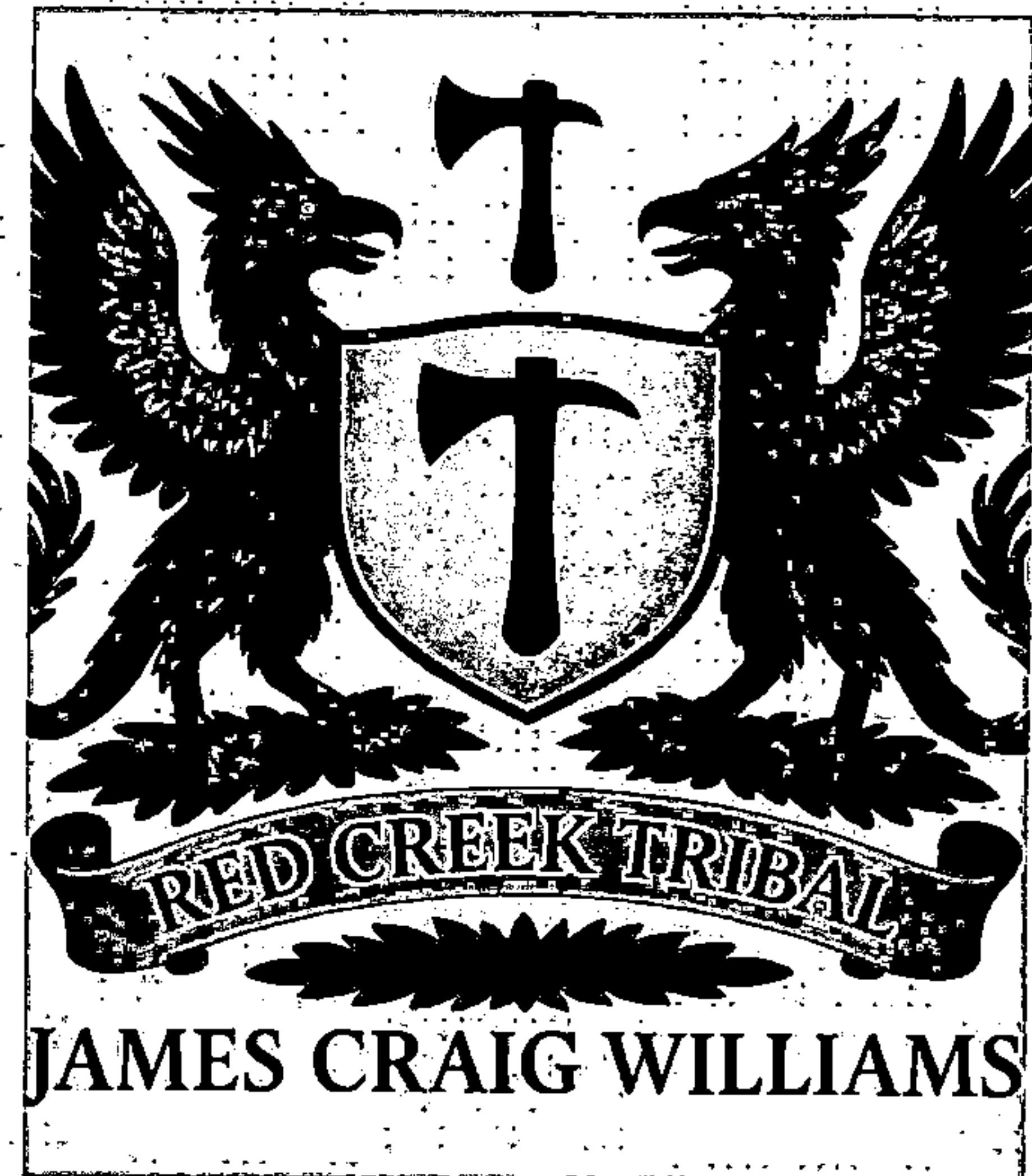
ARTICLE II

All assets will be used primarily for personal, family and household usage only. Sole ownership lies solely with the [James Craig Williams] Consumer Life Estate.

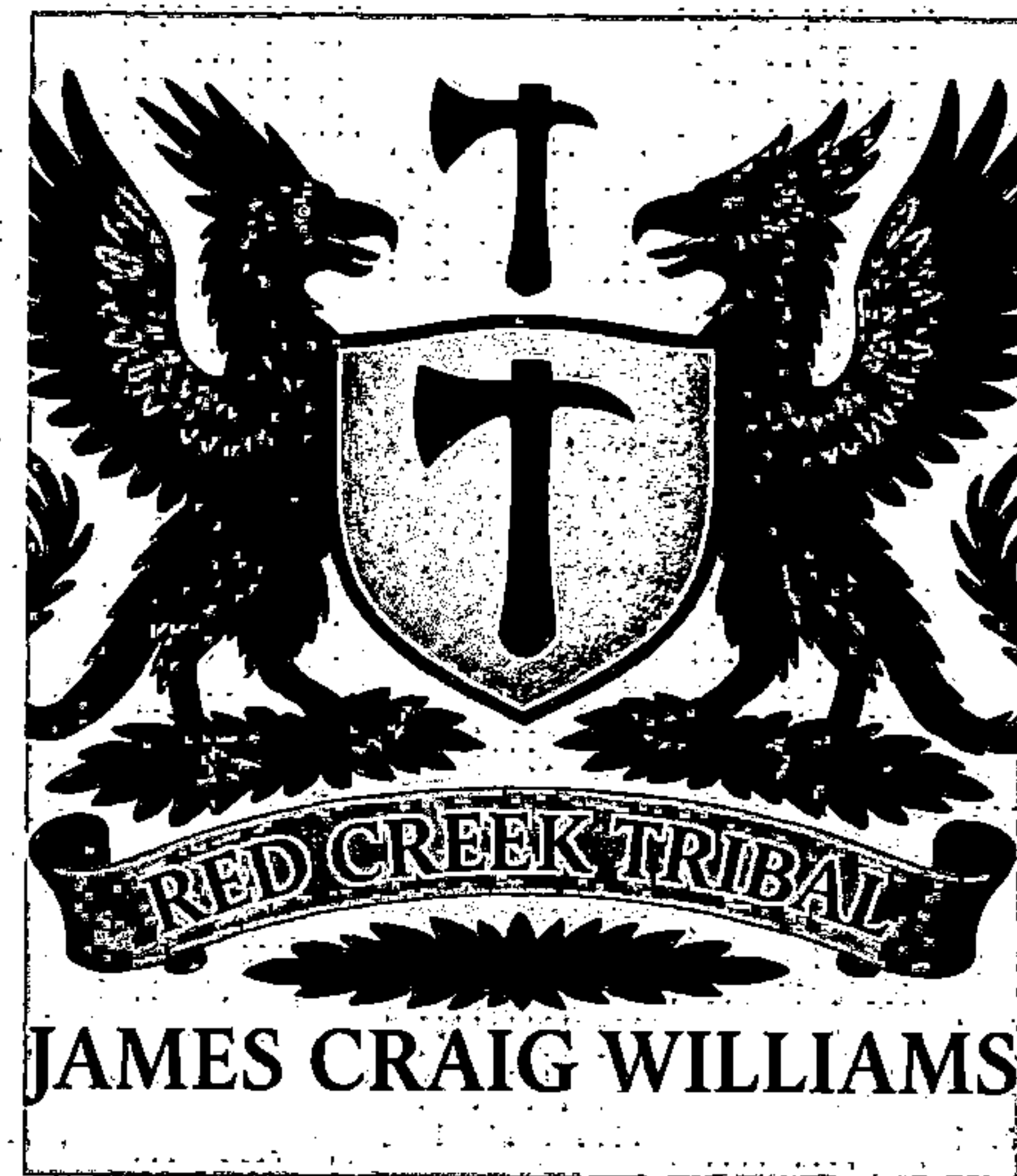
Stipulation II.

All driver licences and auto insurances held by the Secretary of State or DMV shall reimburse the Estate of [James Craig Williams] Five million USD for back wages and compensation plus health care, dental, and vacation pay that was never received. (49 U.S. Code section 31301 (6)(7)(8))

Stipulation IV

A full investigation and autopsy is to be done upon death.

Stipulation V

All beneficiaries, and Executors listed in regards to the [James Craig Williams] Consumer Life Estate are not bound by any institutions created by men. They are to be protected from any criminal and civil actions as natural assets to the [James Craig Williams] Consumer Life Estate and Trust

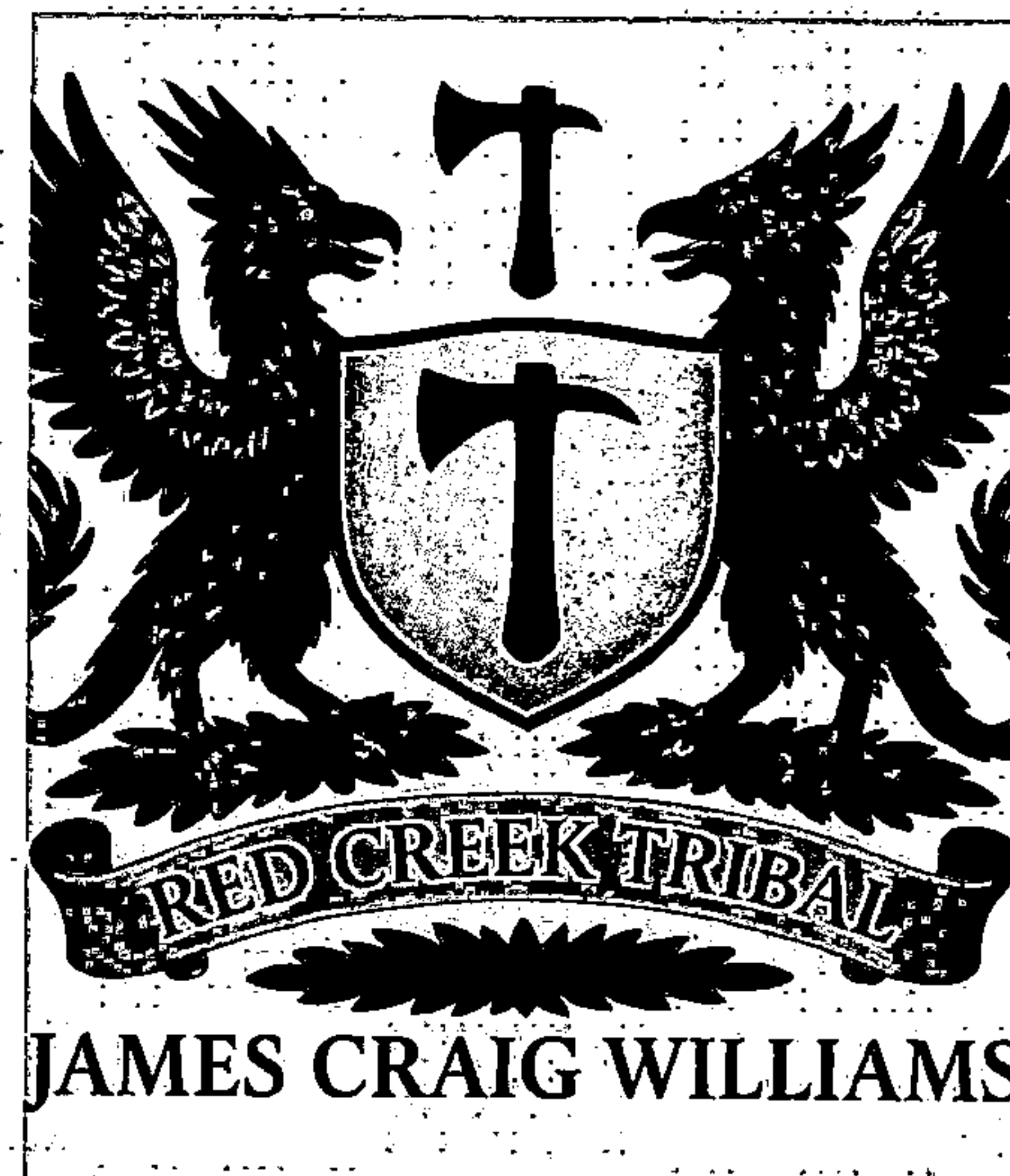
Stipulation VI

C. Remaining Tangible Personal Property.

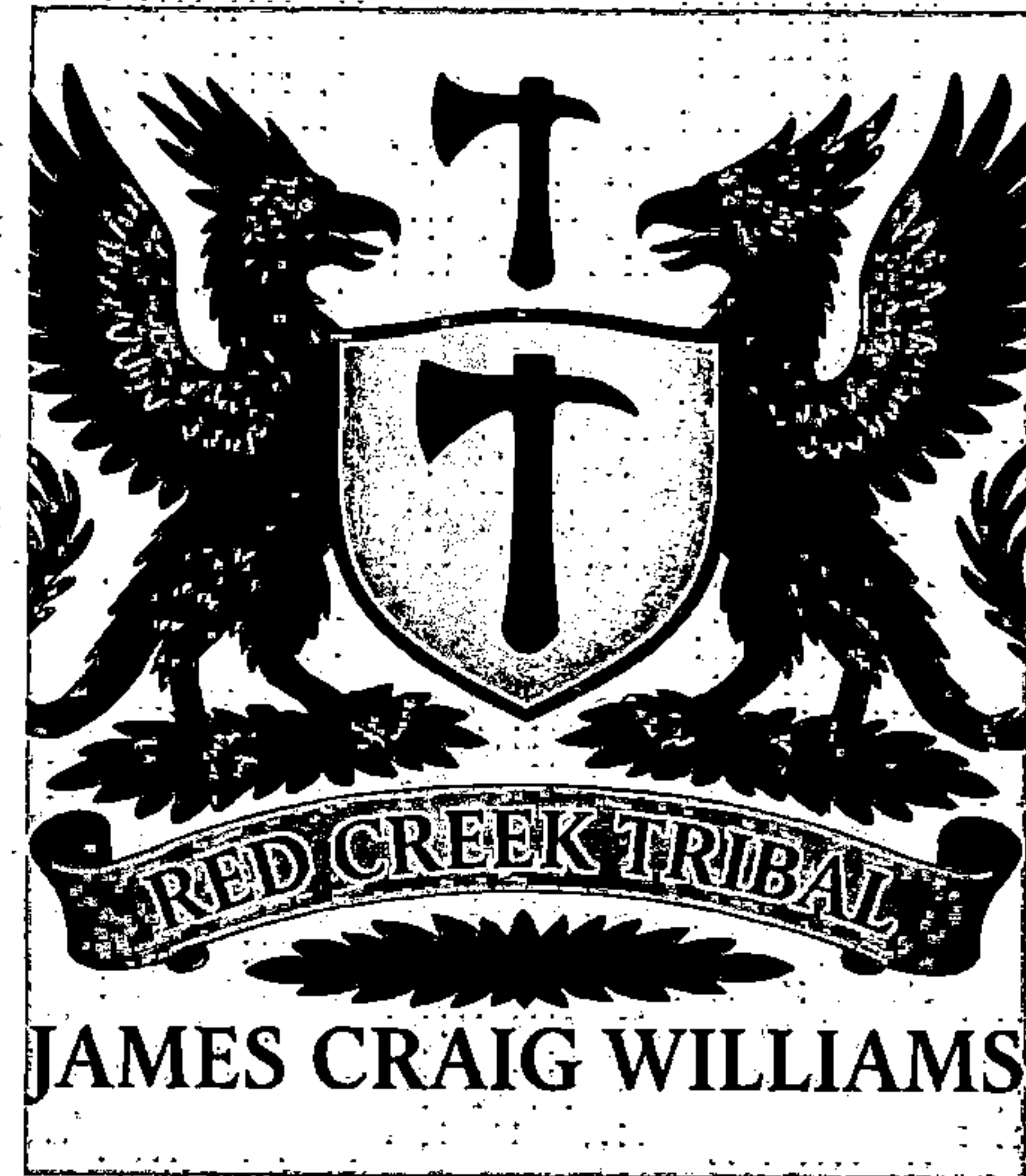
My remaining tangible personal property shall be distributed to All remaining Heirs. If those beneficiaries do not survive me, this property shall be distributed with my residuary estate.

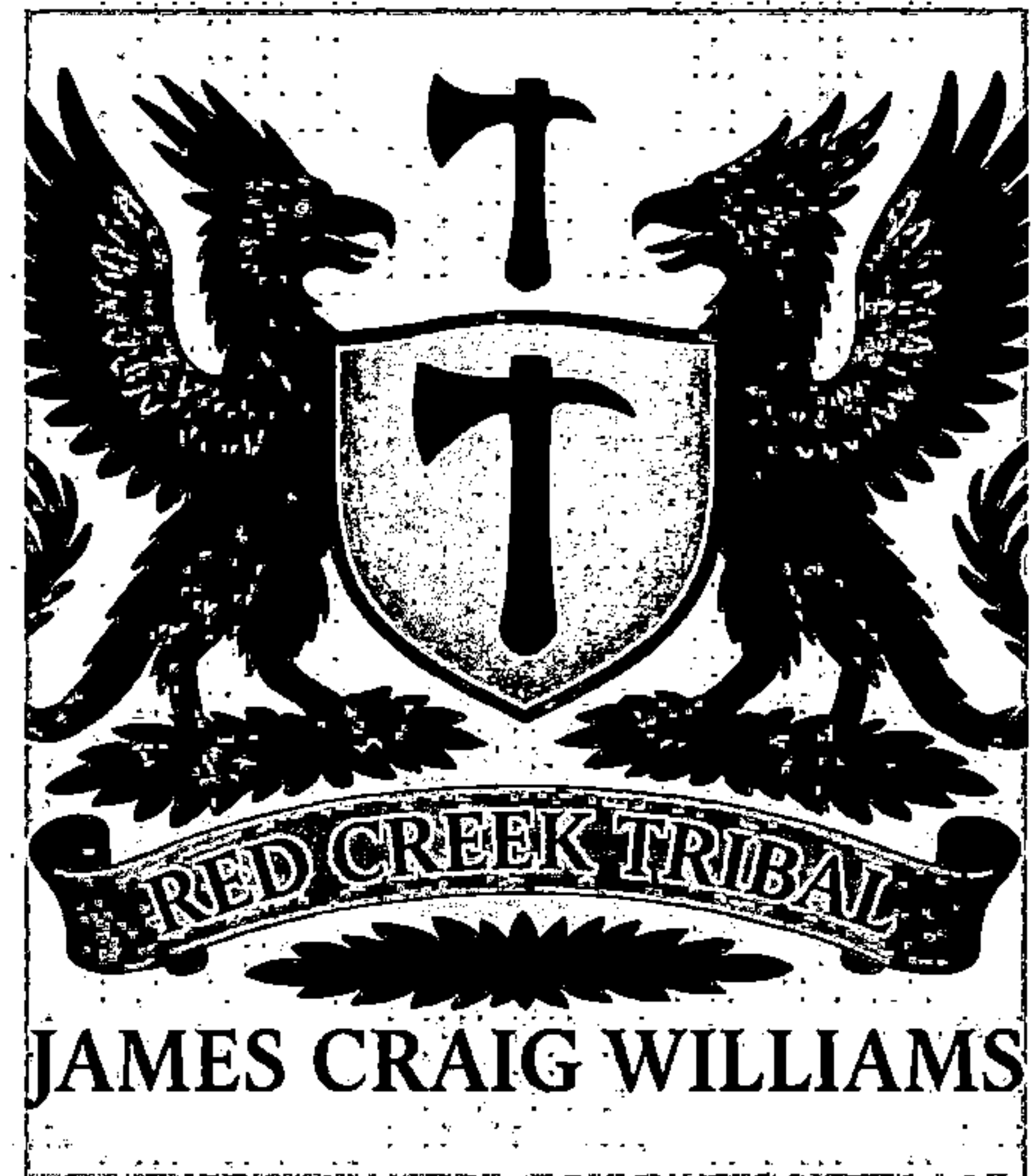

A. Power to Administer Estate.

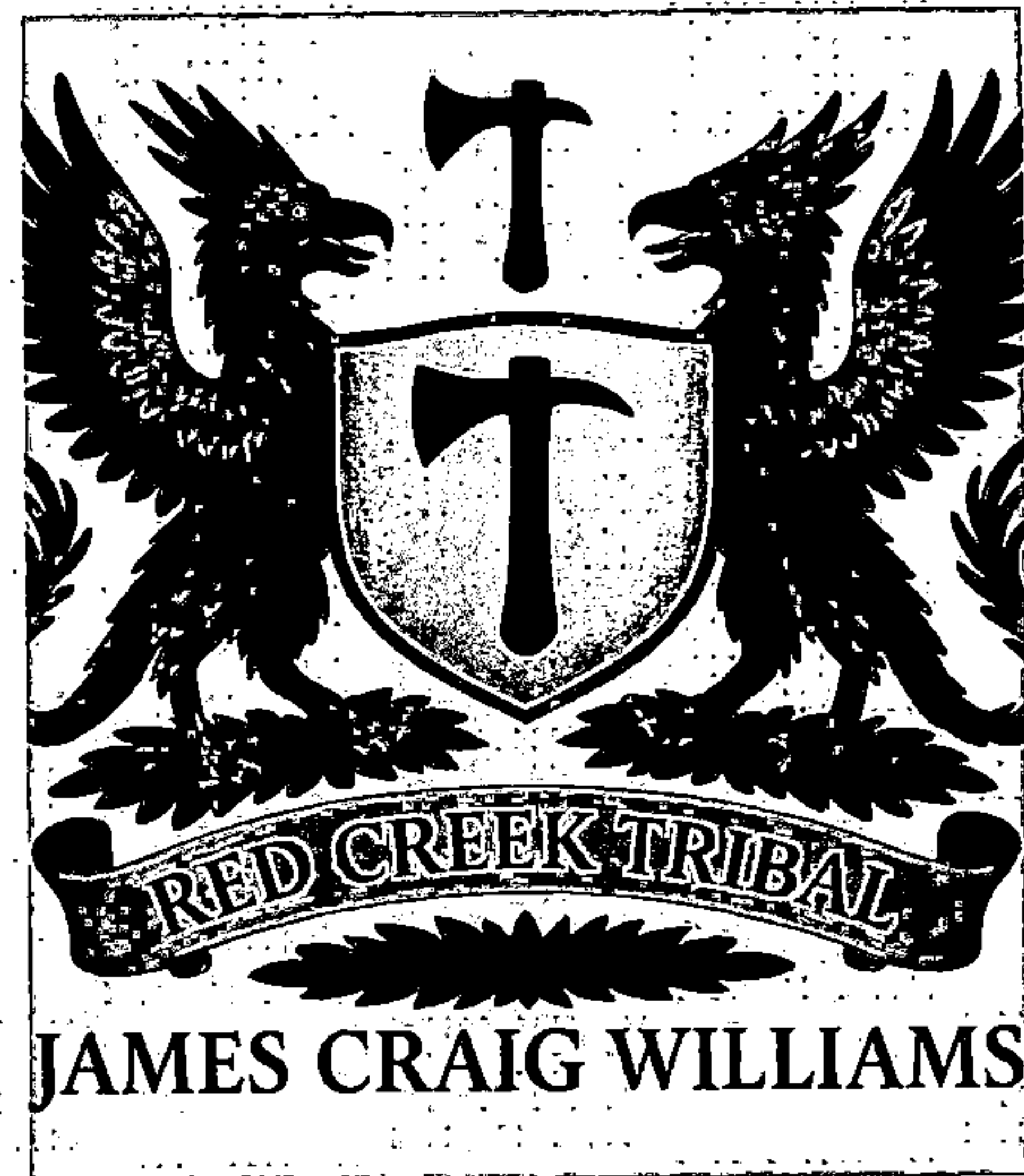

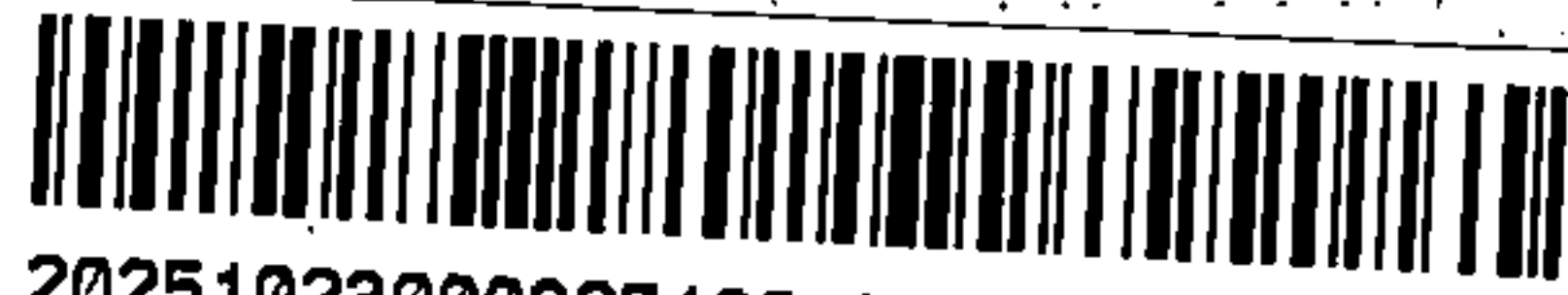

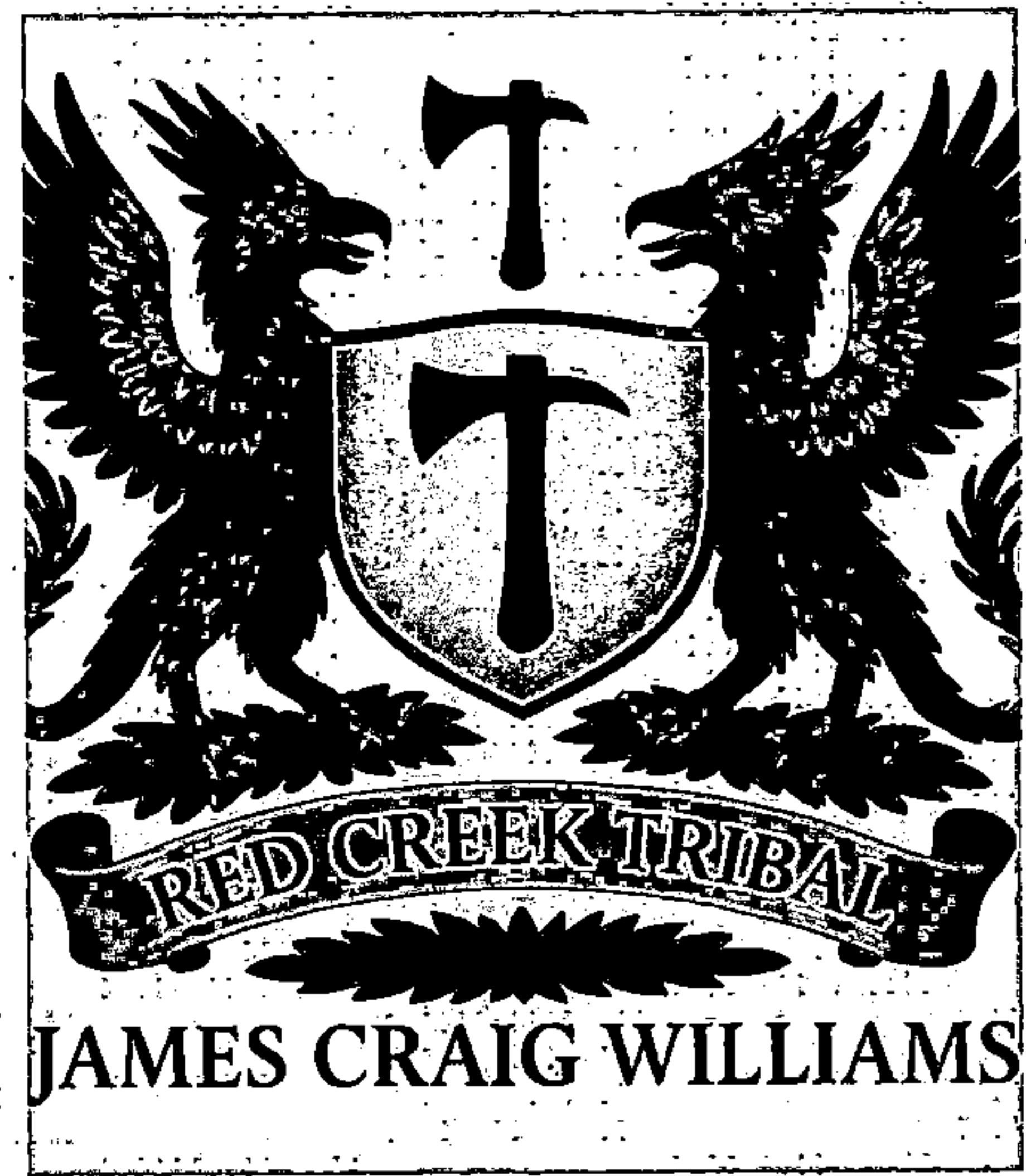
A. Digital Executor

My Digital Executor, in addition to other powers and authority granted by law or necessary or appropriate for proper administration, shall have the right and power to manage, distribute, and/or terminate my digital assets in accordance with this Will. Letter of Instructions incorporated by reference into this Will, without order of court and without notice to anyone. My Digital Executor's powers shall include, but not be limited to, the powers to access any and all devices as necessary to manage digital assets, to clear computer caches and to delete files. The Digital Executor shall also:

- 1. Standard of Care. Manage, distribute, and/or terminate my digital assets, exercising the judgement and care, under the circumstances then prevailing, that the persons of prudence, discretion and intelligence exercise in the management of their own affairs, not in regard to speculation but in regard to the permanent disposition of their digital assets, considering the probable safety of their digital assets.***
- 2. Employ Professional Assistance. Employ and compensate counsel and other persons deemed necessary by the Digital Administrator for proper administration of my digital assets.***
- 3. Delegated Authority. when such delegation is advantageous to the estate or to the management, distribution and/or termination of my ALL assets.***

MISCELLANEOUS PROVISIONS

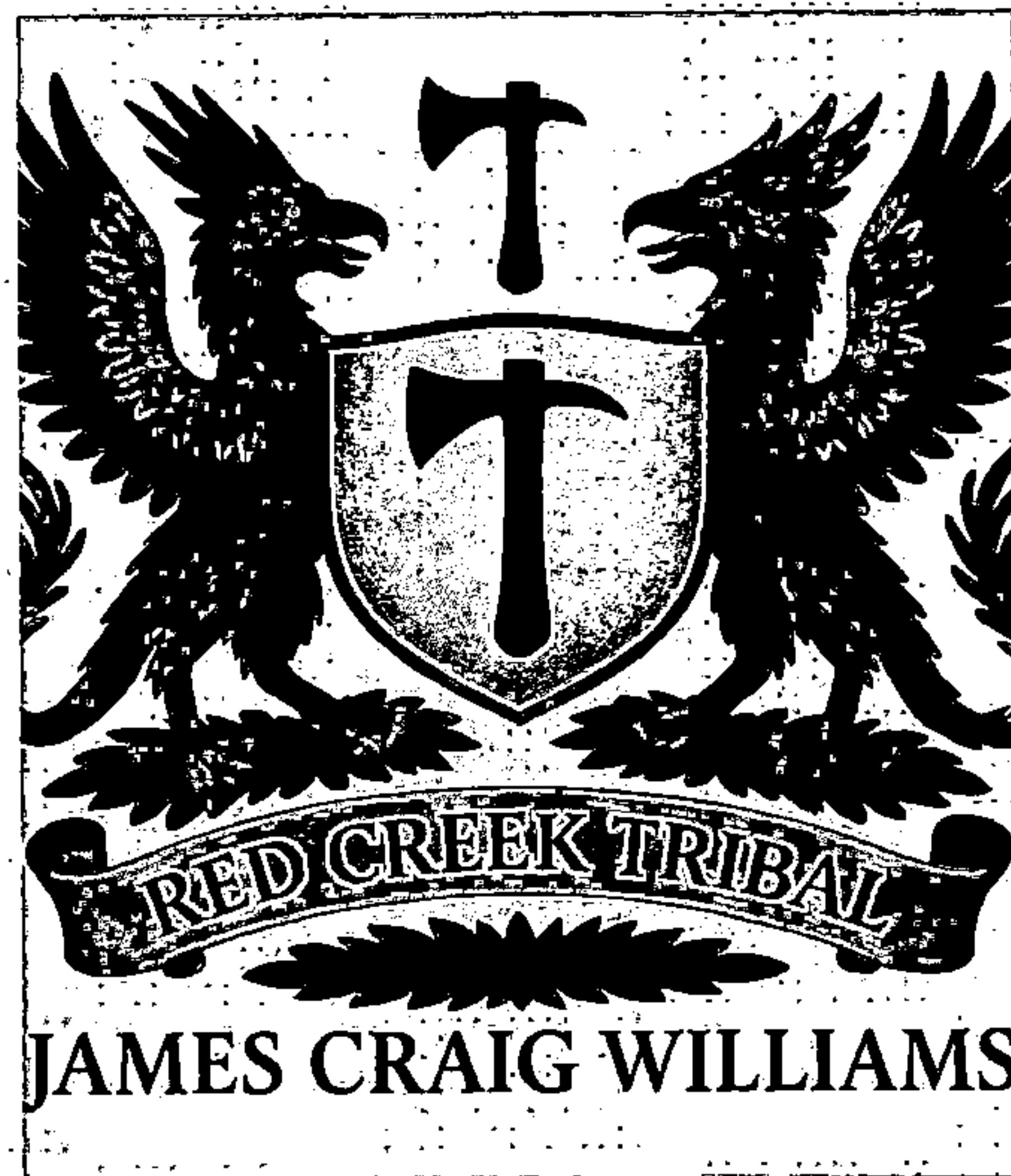
A. Paragraph Titles and Gender.

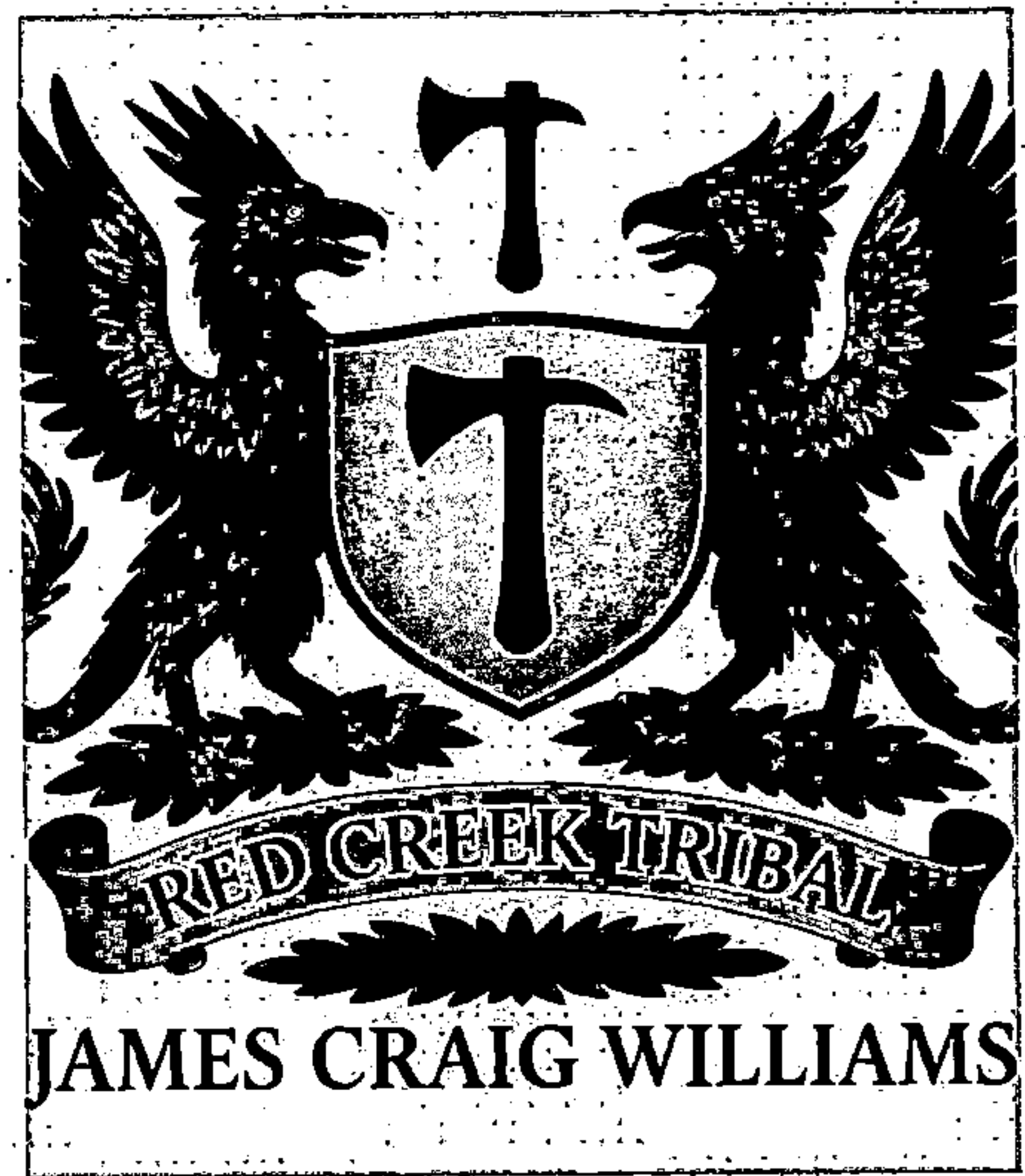

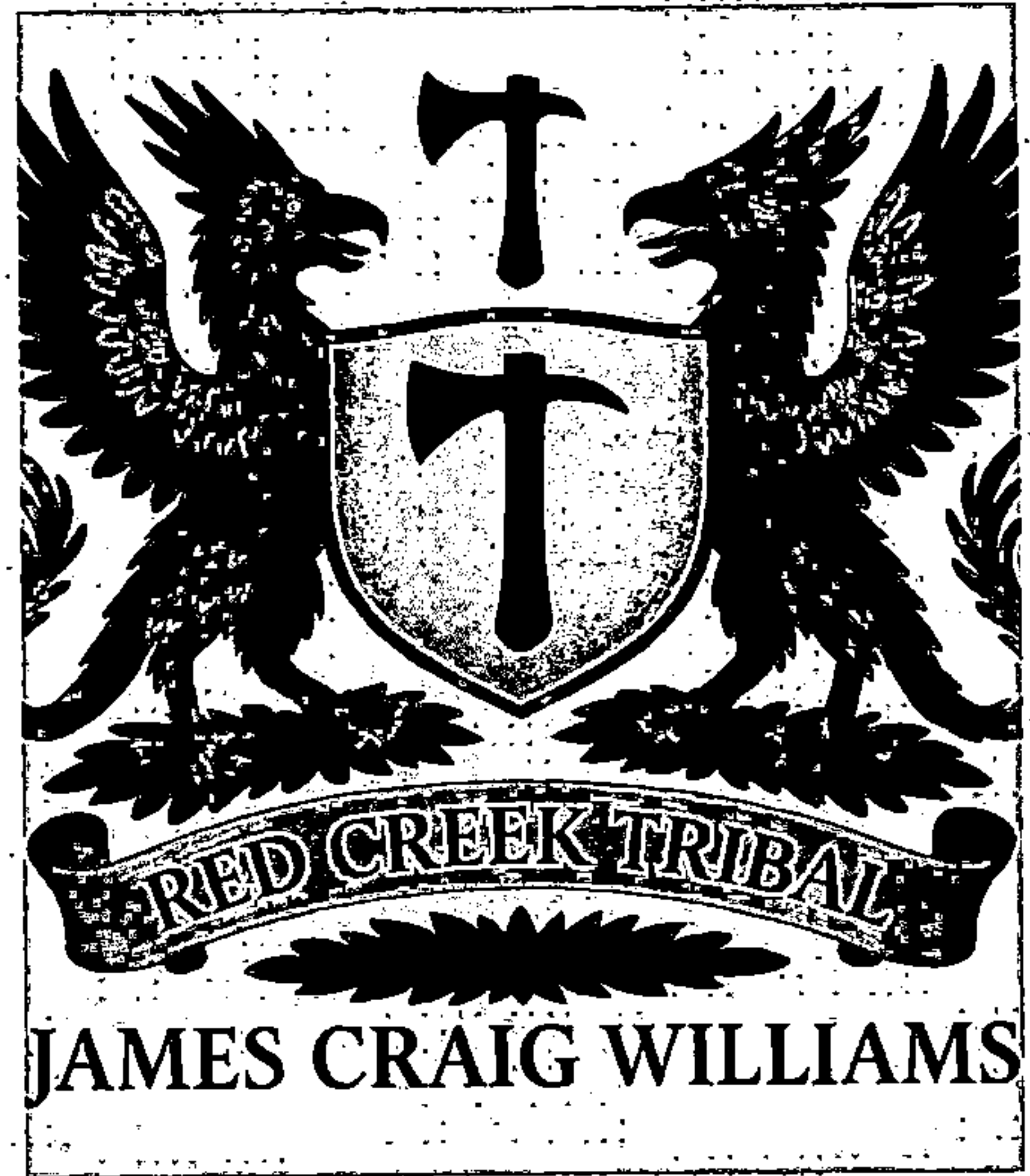

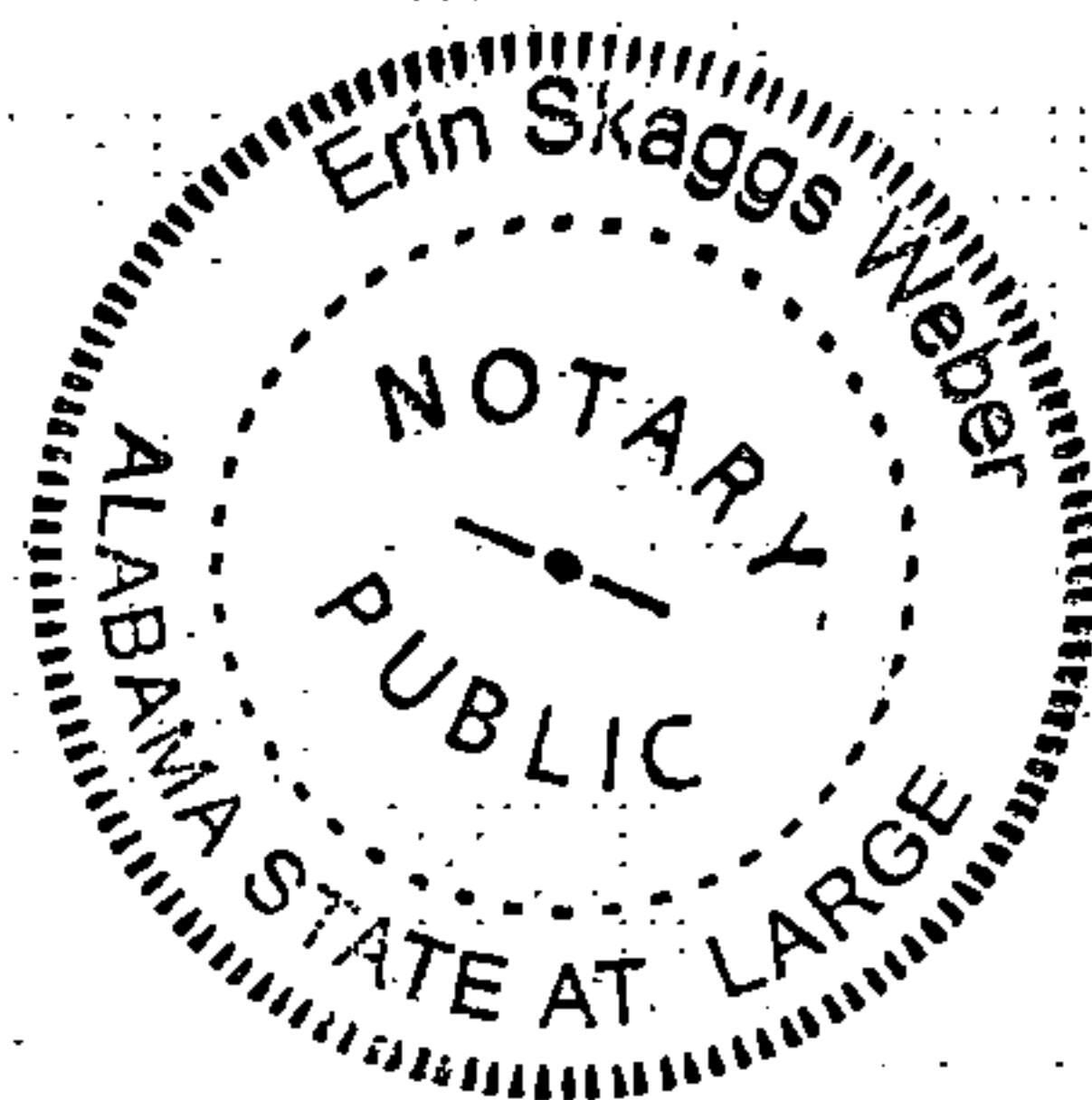
