BOOK 6, PAGE 60, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA

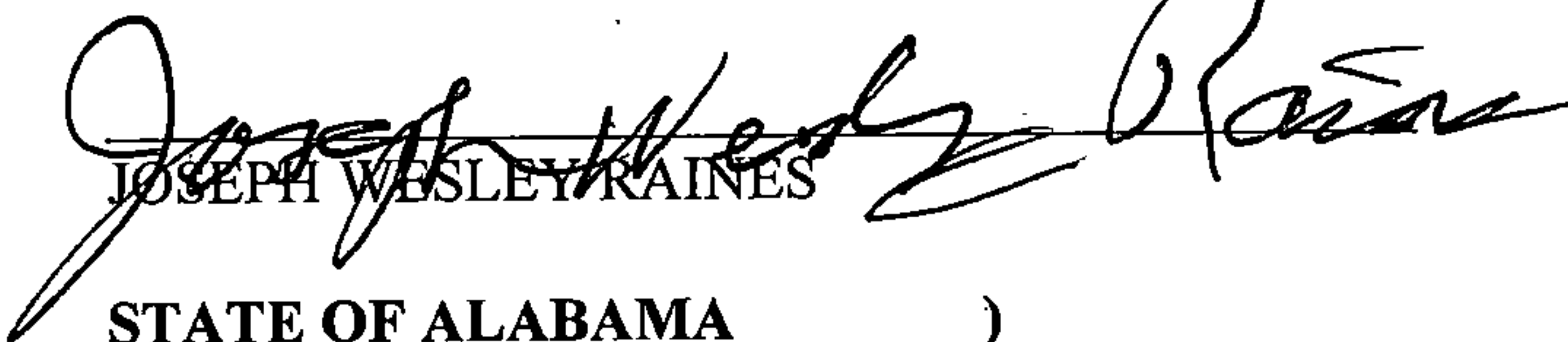
Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

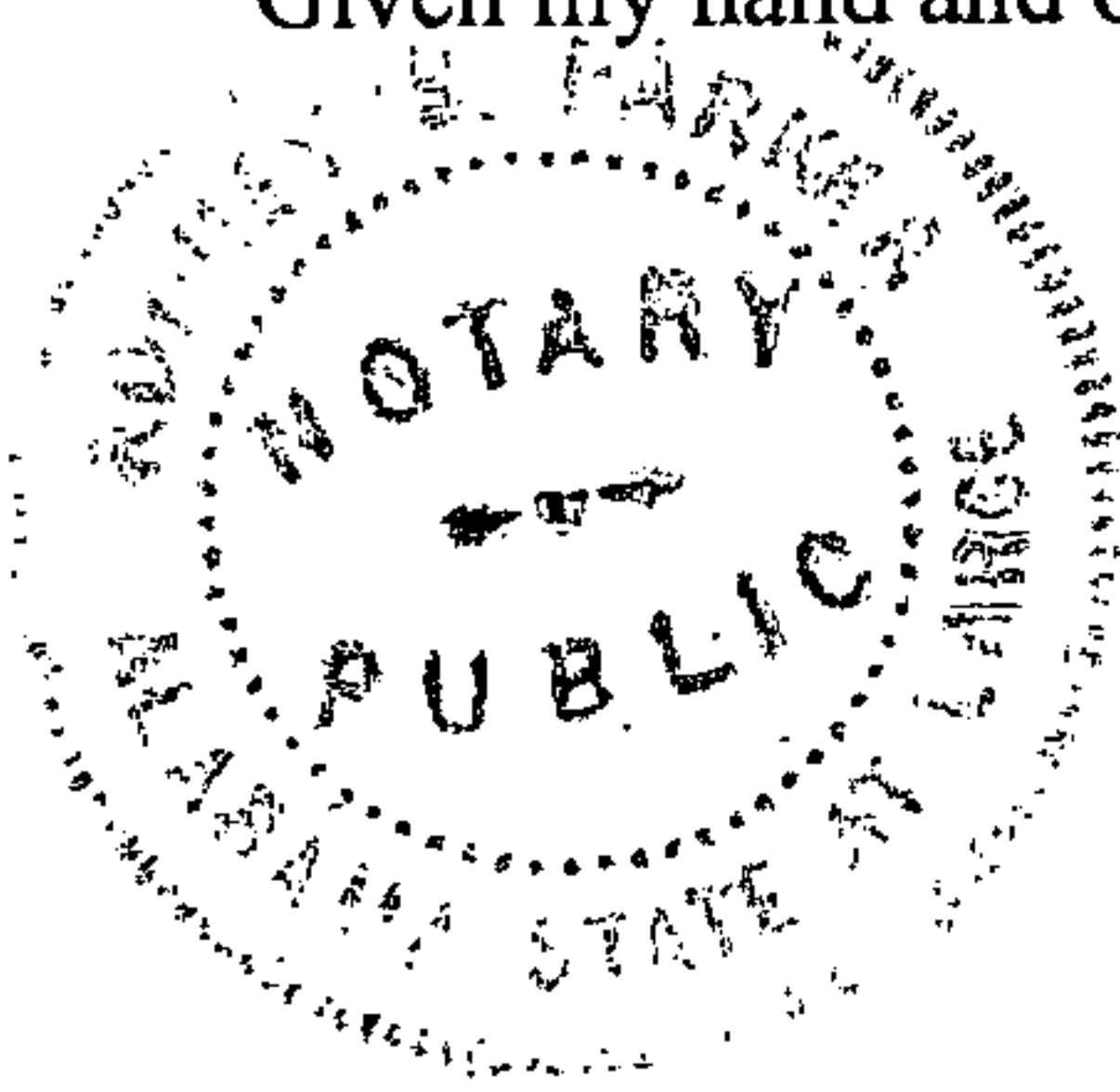
