OFFICE OF SHELBY COUNTY, ALABAMA.**

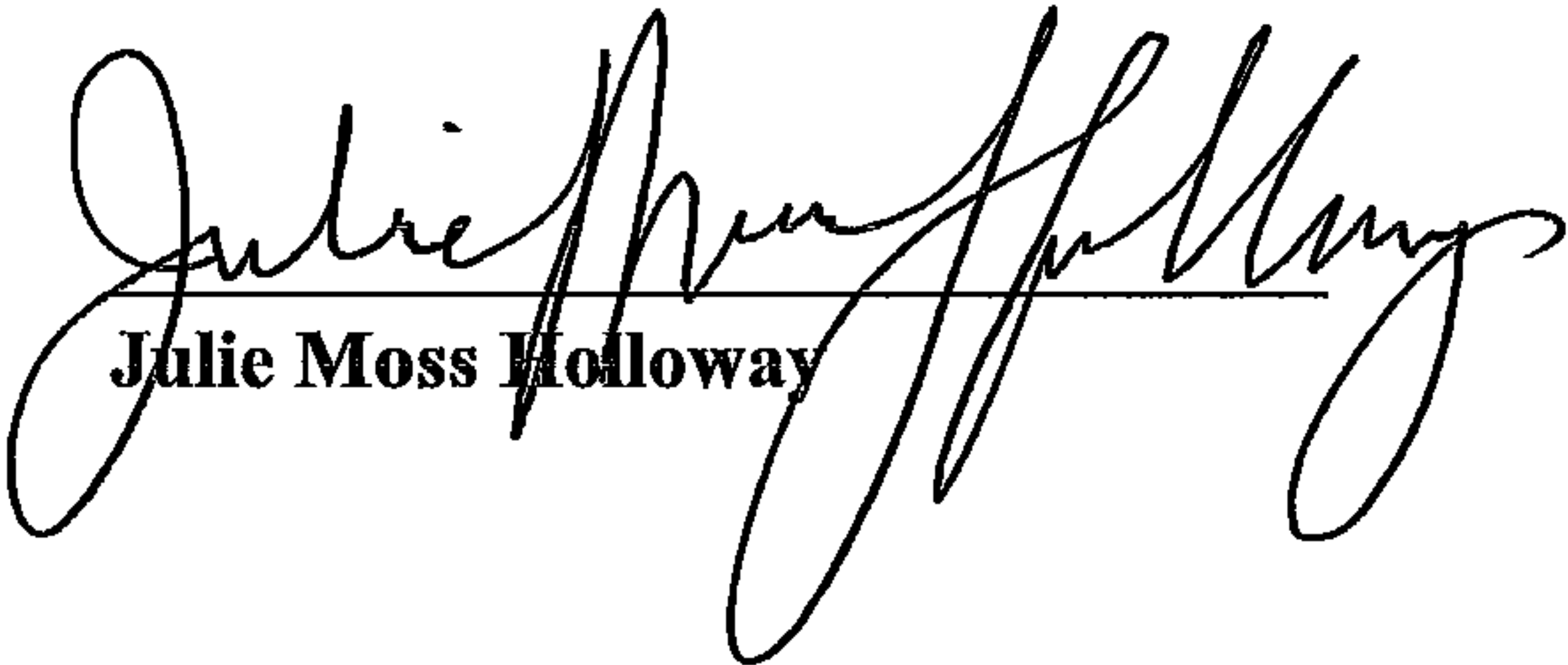
The subject property being conveyed herein does not constitute the homestead of the Grantor, nor that of her respective spouse.

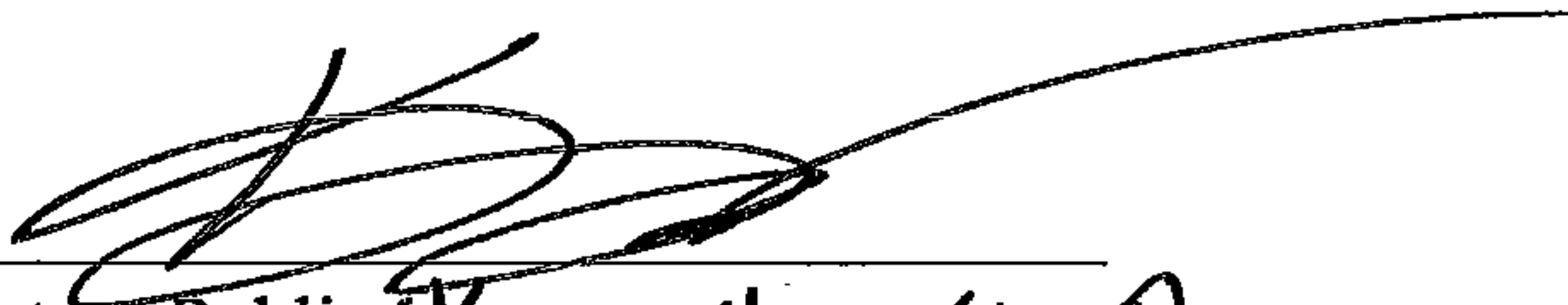

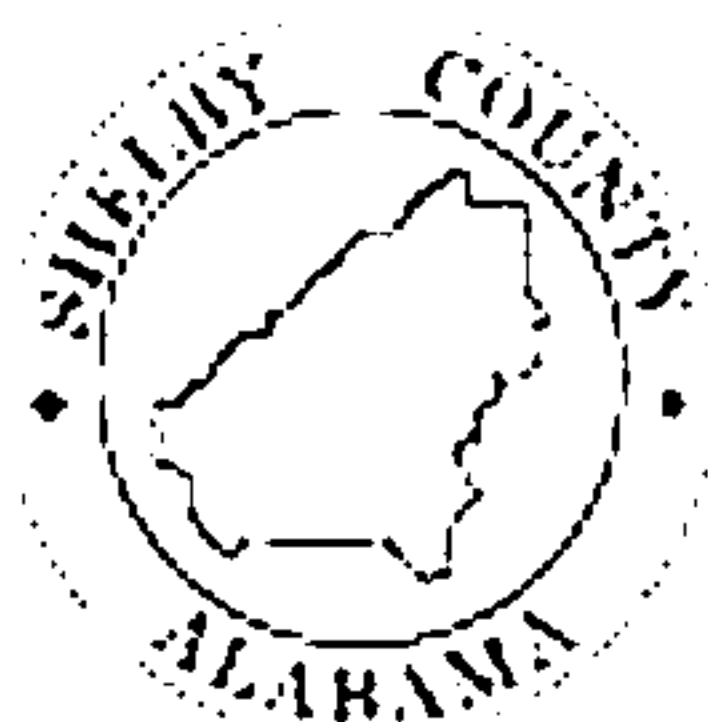
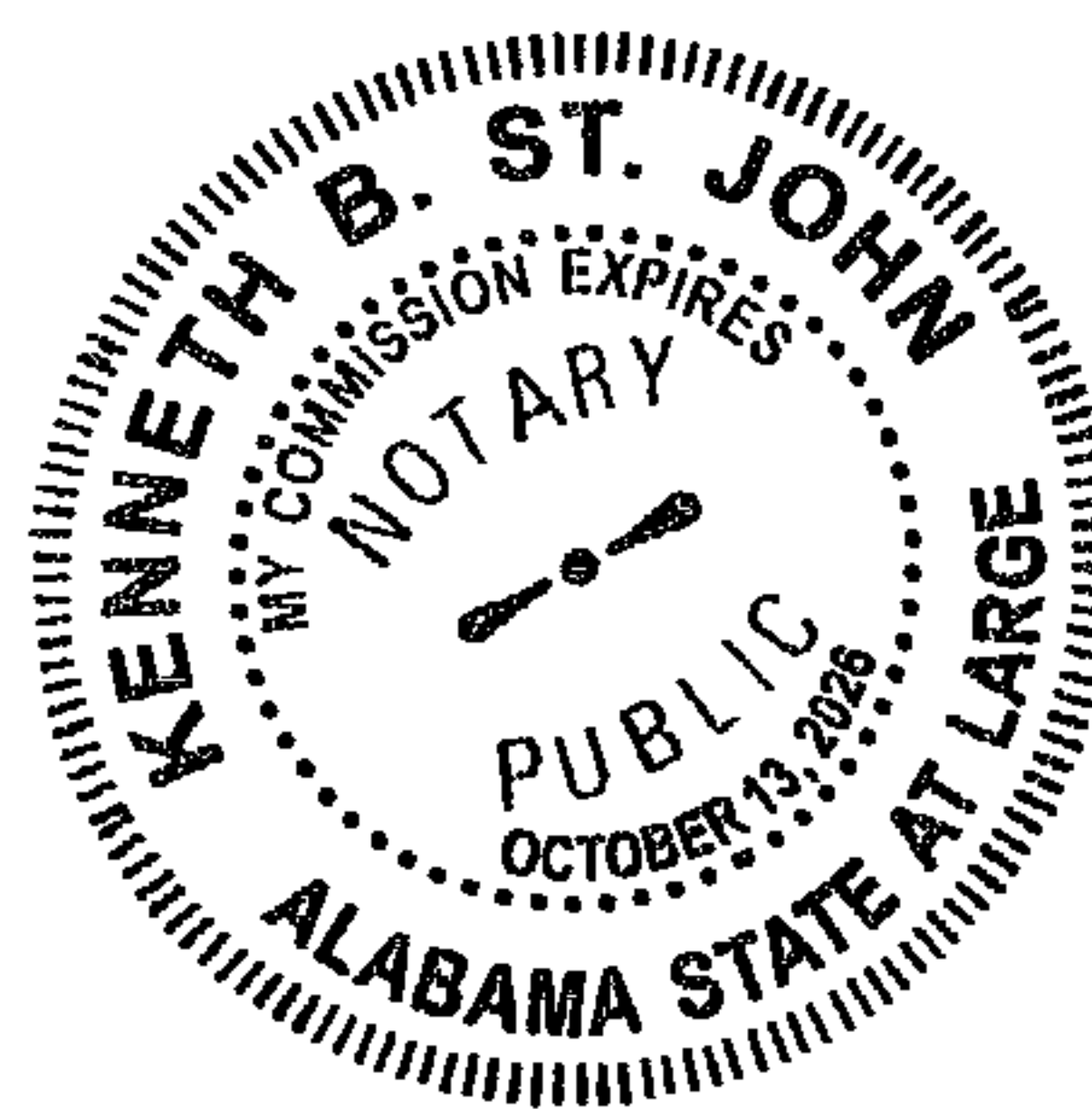
