STATUTORY WARRANTY DEED
Joint Tenants with Rights of Survivorship

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Three Hundred Ninety-Eight Thousand Nine Hundred Fifty and 00/100 Dollars (\$398,950.00) and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto Chie Stella Akiba and Stefan LB Vaziri (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 114, Final Plat Chelsea Acres Sector 1 Phase 2A, a map or plat of which is recorded in Map Book 60 at Pages 39A through 39D, in the Office of the Judge of Probate for Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes not yet due and payable, conditions, covenants, easements and restrictions of record.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.

Grantor makes no warranty or covenant respecting the nature of the quality of the title to the property hereby conveyed other than that the Grantor has neither permitted or suffered any lien, encumbrance or adverse claim to the property described herein since the date of acquisition thereof by the Grantor.
