That the undersigned, City of Politican, Alabema, a municipal corporation, (nominater known as "Granters", whether one or more) for and in consideration of One and No/100 Dollar (\$1.00) and other good and valuable consideration paid to Granters in hand by Alabama Power Company, a corporation, the receipt and sufficiency of which are hereby acknowledged, do hereby grant to said Alabama Power Company, in successors and stellars (hereinafter the "Company"), the following essentents, rights, and privilegas:

The right from time to time to construct, install, operate, and maintain, upon, under, and across the Property described balaw, all wines, conduits, cables, transcioures, transformers, fiber optice, communication lines, and often facilities useful or necessary in connection fremulin (collectively, facilities), for the underground innomination and distribution of electric power and communications, along a route selected by the Company, as determined by the location(s) in which the Company's facilities are to be installed. The Company's right of way will extend live (5) feet on all aldos of said Facilities as and where installed, and shall include the right to clear and keep clear said right of way.

The Company is further granted all the rights or privileges necessary or convertent for the full onlyment and use of said right of way for the purposes above described, including, without limitation, the right of ingress and egrate to and from said Facilities, as applicable, the right to excurate for installation, replacement, repair and removal of said Facilities, and also the right to cut, remove, and otherwise keep class any and all structures, obstructions, or obstacles of whatever character, on, under, adjacent to, and above said Facilities.

The experience, rights and privileges granted hereby shall apply to, and the word "Property" as used in this instrument shall mean a portion of the real property more particularly described in <u>Instrument #2021070100319760</u>, in the Office of the Judge of Probate of the above-mentioned county in Alabama.

If, in connection with the construction or improvement of any public road or highway, it becomes necessary or desirable for the Company to make any of the Facilities. Granter hereby grant to the Company the right to relocate the Facilities and, as to such relocated Facilities, to exercise the rights granted above; provided, however, the Company shall not relocate said Facilities on the Property at a distance greater than ten feet (10') outside the boundary of the right of way of any such public road or highway as entablished from time to time, to time.

This great and agreement shall be binding upon and shall truce to the bandh of Grantons, the Company and each of their respective holes, personal representatives, assessors and easigns and the words "Company" and "Grantons" as used in this tratement shall be desimad to include the hopes, personal representatives, assessation and assigns of such parties.
