**KNOW ALL MEN BY THESE PRESENTS:** That, for and in consideration of **Five Hundred Forty Thousand and No/100 (\$540,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Clayton Matthew O'Neal and wife, Katherine O'Neal** (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Lee Shaw and Monique Shaw** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 5, according to the Survey of High Chaparral Sector 3, First Addition, as recorded in Map Book 25, Page 86, in the Probate Office of Shelby County, Alabama.



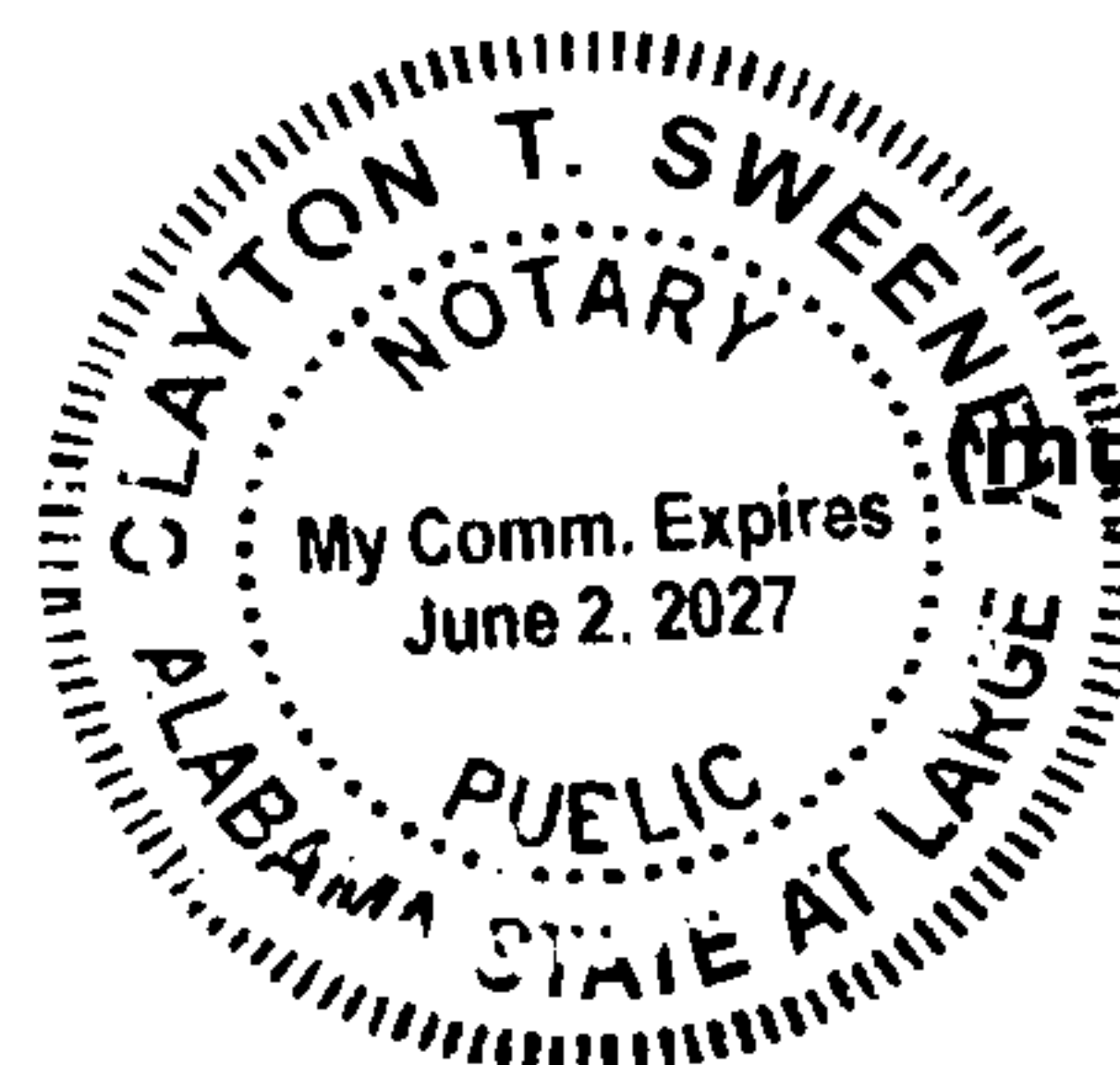

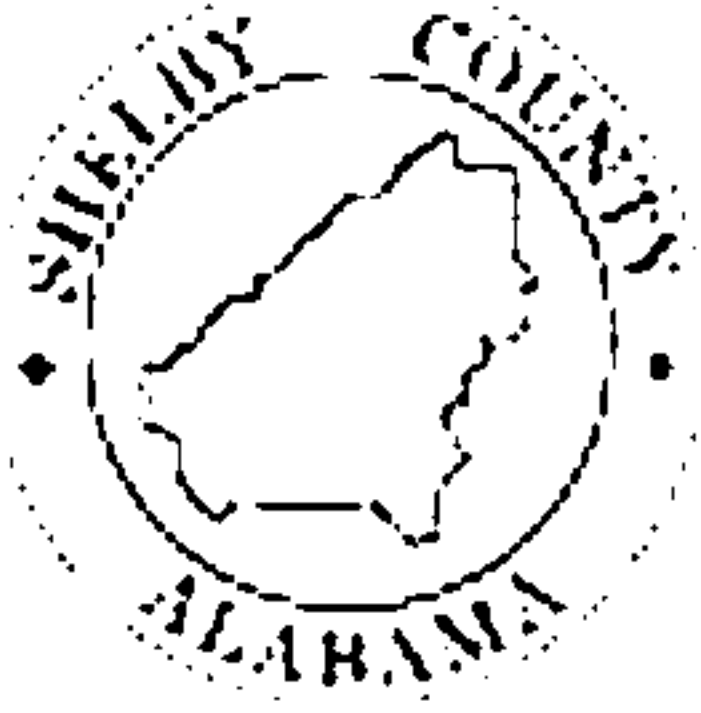
