FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, January 27, 2023, Timothy Wallace, unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Acopia, LLC, which said mortgage was recorded in Instrument Number 20230210000035300 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to AmeriHome Mortgage Company, LLC by instrument recorded in Instrument Number 20250314000077090 in the aforesaid Probate Office Transferee and



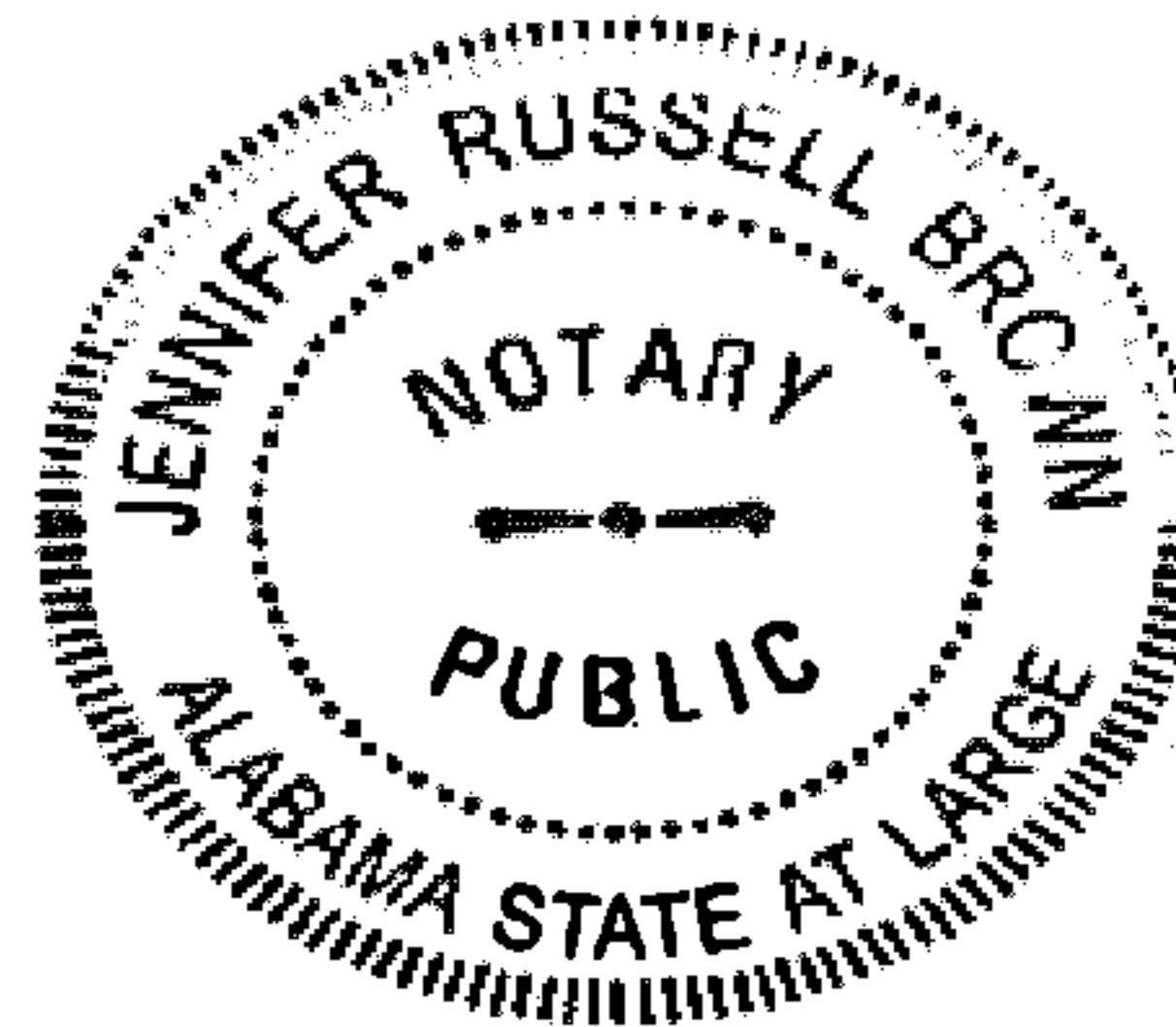

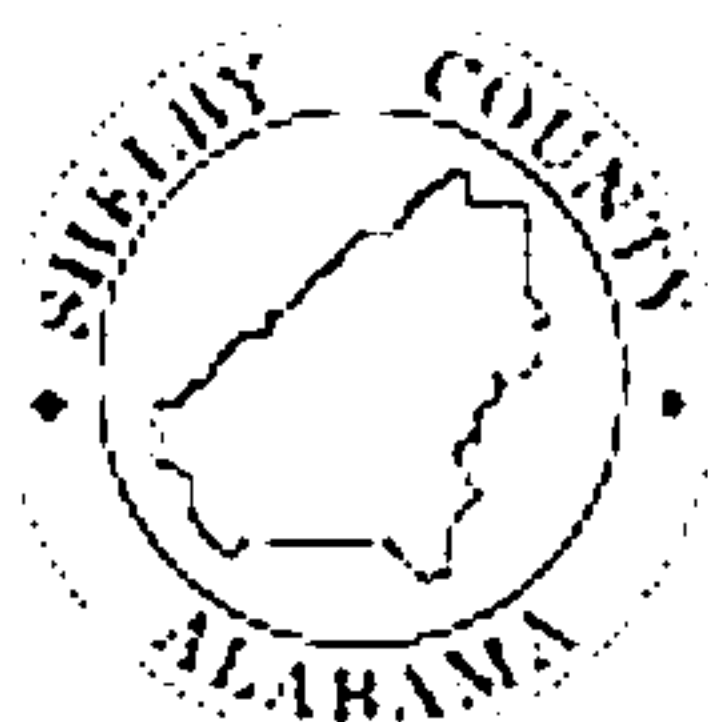
