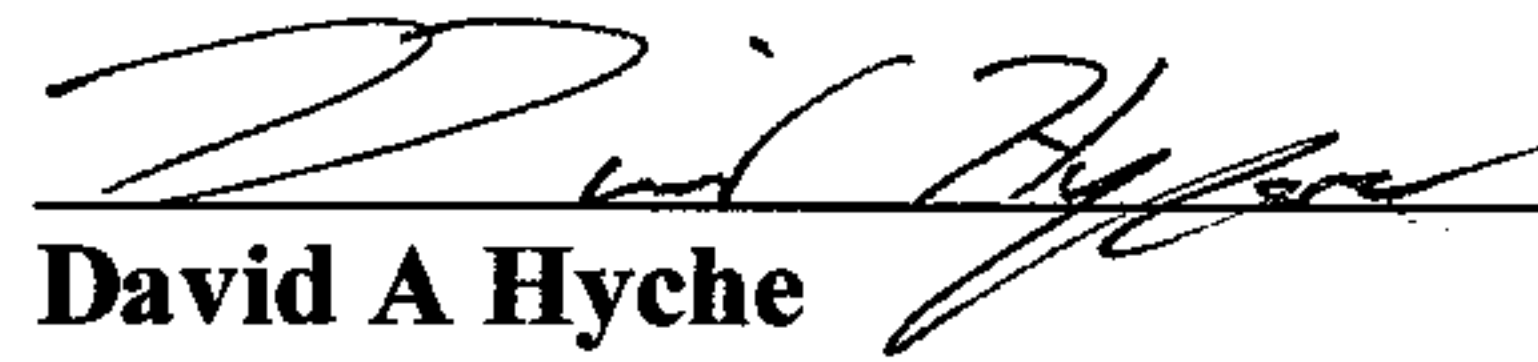
\$280,000.00 of the consideration recited above was paid from a purchase money first mortgage loan closed simultaneously herewith.

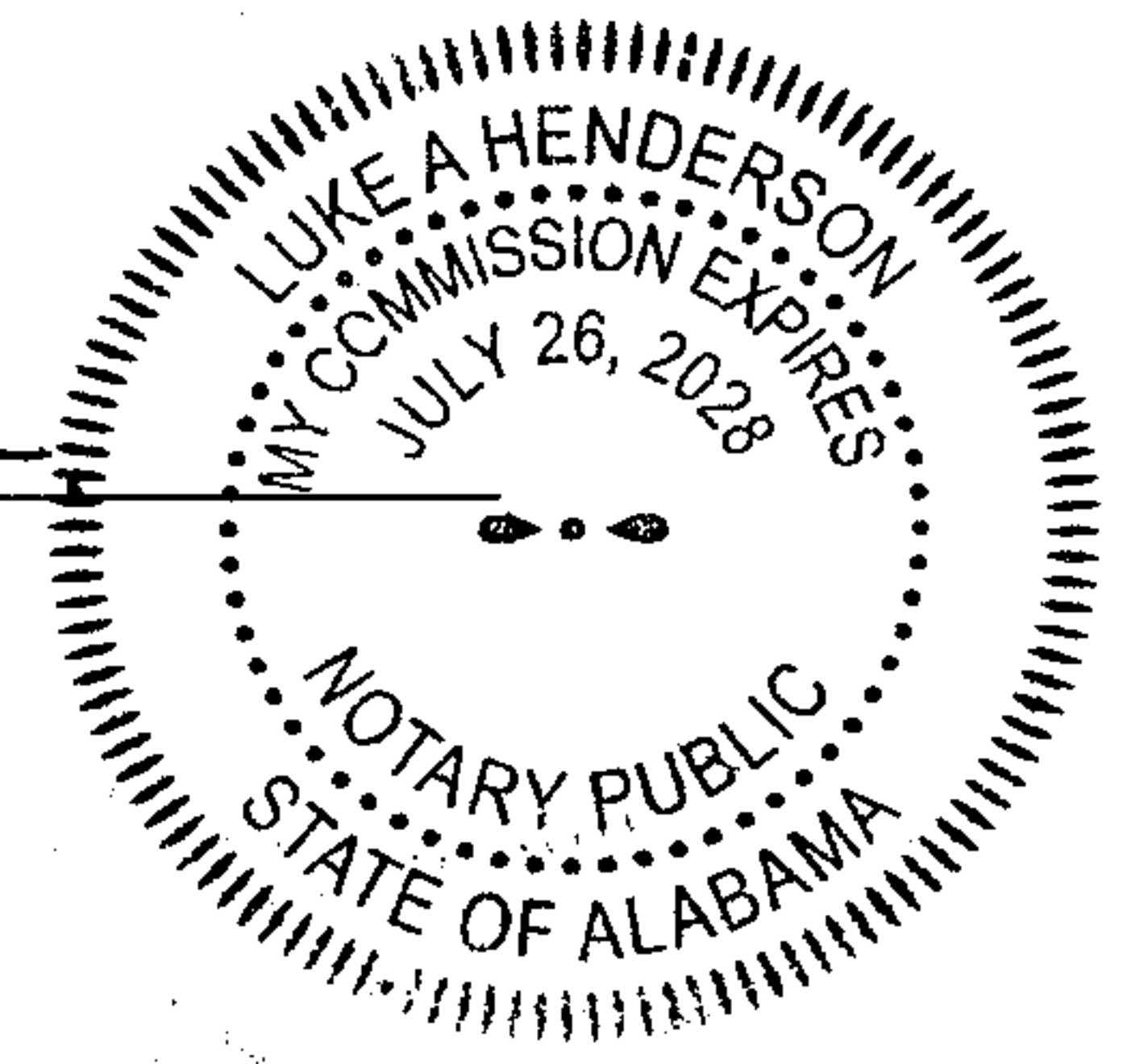
