**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **SIX HUNDRED EIGHTY FIVE THOUSAND AND 00/100 Dollars (\$685,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

**Mark D. Gambill and Emily J. Gambill, husband and wife**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Elizabeth Cain Bryan and Jeremy Lane Bryan**

(hereinafter referred to as "Grantees"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**LOT 8, ACCORDING TO THE SURVEY OF WINDY OAKS, PHASE 3, AS RECORDED IN MAP BOOK 15, PAGE 113, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA; BEING SITUATED IN SHELBY COUNTY, ALABAMA**



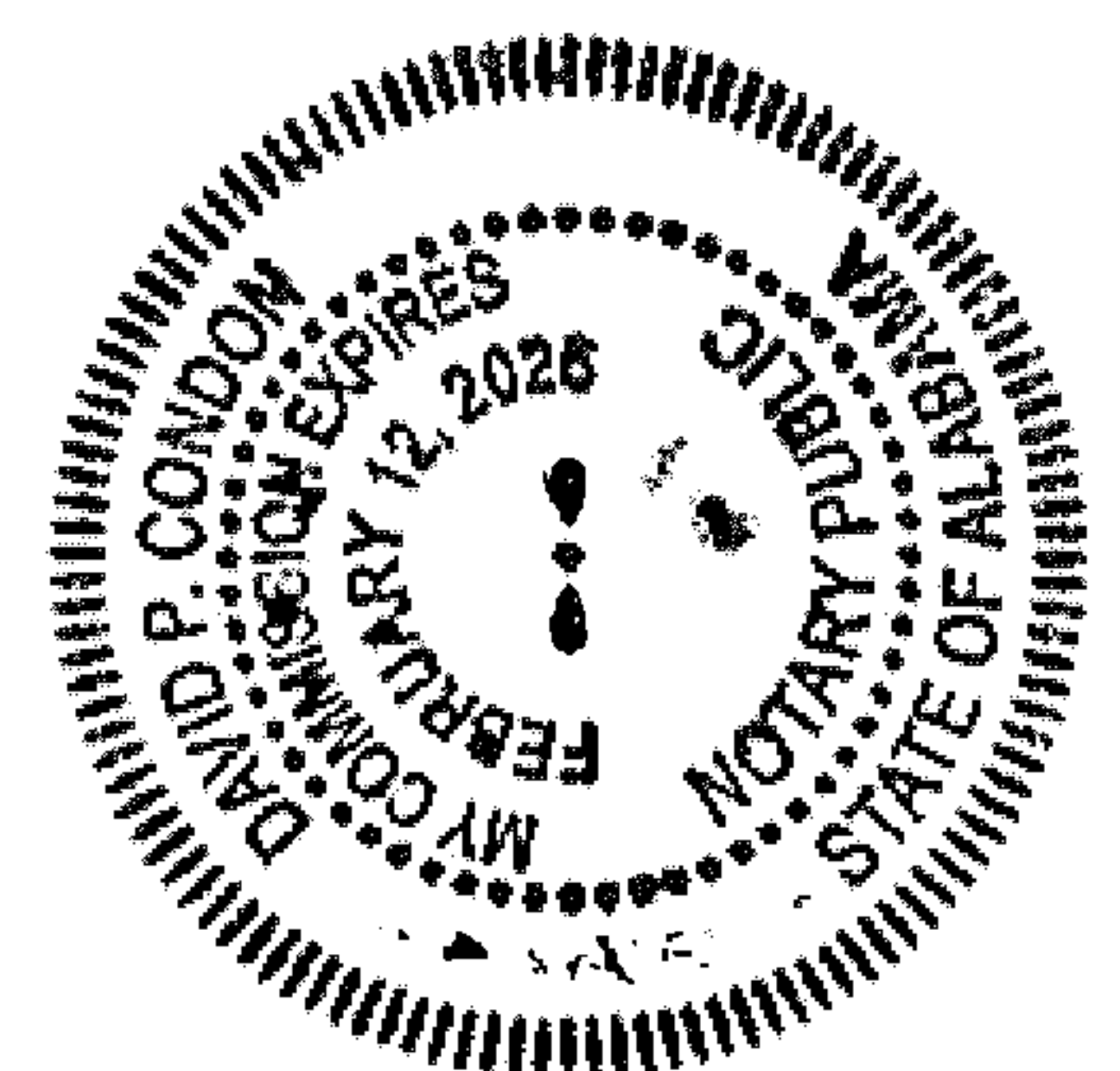
