That in consideration of **Two Hundred Ninety-Two Thousand Four Hundred and 00/100 Dollars (\$292,400.00)** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto **Meredith London Bass** (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby County, Alabama**, to-wit:

Lot 146, Stonehenge Phase I, a map or plat of which is recorded in Map Book 61, Page 92, in the Office of the Judge of Probate for Shelby County, Alabama.

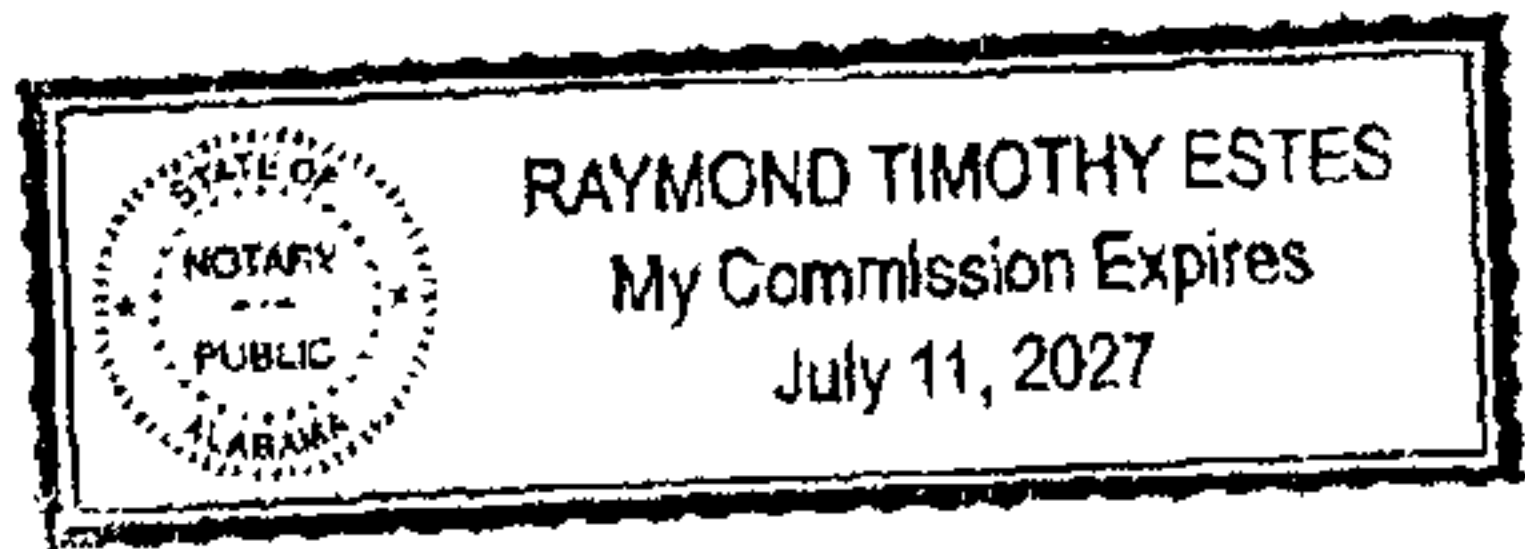


