JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

County of Shelby

That in consideration of the sum of **Four Hundred Seventy Thousand Dollars and No Cents (\$470,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Judith M. Bloom, a single woman** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **William Lee Halfacre and Crystal Halfacre, as joint tenants with right of survivorship** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lots 9, 10 and 11, Block 1, according to Parker's Subdivision, as recorded in Map Book 5, Page 27, in the Probate Office of Shelby County, Alabama

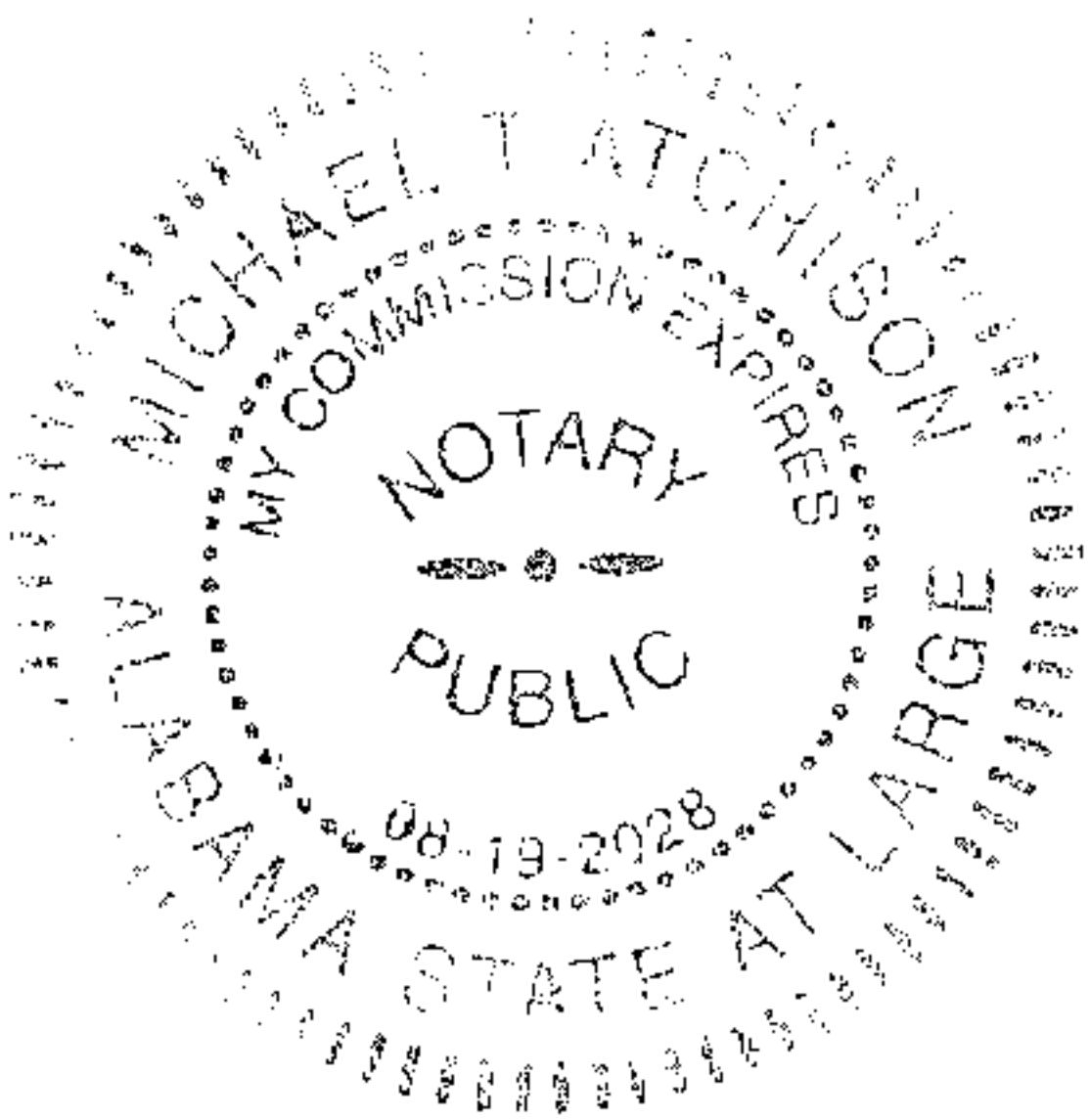
