For ad valorem tax purposes only, the address of the above-described property is 2112 Natalie Lane, Hoover, AL 35244.



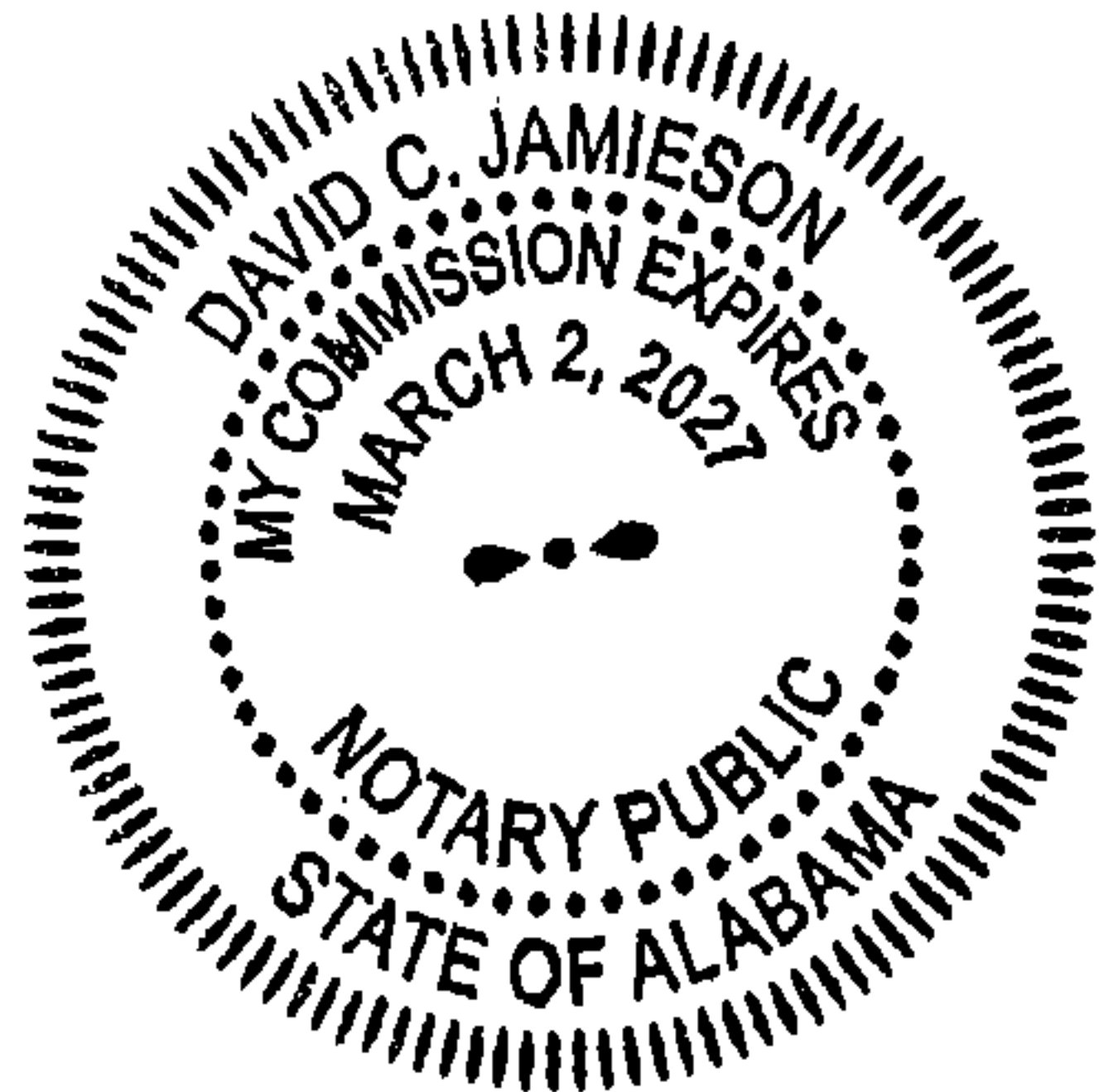
