

#### MEMORANDUM OF LOT BANKING OPTION CONTRACT

(Shelby County, Alabama)

- BY THIS MEMORANDUM OF LOT BANKING OPTION CONTRACT ("Memorandum"), entered into as of the 4th day of December, 2025, TL Peavine Crossing LB, LLC, a Delaware limited liability company ("Seller"), and D.R. Horton, Inc. Birmingham, an Alabama corporation ("Buyer"), declare and agree as follows:
- A. Seller owns that certain real property located in Shelby County, Alabama, and described on the attached Exhibit A (the "Property"):
- B. Pursuant to that certain Lot Banking Option Contract between Buyer and Seller, dated as of the date hereof (the "Contract"), Seller granted to Buyer the option to purchase the Property in accordance with the terms of the Lot Banking Option Contract (the "Option").
- C. The term of the Option commenced upon the date hereof and shall expire February 1, 2027, unless earlier terminated pursuant to the terms of the Contract.
- D. The conveyance of all or a portion of the Property to Buyer or such other party designated by Buyer shall be deemed to automatically terminate this Memorandum as to the portion of the Property conveyed by Seller to Buyer or such other party designated by Buyer. Notwithstanding the foregoing, Buyer may unilaterally execute and record such documents or instruments to further evidence the termination of the Memorandum with respect to the portion of the Property conveyed by Seller to Buyer or any party designated by Buyer.
- E. This Memorandum may be executed in two or more counterparts, each of which shall be deemed an original instrument and all of which combined shall constitute one and the same instrument.
- F. All of the other terms, conditions and agreements contained within the Contract are fully incorporated herein by reference as if fully set forth herein. This Memorandum is not intended



to change any of the terms of the Contract. In the event of any conflict between this Memorandum and the Contract, the Contract shall control.
