Outside electric wiring and underground water pipes are not included. Subject to conditions as required in deed from D.A. Thomas, as Trustee, and W.C. Scott, as Trustee, in deed dated July 23, 1944.

Subject to all easements, restrictions and rights of way of record.

It has been brought to my attention that the legal description stated above is missing the Page Number for the Map Book. The correct book and page numbers of the said Map Book should be Map Book 3, Page 52 and the correct legal description should read as follows:



In addition, the preamble states the Grantor, Ma. Belem Ramirez Dominguez, single. This sentence omits the word "woman" and should read, **Ma. Belen Ramirez Dominguez, a single woman.**

This affidavit is given to correct omission of the Map Book Page number and to correct the marital status of the Grantor in the above-described Quitclaim Deed.


