That in consideration of **TEN AND 00/100 Dollars (\$10.00)** and other good and valuable consideration to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto


- Subject to:

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

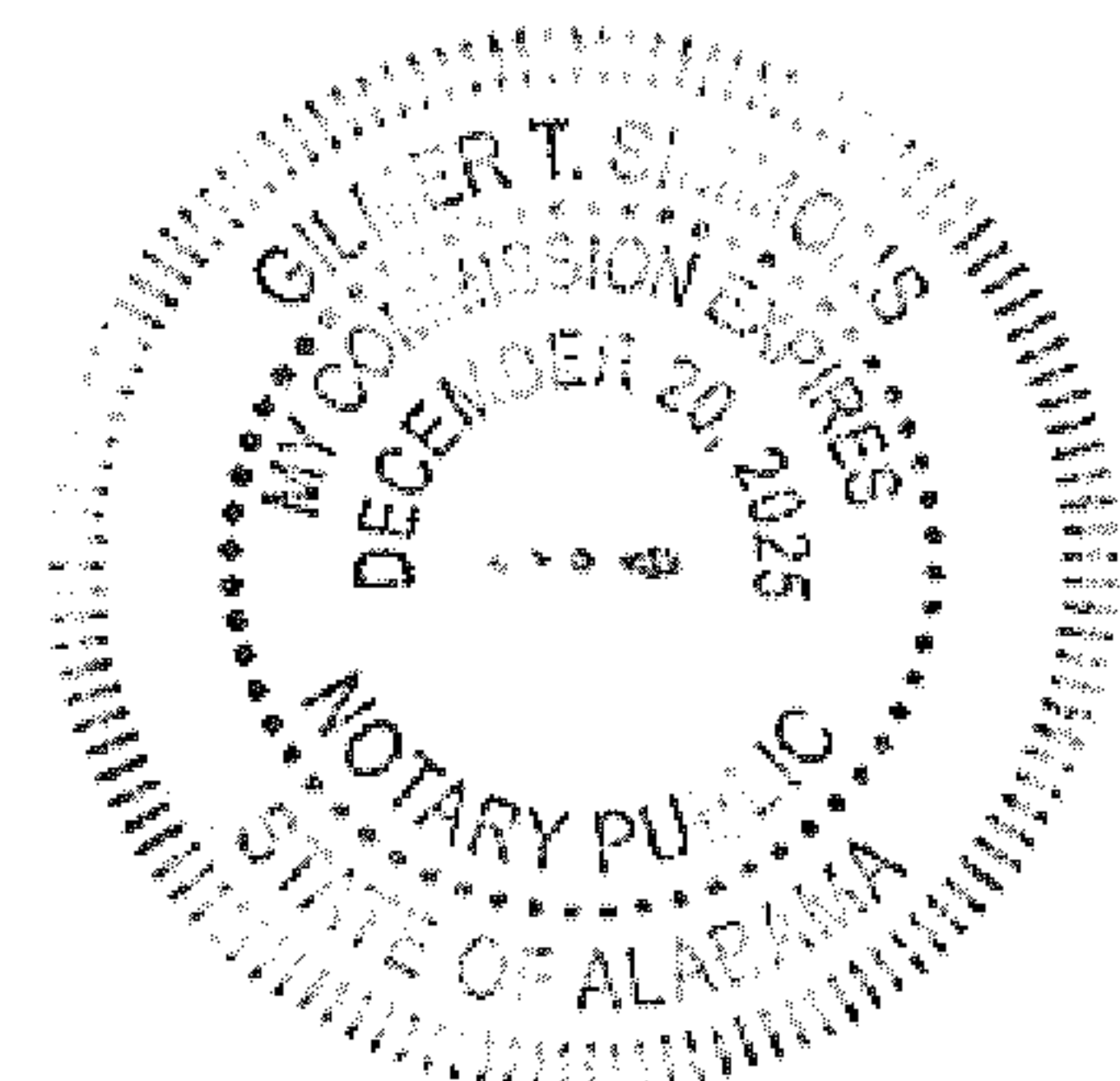


