Further Affiant saith not.

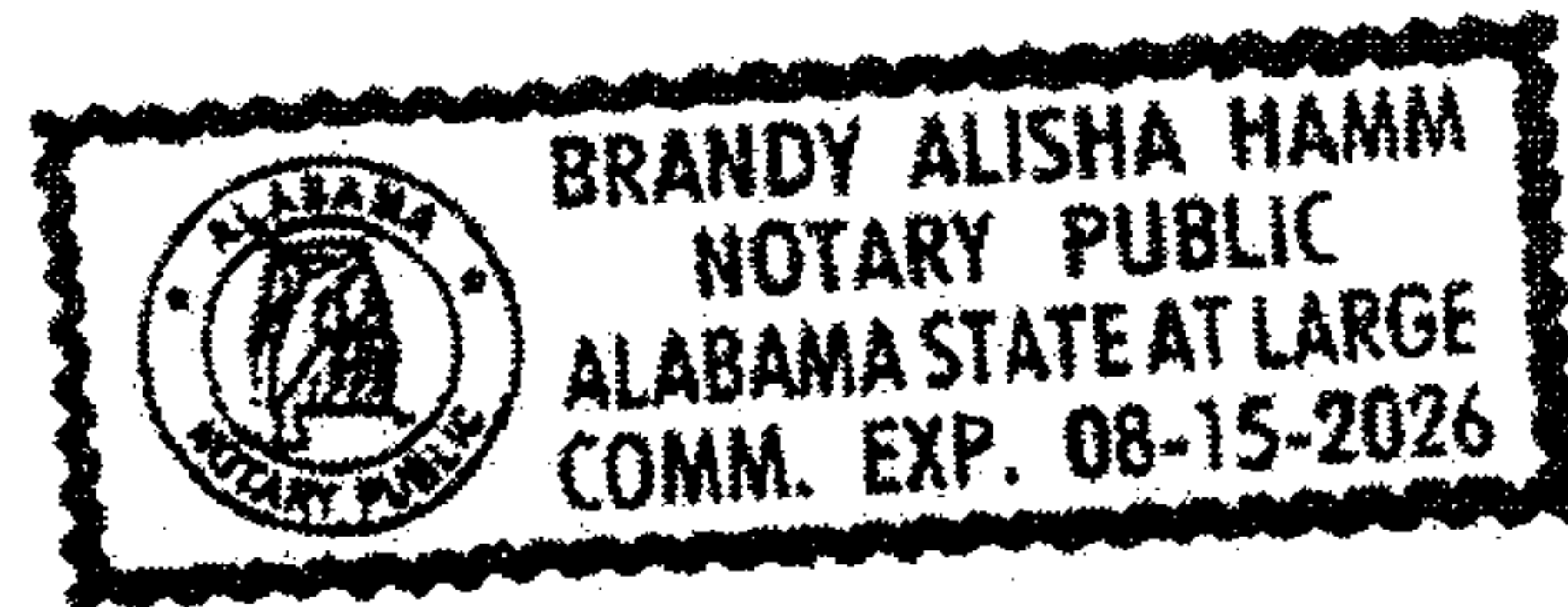
