That in consideration of the sum of **One Hundred Ninety Five Thousand Dollars and No Cents (\$195,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Vickie G. Boggs as Trustee of the Jessie E. Yarbrough and Wanda F. Yarbrough Revocable Living Trust**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Michael Esco and Mindy Esco**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

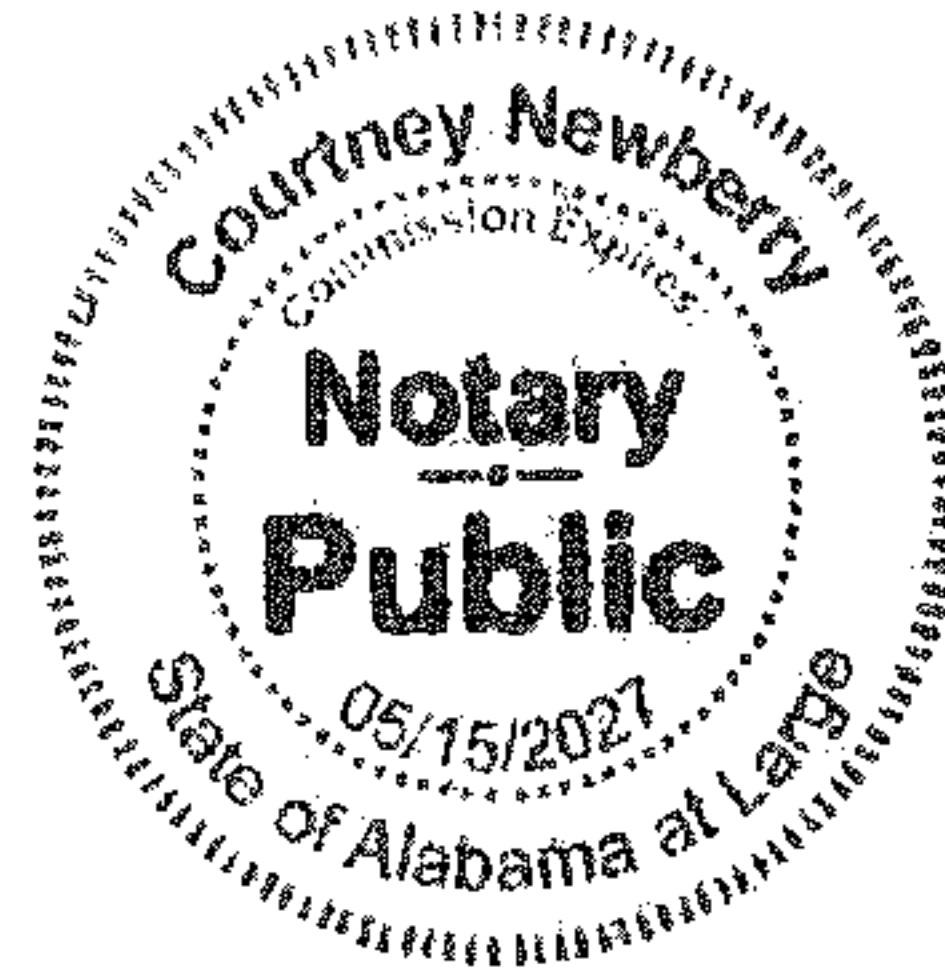

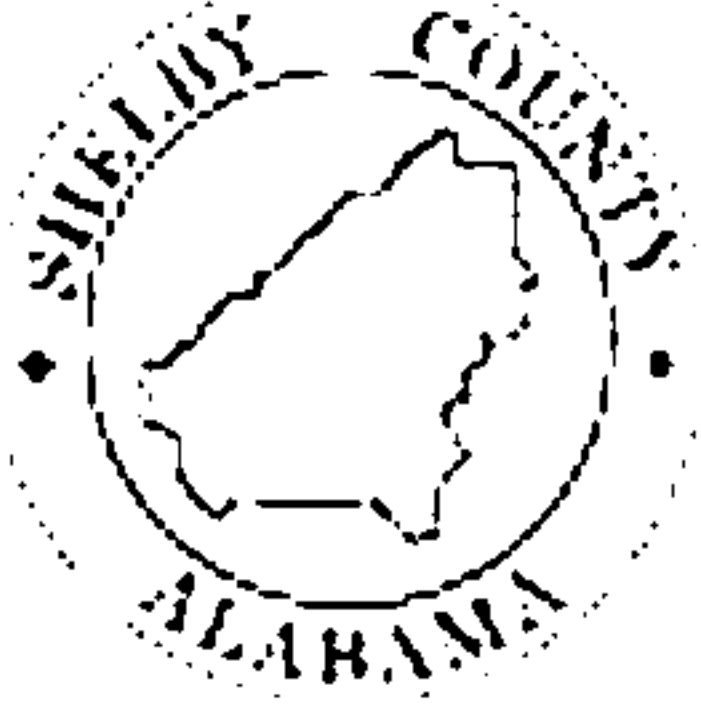
