ORDER


This cause came before the Court on December 11, 2025 on the Motion To Join Trust And Trustees As Necessary And Indispensable Parties, Motion For Accounting and Motion For Instructions With Status Report filed on September 24, 2025. Notice was given to all parties. Jennifer Elgin, as Trustee of the Marilyn M. Rein Living Trust was served with notice of the hearing. Present for the hearing were: Elizabeth Rein, along with Wendy Hartley-Gregerson, Esq., the court appointed guardian ad litem and Kill T. Karle, Esq., the Guardian.

The Court having considered the pleadings and the arguments of counsel, it is **ORDERED**, **ADJUDGED** and **DECREED** by the Court as follows:

1. Jennifer Elgin as trustee of the Marilyn M. Rein Living Trust is added as a party to this matter.
2. Jennifer Elgin shall prepare and file a full and complete accounting of her actions as Trustee of the Marilyn M. Rein Living Trust on or before 4:30 PM on January 23, 2026.
3. The Court previously granted the Motion for Guardian To Be Relieved, and Ordered that Letters of Guardianship issued to Jill T. Karle, Esq. as Guardian for Ms. Rein would be **REVOKED** effective immediately upon the acceptance of the appointment of Guardian and issuance of Letters of Guardianship to the Successor Guardian to be named by separate Order.
4. Nicole Edwards, Esq. is duly qualified and is hereby appointed under Ala. Code §26-2A-152 (1975, as amended) as Successor Guardian over the said Elizabeth Rein and is conferred all powers and duties under Ala. Code §26-2A-108 (1975, as amended), and as otherwise provided by law.
5. Costs of court are hereby taxed to the estate of Elizabeth Rein, for which let execution issue.
