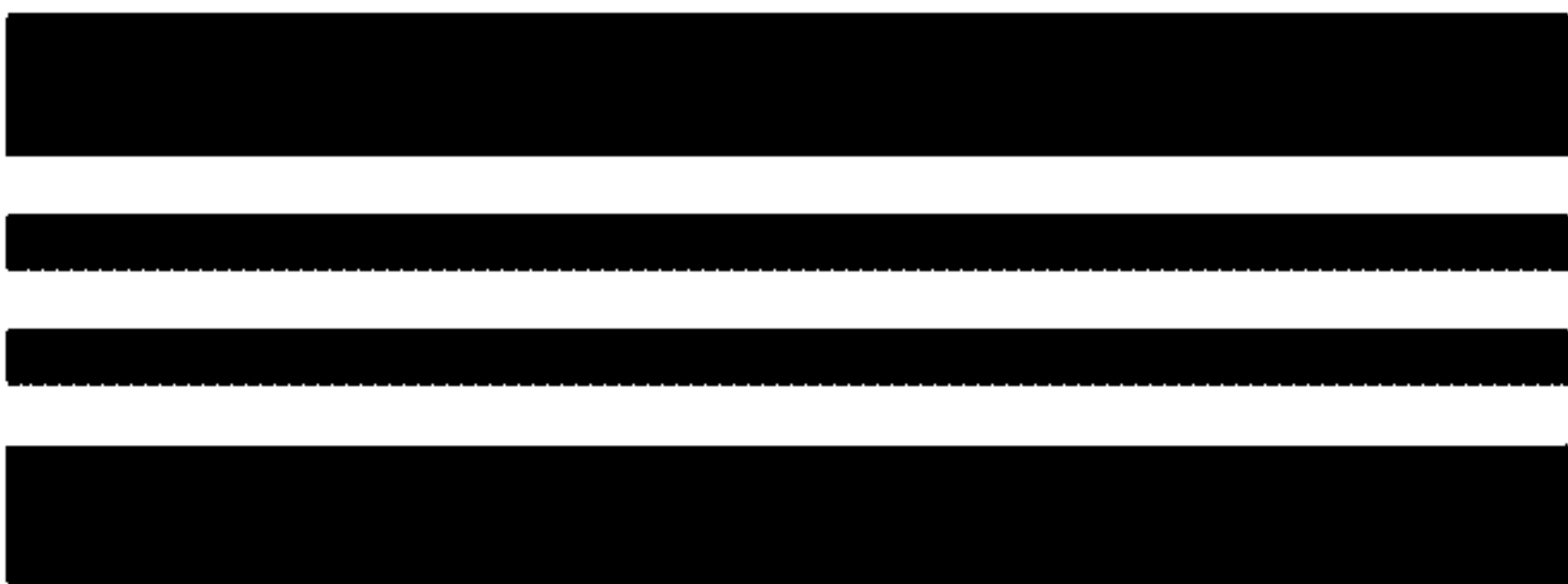

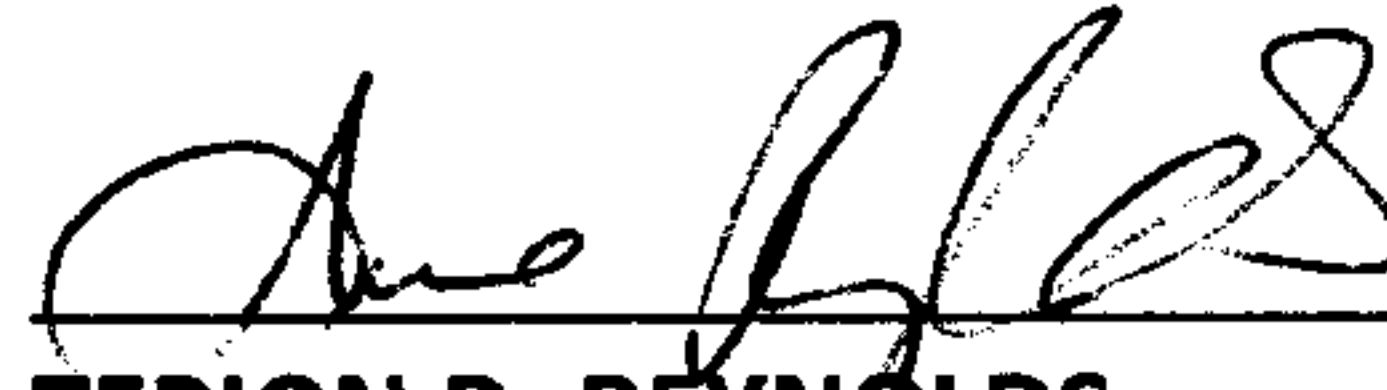
Subject to easements, restrictive covenants and ad valorem taxes of record.

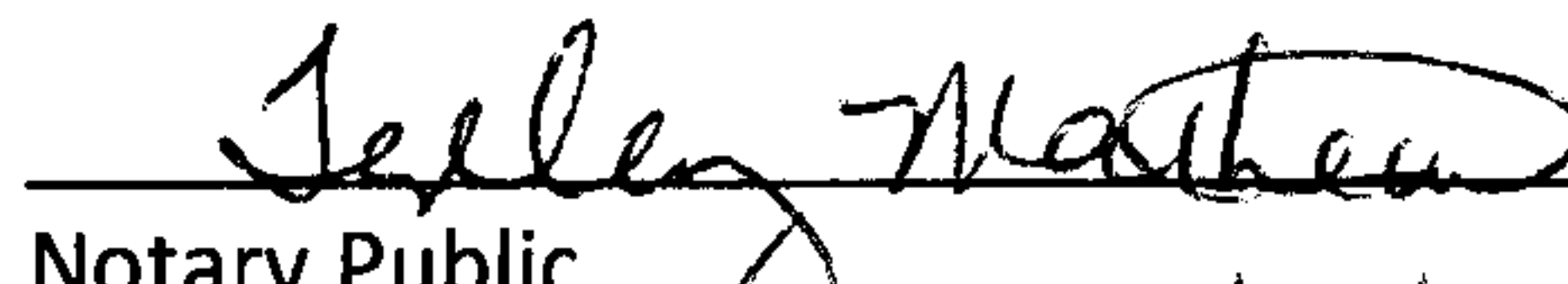
