KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **THREE HUNDRED EIGHTY THOUSAND NINE HUNDRED TWENTY AND 00/100 (\$380,920.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Tower Development, Inc., a Corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR hereby give, grant, bargain, sell and convey unto the GRANTEEES, **Edward W. Neill and Taylor M. Neill** (hereinafter referred to as GRANTEEES), their successors and assigns, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:



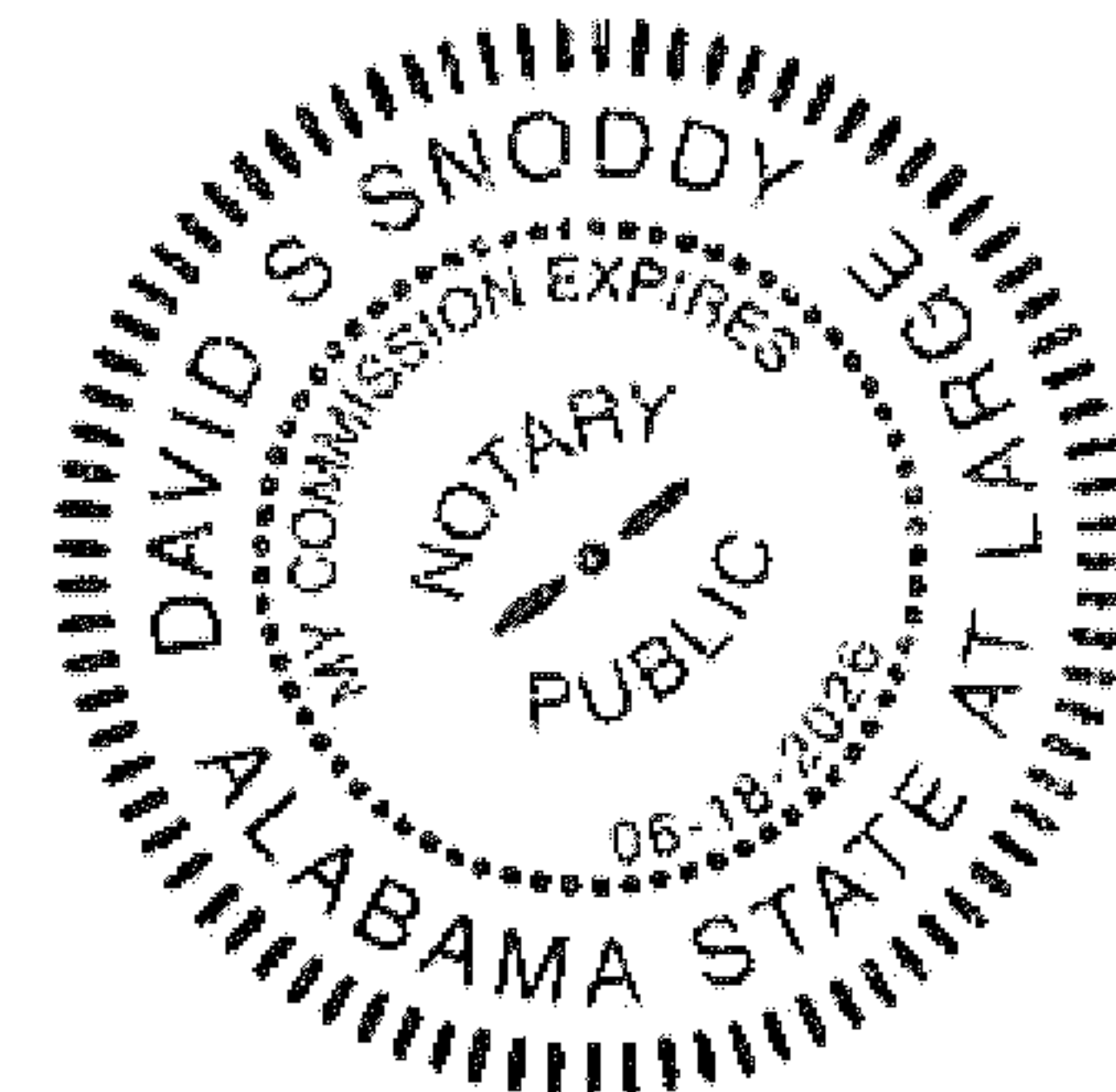
