Stoker and Sandra L. 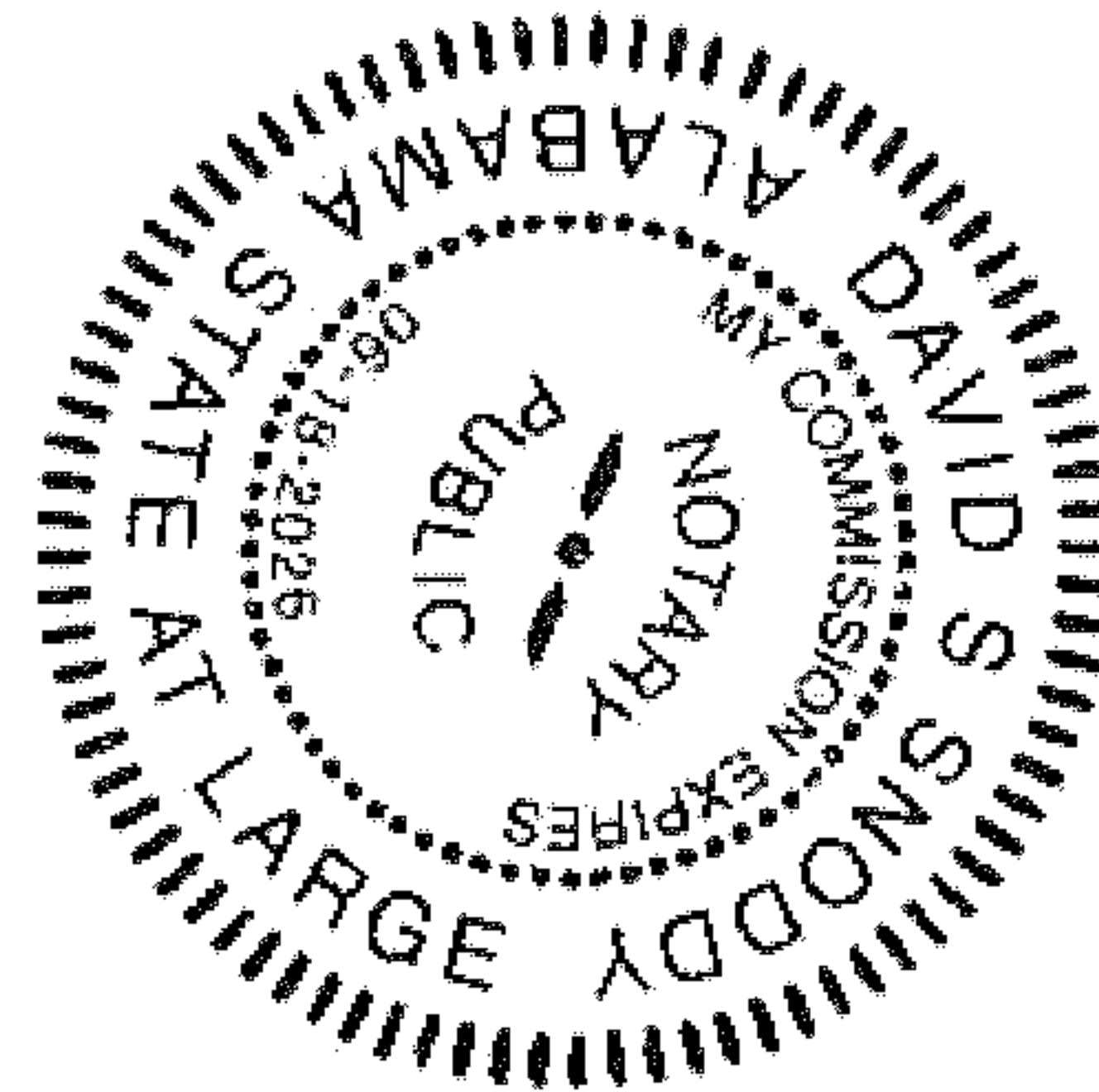
