WARRANTY DEED

That in consideration of **THREE HUNDRED SEVENTEEN THOUSAND AND 00/100 Dollars (\$317,000.00)** to the undersigned grantor in hand paid by the grantee herein, the receipt and sufficiency of which is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

Shelly Turnbough

(hereinafter referred to as "Grantee") the following described real estate situated in Shelby County, Alabama to-wit:

Lot 4-107, according to the Survey of Chelsea Park, 4th Sector, as recorded in Map Book 34, Pages 147A and 147B, in the Probate Office of Shelby County, Alabama.

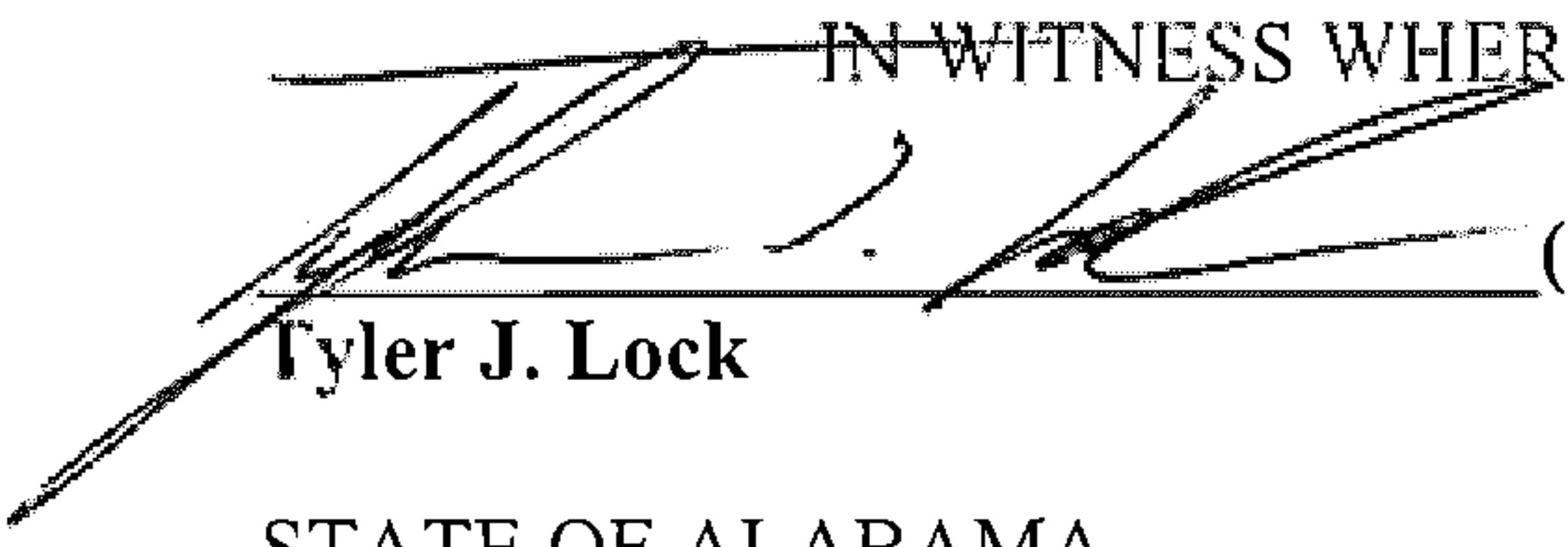
\$267,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

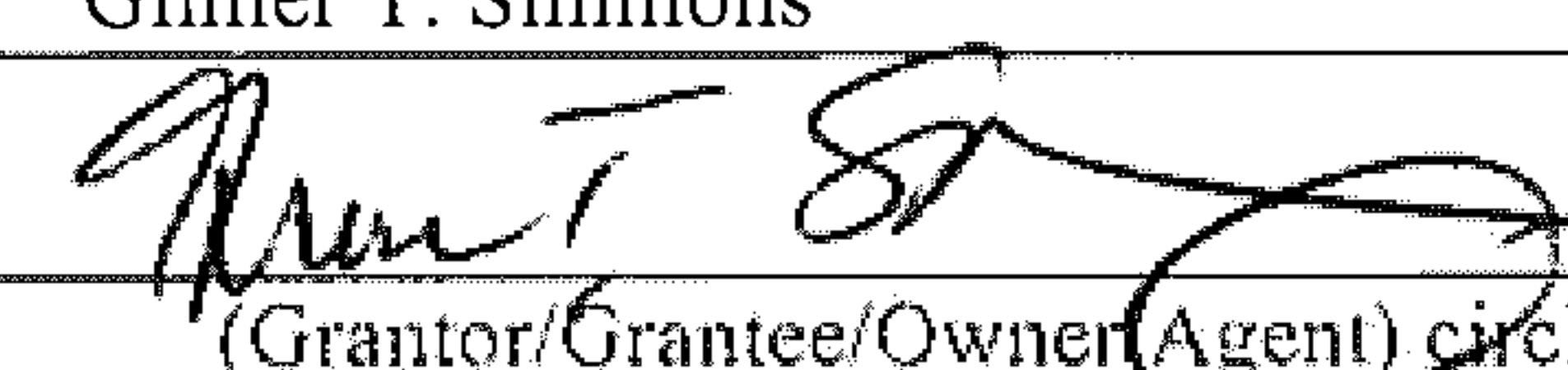
