KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of SIX HUNDRED FIFTEEN THOUSAND AND NO/100 DOLLARS (\$615,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **MICHAEL W. SMITH and STACY S. SMITH, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **DEANNA CATHEY BELLSNYDER, MASON ROBERT BELLSNYDER, and COLTON LEE BELLSNYDER** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

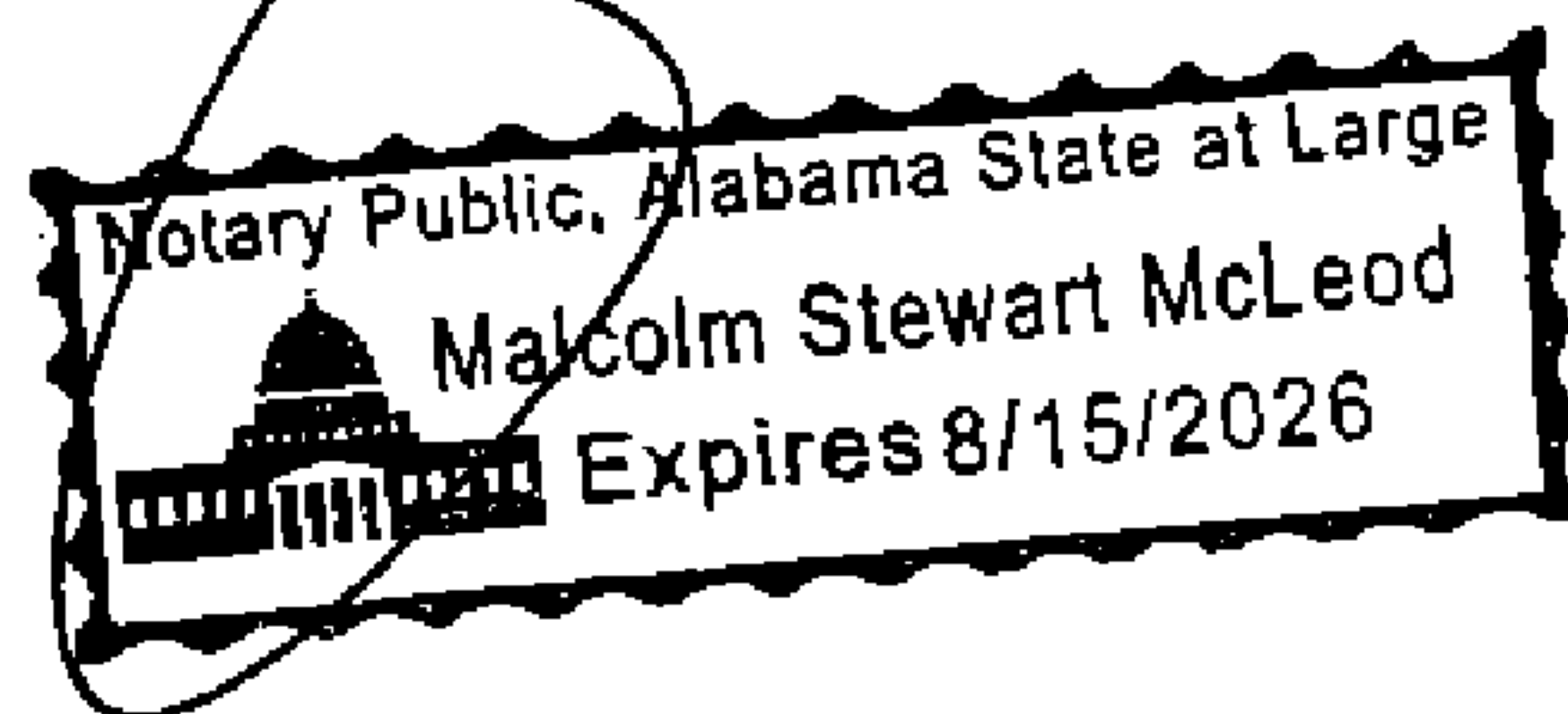

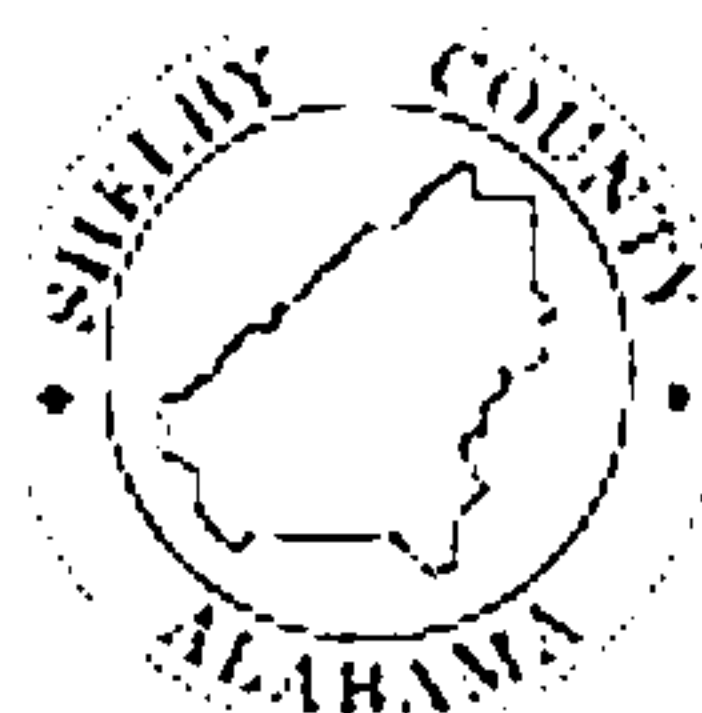
