

AFFIDAVIT

Maggie Dotson died July 30, 1977. At the time of her death, Maggie Dotson was not married, her husband predeceased her in 1932. Maggie left surviving her nine children, namely Mattie Dotson Smith, Lucille Dotson Small, Annie Jo Dotson Coleman, Ruth Dotson Morton, Emma Dotson Robinson, Warren Dotson, Alice Dotson Burt, Sadie Dotson Allen and William Dotson. Maggie also had one daughter, Mary Dotson Glover, who predeceased her, having died in 1945. Maggie Dotson had two children who only lived a few weeks after birth and died in infancy.

Of Maggie Dotson's children all are now deceased. Mary Dotson Glover, a daughter of Maggie Dotson, predeceased Maggie Dotson, having died in 1945. Mary Dotson Glover left surviving her two children, namely Felecia Glover Harris and Ronald Glover. Ronald Glover passed in 2000 and left two 2 children, Nikita Glover and Amre Glover-Wilcher. Both children are over the age of nineteen and of sound mind. Alice Dotson Burt died in 1985 and did not leave surviving her spouse or children. Warren Dotson, son of Maggie Dotson, died in 1986 and left surviving him three children, William Dotson, Wayne Dotson, and Wanda E. Parker. All of whom are over the age of nineteen and are of sound mind. William Dotson died in 1989 and did not leave surviving him any children or spouse. Sadie Dotson Allen died in 1992 and did not leave surviving spouse or children. Mattie Dotson Smith died in 1995 and did not leave surviving her spouse or children. Lucille Dotson Small died in 1999 with no surviving spouse but was survived by one daughter: Jeanne Small Howard who died in 2022 who left no surviving spouse or children. Annie Jo Dotson Coleman died in 2002 and left no surviving spouse or children. Ruth Dotson Morton died in 2015 and left three surviving children. Janice Faye Oliver died in
