### Section 1: Existence

As of the date hereof, the Trustee represents that:

- (a) the Trust is revocable and is in full force and effect;
- (b) the Trustee has full authority to act on behalf of the Trust;
- (c) the provisions set forth below are sufficient on their face and may be relied upon by anyone dealing with the Trust, without need for further inquiry.

### Section 2: Manner in Which Title to Trust Assets Should Be Taken

Title to trust assets should be taken in the following form: "Eva D. Billingsley, as Trustee of the Eva D. Billingsley Revocable Living Trust dated 18<sup>th</sup> day of December, 2025".

### Section 3: Construction

The Trust is subject to and is construed under the laws of the State of Alabama.

**Section 4: Third Party Reliance**

No person or legal entity dealing with the Trustee is required to investigate or determine the regularity, validity or propriety of any transaction involving any Trust asset; the application of the proceeds of any such transaction; or any provision of the Trust Agreement. The Trustee's delivery of a copy of this certification is sufficient (without requiring examination of the remainder of the Trust Agreement document) to release and discharge any such person or legal entity from any irregularity, invalidity, or impropriety in any provision of the Trust Agreement or on the part of the Trustee arising out of any such transaction or application of proceeds.

**Section 5: Trustee's Title**

The Trustee is vested with absolute title to all Trust assets, both as to principal and income, subject only to the execution of the Trust. If the Trust owns any interest in real property at the time this Certificate of Trust is recorded, the legal description of such real property is attached to this Certificate of Trust as Exhibit A.

**Section 6: Trustee's Powers**

The powers of the Trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests of all kinds, including accounts at financial institutions, and include all powers as defined in the State of Alabama's Trust Code. There are no limits placed on the Trustee's powers.

**Section 7: Successor Trustee**

Any Successor Trustee, upon his or her acceptance of administration of said Trust without order of Court, succeeds to all obligations and powers, including discretionary powers, granted to the Trustee. Each successor to any Successor Trustee has identical powers and obligations of said Successor Trustee.

**Section 8: Reliance**

A party may rely on this certification until receiving a new certification advising of any changes to the Trust. This certification supersedes any prior certifications, documents or information provided regarding the Trust.

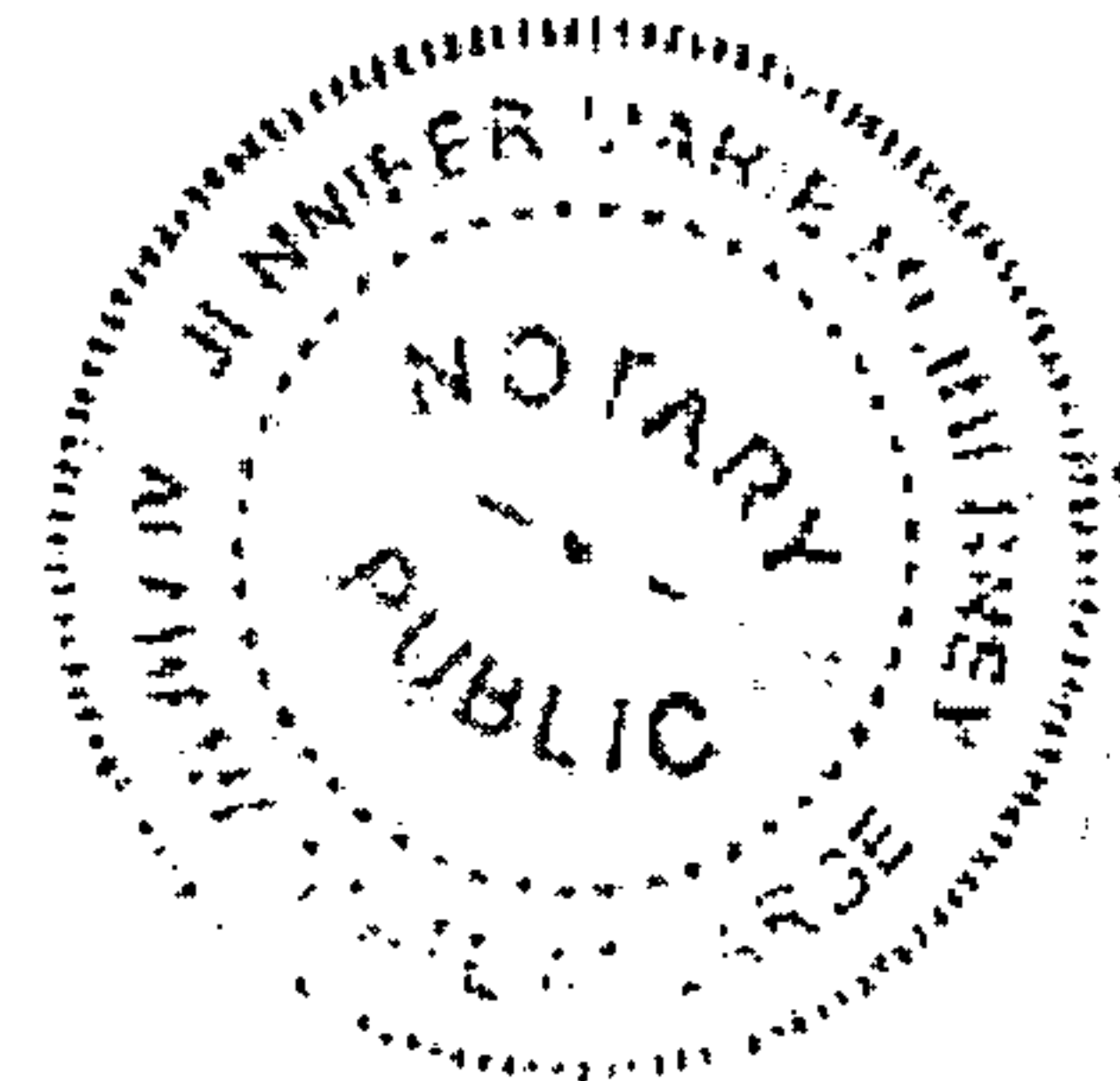
