


**AFFIDAVIT OF HEIRSHIP**

BEFORE ME, the undersigned authority, a Notary Public for the State of Alabama at Large, did personally appear, JANICE STILLWELL GREENLEAF, hereinafter referred to as "Affiant", who is personally known to me, and did confirm his/her identity by presenting a valid State ID, and appearing to be fully competent and of sufficient age, did, after having been duly sworn, state upon oath as follows:

My name is Janice Stillwell Greenleaf. I am a resident of the City of ~~Madison~~ <sup>Huntsville</sup>, Madison County, Alabama residing at 189 Clouds Creek Dr., Huntsville, Al 35806 I am personally familiar with the family and marital history of Lawrence W. Spradley (Decedent), and with all those who would, under the laws of the state of Alabama, be his heirs. The following statements and the information contained herein are based upon my personal knowledge and are true and correct.

Lawrence W. Spradley was my brother-in-law whom I have known from at least 1958 until his death in 2022. Lawrence Spradley died of natural causes at Crestwood Medical Center in Huntsville, Madison County, Alabama on February 7, 2022 (See Exhibit A- Certificate of Death- attached). At the time of his death, Lawrence was a resident at 7809 Doubletree Lane, Huntsville, Madison County, Alabama, 35802

Lawrence W. Spradley began dating my sister, Betty C. (Stillwell) Spradley while they were both attending Vincent High School. After they each graduated from college they were married on August 31, 1963 at the Vincent First United Methodist Church in Vincent, Alabama. Lawrence was not married prior to his marriage to my sister, and they remained married until his death in February 2022.

Lawrence W. Spradley and Betty C. Spradley had two children born to their marriage, to wit: Darryl Ward Spradley (02/16/1968) and Krista Spradley Chambless (05/14/1971. Darryl Spradley is currently a resident of Alexandria, Calhoun County, Alabama. Krista is currently a resident of Northport, Tuscaloosa County, Alabama. Lawrence had no other children. Both Darryl and Krista survived Lawrence's death.

At the time of his death Lawrence had a Will leaving everything to his wife Betty if she survived him, and to their children in equal share if she did not. My sister chose not to probate Lawrence's, her husband's, Will as all assets, both real, financial and personal were titled jointly between them. This included their real property

consisting of their home at 7809 Doubletree Lane, Huntsville, Alabama 35802 (See Exhibit B- Deed- attached) and certain lands located on U.S. Hwy 231 E, just outside of Vincent, in Shelby County, Alabama (see Exhibit C- Deed- attached) both of which were held as Joint Tenants with Right of Survivorship.

At the time of each of his death, Lawrence W. Spradley had no debts to be paid and assets substantial enough to pay any that may have arisen.
