**KNOW ALL MEN BY THESE PRESENTS**, That the undersigned **Samuel Glass and Ramona F Glass** a married couple (hereinafter known as "Grantors," whether one or more), for and in consideration of the sum of One Thousand Five Hundred Dollars and Zero Cents Dollars ( \$1500.00 ) and other good and valuable consideration paid to Grantors in hand by Alabama Power Company, a corporation, the receipt and sufficiency of which are hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns (hereinafter the "Company" or "Grantee"), an easement for road purposes located upon, over, and across land situated in Shelby County, with said land being more particularly described in **Exhibit A** attached hereto (hereinafter "Right of Way").

The Company is further granted all the rights or privileges necessary or convenient for the full enjoyment or use of said Right of Way for the purposes above described, including the right to grade, drain, fill, bridge, or improve such Right of Way. Upon each use of such road, Grantee agrees that it will leave such road in the same or better condition as such road was in immediately prior to such use by Grantee.

Grantee agrees that Grantor may relocate said easement and road provided that Grantor provides a comparable easement and road and that Grantee approves of such new location and road.

The Grantors covenant with the said Grantee, that Grantors are lawfully seized in fee of the above described land; that said land is free from all encumbrances; that Grantors have a good right to convey the same to the said Company, and that Grantors will warrant and defend the said land to the said Company forever.

TO HAVE AND TO HOLD the same to the said Grantee, its successors and assigns, forever.




