Know All Men by These Presents: That in consideration of **Two Hundred Eighty-Seven Thousand and 00/100 Dollars (\$287,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH ALABAMA, LLC, a Georgia Limited Liability Company** (herein referred to as Grantor) grant, bargain, sell and convey unto **LEDA PORTER and EMMANUEL LINDSEY** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:
