WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this February 13, 2026, That for and in consideration of **EIGHTEEN THOUSAND AND NO/100 (\$18,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **BETTY ANN KING BRITNELL, a married person,** (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **HERSHEL JAMES DANIEL WAYMAN III and MCKENZIE ANN WAYMAN,** (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

The Northwest Quarter of the Southwest Quarter of Section 21, Township 21 South, Range 1 East, Shelby County, Alabama. Together with an easement for ingress, egress and utilities as filed of record.

Less and except the following:

Begin at the Southwest corner of the Northwest Quarter of the Southwest Quarter of Section 21, Township 21 South, Range 1 East, Shelby County, Alabama, said point of beginning; thence North 01 degrees 00 minutes 28 seconds West a distance of 1315.56 feet to the Northwest corner of the above said quarter – quarter; thence South 89 degrees 36 minutes 39 seconds East a distance of 1326.10 feet to the Northeast corner of above said quarter-quarter; thence South 01 degrees 01 minutes 45 seconds East a distance of 370.00 feet; thence North 89 degrees 36 minutes 39 seconds West a distance of 922.94 feet; thence South 01 degrees 00 minutes 45 seconds East a distance of 954.20 feet; thence North 88 degrees 23 minutes 03 seconds West a distance of 403.60 feet to the point of beginning.

Subject to:

2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.

- 6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in of record.


The property conveyed herein does not constitute the homestead of the Grantor nor the homestead of the Grantor's spouse.

AND SAID GRANTOR, for said GRANTOR'S, GRANTOR'S heirs, successors, executors and administrators, covenants with GRANTEES, and with GRANTEES' heirs and assigns, that GRANTOR is lawfully seized in fee simple of the said Real Estate; that said Real Estate is free and clear from all liens and encumbrances, except as hereinabove set forth, and except for taxes due for the current and subsequent years, and except for any restrictions pertaining to the Real Estate of record in the Probate Office of **SHELBY COUNTY**; and that GRANTOR will, and GRANTOR'S heirs, executors and administrators shall, warrant and defend the same to said GRANTEES, and GRANTEES' heirs and assigns, forever against the lawful claims of all persons.


