FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, February 14, 2019, Fernando Garfias Sr and Maria G Valencia Ramiraz aka Maria G Valencia Ramirez, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for LoanDepot.com, LLC, which said mortgage was recorded in Instrument No. 20190222000056780 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to MidFirst Bank by instrument recorded in Instrument No. 20230327000083560 in the aforesaid Probate Office Transferee and

Page 7, in the Probate Office of Shelby County, Alabama.

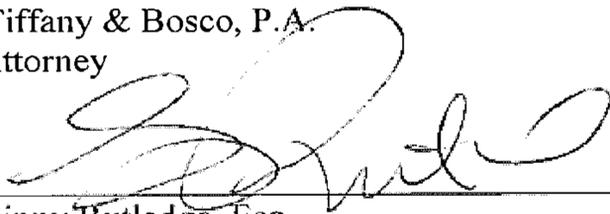

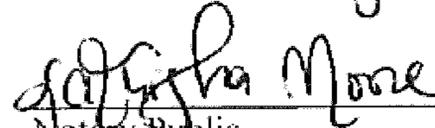

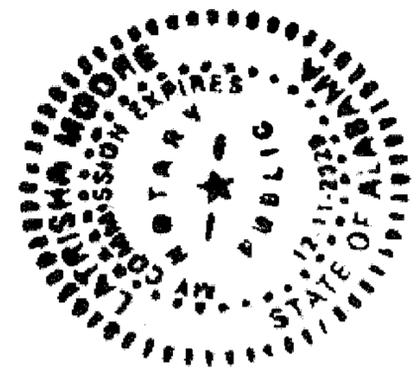
