Certification of Trust for the Gwendolyn M. Etheredge Living Trust dated March 4, 2002

Pursuant to Ala. Code § 19-3B-1013, this Certification of Trust is signed by all the currently acting Trustees of the Gwendolyn M. Etheredge Living Trust dated March 4, 2002, as restated on October 9, 2025, who declare:

1. The Grantor of the trust is Gwendolyn M. Etheredge, also known as Gwendolyn Mills Etheredge. The trust is revocable by the Grantor.
2. The Trustees of the trust are Gwendolyn M. Etheredge (whose address is 2060 Rockwood Lane, Auburn, Alabama 36830) and H. Rex Etheredge (whose address is 2060 Rockwood Lane, Auburn, Alabama 36830).

The signature of one Trustee is sufficient to exercise the powers of the Trustee.

3. The Successor Trustees of the trust are:

Upon Incapacity or Death:

H. Rex Etheredge and Joshua Lee Etheredge will serve as successor Co-Trustees. If H. Rex Etheredge is unable or unwilling to serve, then Joshua Lee Etheredge and Judson Odell Etheredge will serve as successor Co-Trustees, or if either of them is unable or unwilling to serve, then the other may serve alone.

4. The tax identification number of the trust is the Social Security number of Gwendolyn M. Etheredge.
5. Title to assets held in the trust will be titled as:

Gwendolyn M. Etheredge and H. Rex Etheredge, Trustees of the Gwendolyn M. Etheredge Living Trust dated March 4, 2002, and any amendments thereto.

6. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
7. Excerpts from the trust document that establish the trust, designate the Trustee, and set forth the powers of the Trustee will be provided upon request. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.

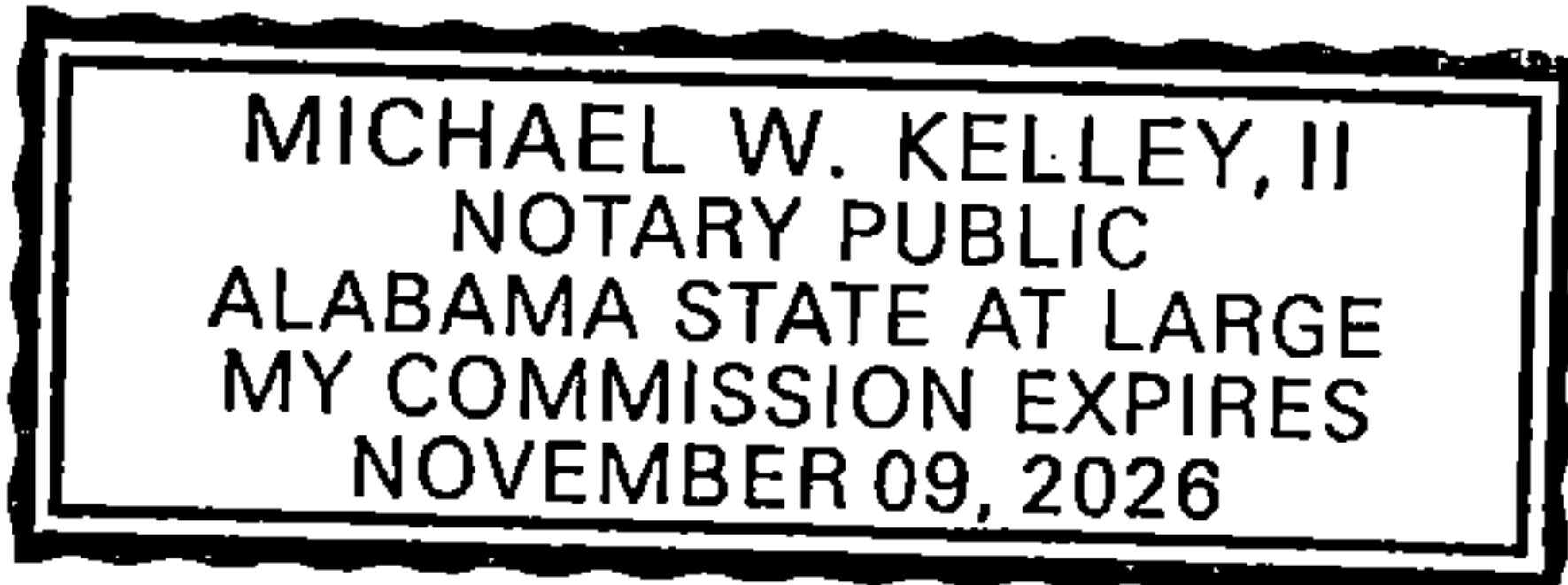
