WHEREAS, heretofore, on to-wit, April 3, 2020, **Richard R Agee and Jo Ann Agee, husband and wife, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., as mortgagee, as nominee for Quicken Loans Inc., its successors and assigns**, which said mortgage is recorded as Instrument No. 20200408000138080, in the Office of the Judge of Probate of Shelby County, Alabama.; and




