That in consideration of the sum of **Four Hundred Twenty Five Thousand Dollars and No Cents (\$425,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Rosemary C Liveoak**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **James Walter Blackmon, Jr. and Janice Tucker Blackmon**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

The North half of the South half of the Northwest Quarter of Section 7, Township 21, Range 2 East, Shelby County, Alabama.


