

1. There is a valid and existing trust, having been created by the **JACKSON LIVING TRUST dated June 05, 2024**.

  - A. The original settlor(s) and successor settlor(s), if any, of the trust was/were: **RODNEY JACKSON and E.B. JACKSON**
  - B. The following person(s) contributed money, funds, real property, or personal property to the trust: **RODNEY JACKSON and E.B. JACKSON**
  - C. The original settlor(s), **RODNEY JACKSON and E.B. JACKSON**, are alive and well as of this date.
  - D. The original trustees are **RODNEY JACKSON and E.B. JACKSON**.
  - E. The name and address of the currently acting trustees: **RODNEY JACKSON and E.B. JACKSON**

  - F. The **JACKSON LIVING TRUST dated June 05, 2024** has definite beneficiaries. The named beneficiaries are not the sole trustee and sole beneficiary.

Our Trustees under our Trust Agreement as authorized to acquire, sell, convey, encumber, mortgage, pledge, lease, borrow, manage and otherwise deal with interests in real and personal property in our Trust name. Our Trustees shall have full banking powers, including the power to open, close, or modify accounts or other banking arrangements, including, but not limited to, safe deposit boxes, savings checking, and CD account. Our Trustees shall have the power to buy, sell and trade in securities of any nature, including options, futures contracts, short sales, and for such purposes, may maintain and operate margin accounts with brokers, and may pledge any securities held or purchased by our Trustees with such brokers as security for loans and advances made to our Trustees. All powers of the Trustees are fully set forth in the Trust Powers Article of the **JACKSON LIVING TRUST dated June 05, 2024**.
4. The Trust is revocable and **RODNEY JACKSON and E.B. JACKSON** hold the power to revoke the Trust.
5. The following trustees have the authority to sign documents and instruments: **RODNEY JACKSON and E.B. JACKSON**, as Trustees.
6. Trust Property should be titled as follows: **RODNEY JACKSON and E.B. JACKSON as Trustees, or their successors in trust, under the JACKSON LIVING TRUST, dated June 05, 2024**.


7. The tax identification number of the Trust is intentionally omitted for privacy reasons.


