Graham, a married man (herein referred to as Grantor)** grant, bargain, sell and convey unto **David Lee Simpson and Libby Moring Simpson, as joint tenants with right of survivorship (herein referred to as Grantees)**, the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:

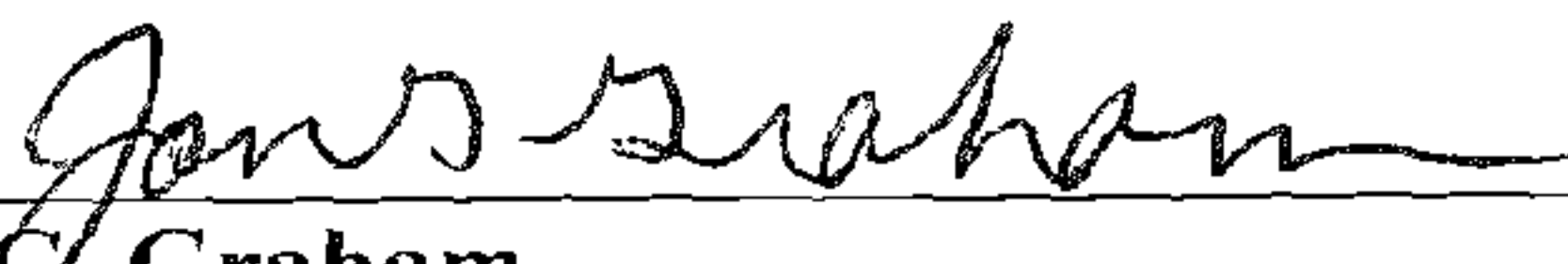
**SUBJECT TO:**

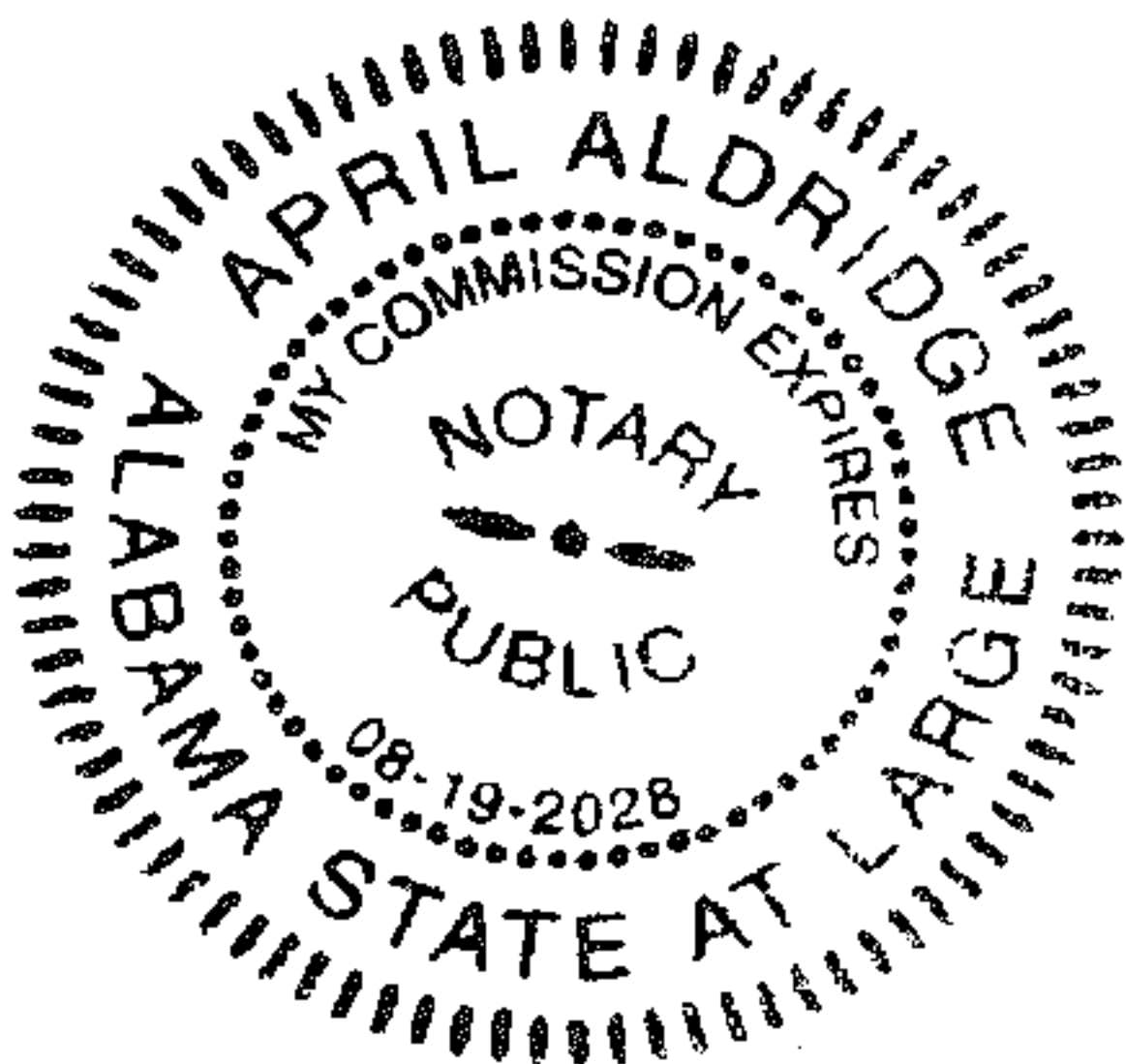
