
This Certification of Trust is in lieu of a copy of the trust instrument pursuant to Section 19-3B-1013 of the Code of Alabama, as amended from time to time.

All of the powers of the Trustee are full set forth in the Duties and Powers Section of Julie Kim Revocable Trust dated August 27, 2001.
4. The Trust is revocable and the Settlor has the power to revoke the Trust.

All persons relying on this document regarding the Trustee and his/her/their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.

The undersigned Trustee certifies that the statements in this Certificate of Trust are true and correct and that it was executed on this the 26<sup>th</sup> day of February, 2026.



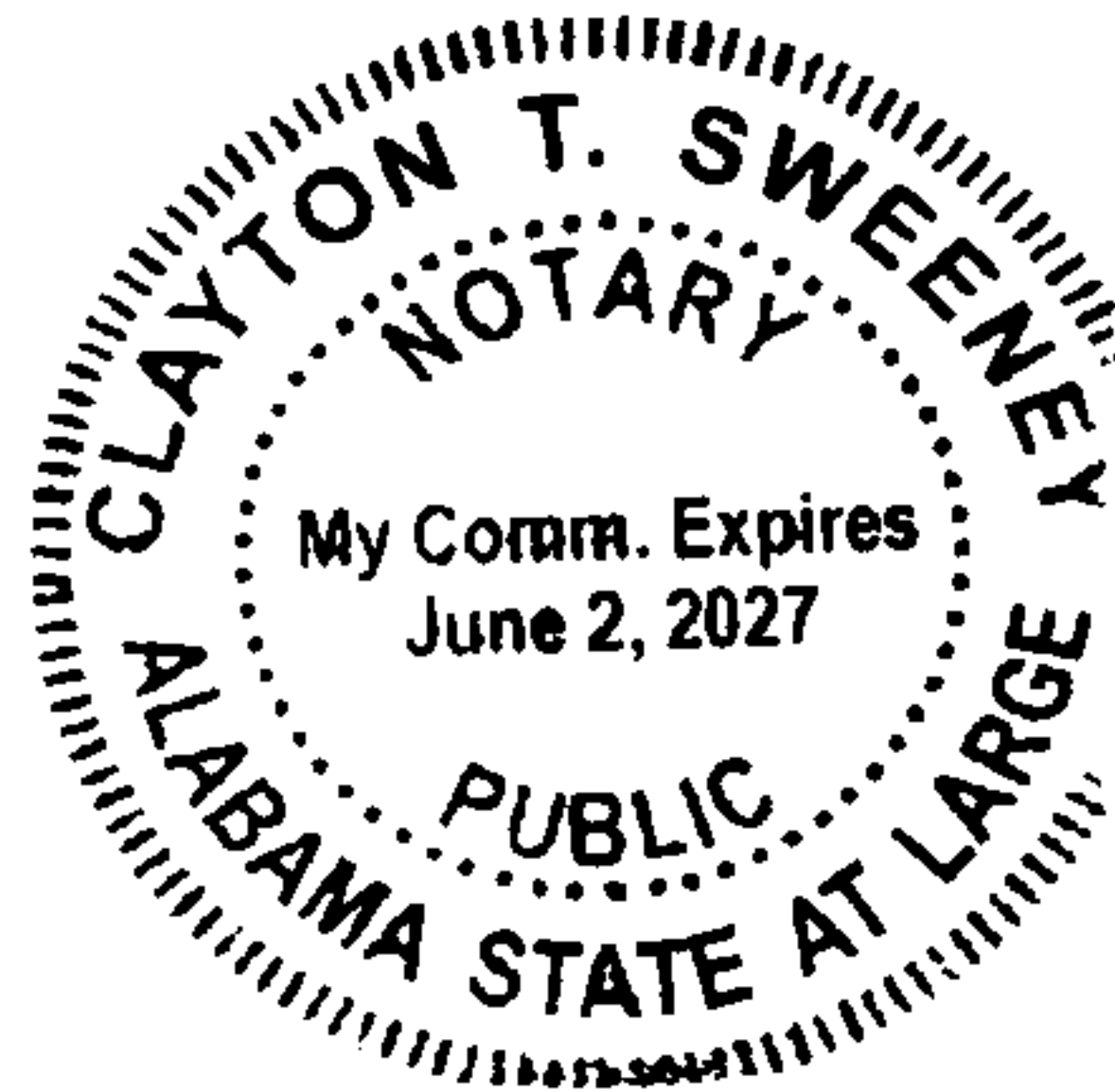
