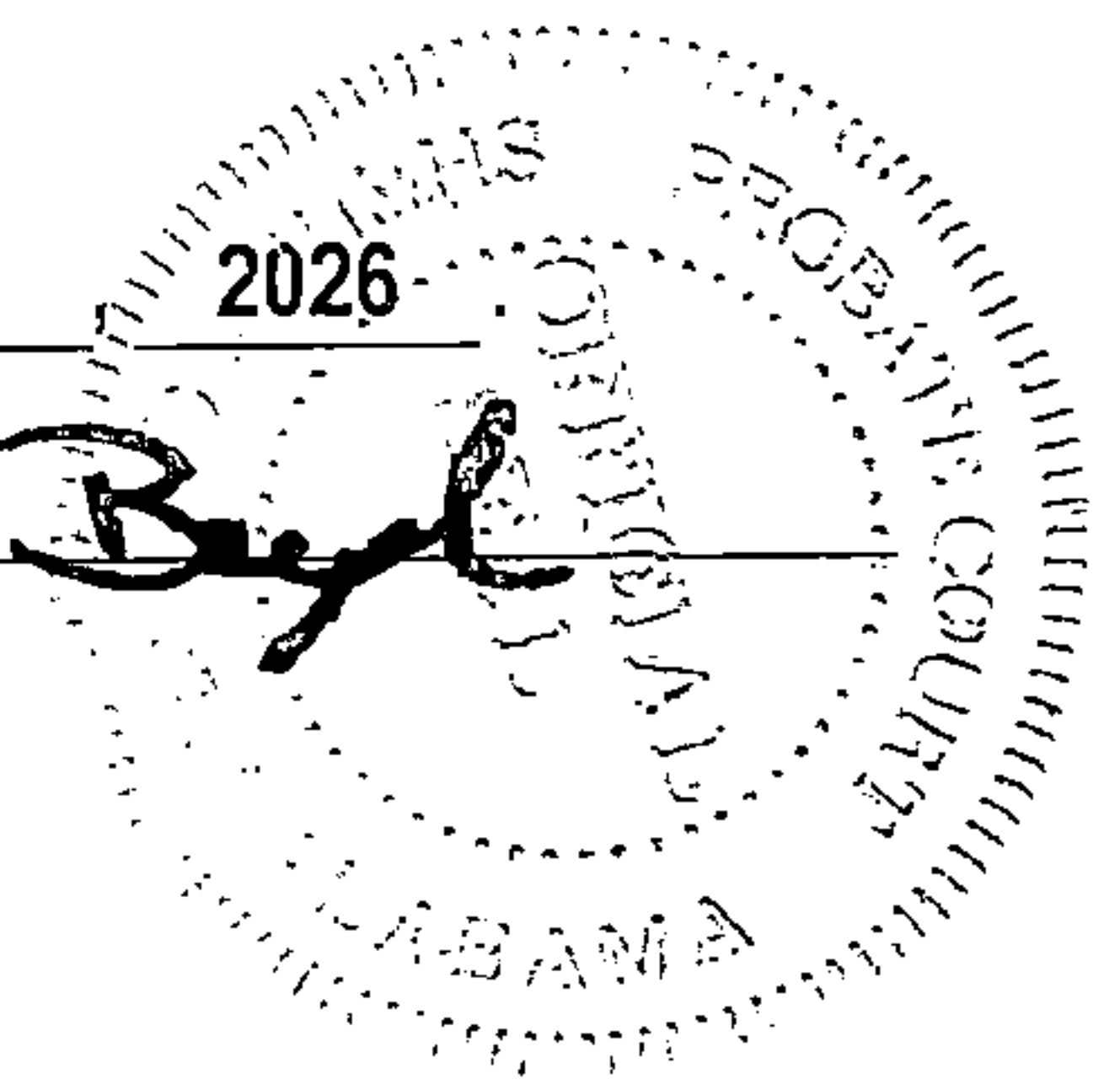

# Power of Attorney

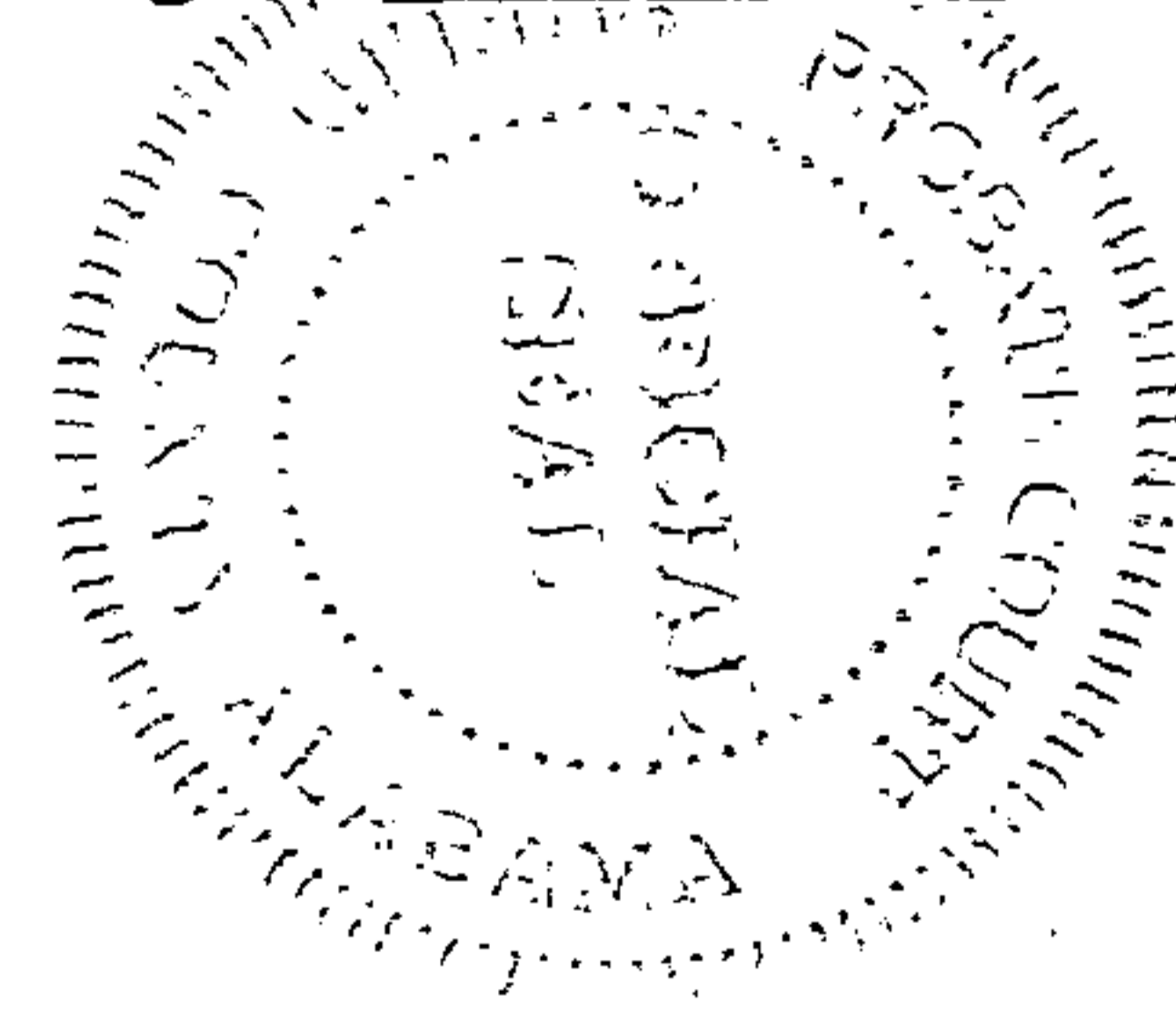

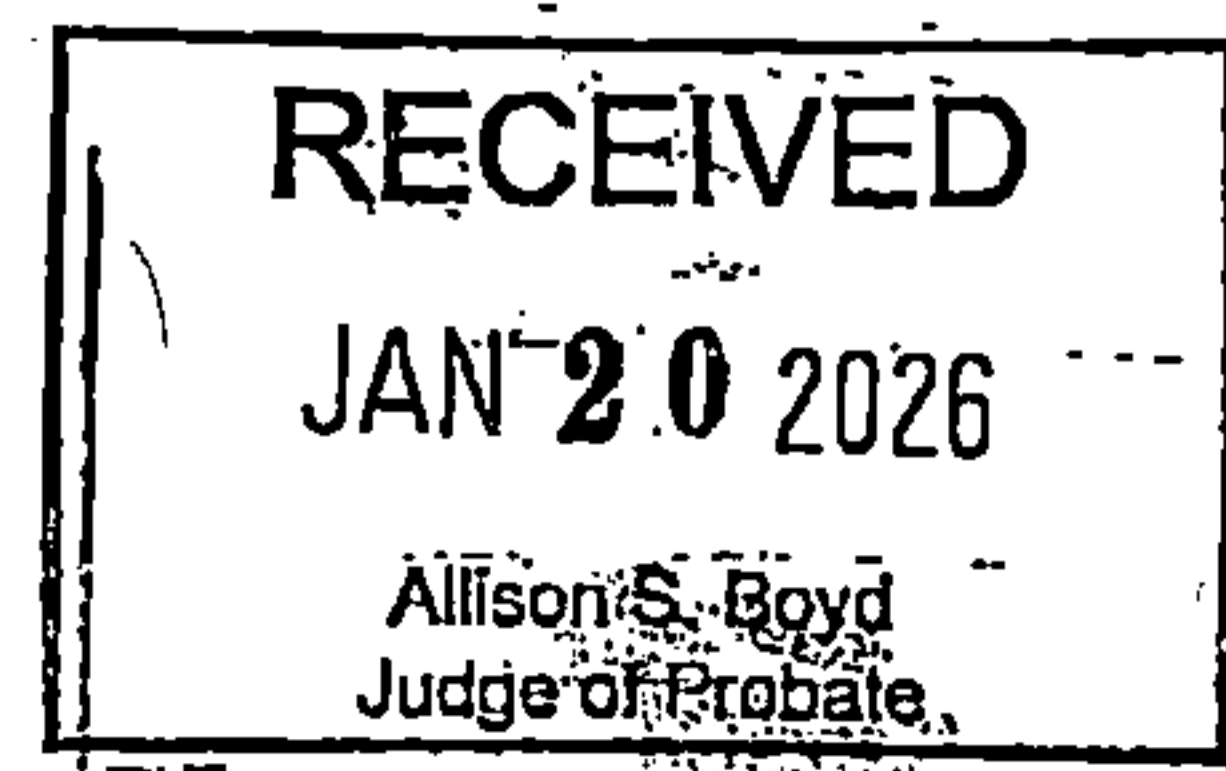
