GENERAL WARRANTY DEED

That in consideration of the sum of THREE HUNDRED EIGHTY TWO THOUSAND FIVE HUNDRED AND 00/100 (\$382,500.00) and other good and valuable consideration to the undersigned grantor, Barpala, LLC, an Alabama Limited Liability Company (herein referred to as Grantor) in hand paid by the grantees herein, the receipt of which is hereby acknowledged, the said Grantor does hereby these presents, grant, bargain, sell, and convey unto Bryan D. Alderman and Kayli D. Alderman, husband and wife (herein referred to as Grantees whether one or more, for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

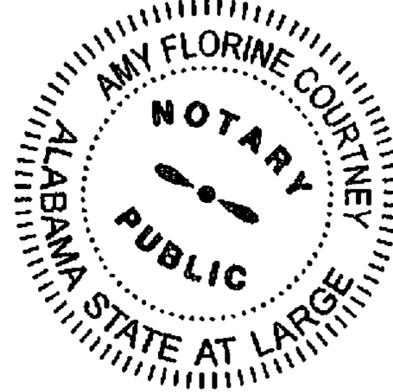
